INDEPENDENT AUDITORS' REPORT

To the Plan Administrative Committee
Flint Hills Resources Chemicals Salary Deferral Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Flint Hills Resources Chemicals Salary Deferral Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of November 30, 2022 and December 31, 2021, the related statements of changes in net assets available for benefits for the period ended November 30, 2022 and year then ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of November 30, 2022 and December 31, 2021 and for the period ended November 30, 2022 and year ended December 31, 2021, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information

to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1 Description of the Plan

The following brief description of the Flint Hills Resources Chemicals Salary Deferral Plan (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

General

The Plan was a defined contribution plan covering certain groups of union employees of Flint Hills Resources, LLC (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was established on August 1, 2007.

Alight Solutions was the recordkeeper for the Plan and The Northern Trust Company was the Plan's trustee. The Northern Trust Company held all investment assets of the Plan in the Koch Companies Defined Contribution Master Trust (Master Trust) with the exception of the CISC Self-Directed Brokerage Account and the Northern Trust Common Collective Trust Fund.

Effective October 31, 2019, Flint Hills Resources Port Arthur, LLC was sold, and as of that date, those employees were no longer eligible to actively participate in the Plan.

Effective October 31, 2020, Flint Hills Resources Peru, LLC was sold and as of that date, there are no longer any employees eligible to actively participate in the Plan.

The Plan Sponsor voted to merge the Plan into the Koch Industries Employees' Savings Plan (EIN 48-0484227 Plan #002) during 2022. The participant accounts merged in July 2022 and residual plan assets relating to forfeited non-vested accounts and the expense account transferred in September 2022. The final transactions occurred in November 2022 to close the trust. In total, \$14,644,884 in assets were transferred out of the Plan.

Eligibility

Prior to the sale of both Flint Hills Resources Port Arthur, LLC and Flint Hills Resources Peru, LLC described above, all employees of the Company who were members of a participating group Local No. 436G of the United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, and Allied Industrial and Service Workers International Union, AFL-CIO, CLC (Peru) were eligible to participate in the Plan on the first day of the month following the date of employment through October 31, 2020. Members of Local No. 2286 of the International Brotherhood of Electrical Workers AFL- CIO, CLC (Port Arthur); and Local No. 13-423 of the United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union (Port Arthur), were eligible to participate in the Plan on the first day of the month following the date of employment through October 31, 2019.

Contributions and Vesting

Prior to the sale of both Flint Hills Resources Port Arthur, LLC and Flint Hills Resources Peru, LLC described above, the Plan allowed for participants to contribute up to 25% of their eligible compensation on a pre-tax basis subject to the annual limitation specified by the Internal Revenue Code (the Code). Participants who attained age 50 or older during the plan year were eligible to make additional contributions to the Plan.

The latest collective bargaining agreements for each location dictated eligibility for the Company's matching contributions and vesting schedule.

1 Description of the Plan (continued)

Participant Accounts

Individual accounts were maintained for each of the Plan's participants to reflect the participant's share of the Plan's earnings (losses), the Company's contributions and the participant's contributions. Allocation of earnings (losses) and administrative expenses were based on relative account balances and the participant's investment elections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Withdrawals and Terminations

Withdrawals from participant accounts may be made only for the following reasons: termination of employment, certain financial hardships, retirement, death or attainment of age 59-1/2. With the sale of both Flint Hills Resources Port Arthur, LLC and Flint Hills Resources Peru, LLC described in the general paragraph, all participants have terminated and therefore conditions for withdrawals were met. Upon election of the participant, the Plan would distribute to the participant up to 100% of the participant's vested account balance in a lump-sum payment or, if eligible, a series of installment payments not to exceed the life expectancy of the member, spouse or beneficiary.

Hardship withdrawals were permitted if certain criteria were met, as defined by the Plan, and were subject to taxes in the year received. Hardship withdrawals (either full or partial) were paid in cash.

Notes Receivable from Participants

The Plan allowed participants employed by the Company to obtain up to three loans which in total could be equal to the lesser of \$50,000 or 50% of their vested account balances. Loans bear interest at a rate equal to the prime rate plus 1% or other reasonable lending rate at the date of origination of the loan and are secured by the balance of the participant's vested account. Loan repayments were generally made through payroll deductions and loans normally must be repaid within five years. Loans become due and payable in full once participants terminated employment, however, the participants would be allowed to continue making the loan payments in accordance with his or her loan agreement.

Forfeited Accounts

At November 30, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0 and \$342. During 2022 and 2021, no forfeitures were used. During 2022, forfeitures of \$347 were transferred to the Koch Industries Employees' Savings Plan as part of the plan merger described in the general paragraph.

2 Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been presented on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2 Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

The Plan's investments were reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net investment gain (loss) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits were recorded when paid.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans were reclassified as distributions based upon the terms of the Plan document. Related fees were recorded as administrative expenses and were expensed when they were incurred.

Administrative Expenses

Certain expenses of the Plan were paid by the Company and were not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses.

Subsequent Events

The Plan administrator has evaluated subsequent events through September 14, 2023, the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

3 Investment in Master Trust

The majority of the Plan's investments were in the Koch Companies Defined Contribution Master Trust, which was established for the investment of assets of the Plan and several other Company sponsored retirement plans. Each participating plan has a divided interest in the Master Trust based on participant account balances. The assets of the Master Trust are held by The Northern Trust Company, the trustee.

Due to the merger of the Plan as described in Notes 1 and 7, the Plan no longer held any interest in the Master Trust as of November 30, 2022.

The Master Trust activity is reported on an annual basis and therefore no activity is presented for the period ended November 30, 2022. The 2022 annual activity is reported in the Koch Industries Employees' Savings Plan (EIN 48-0484227 Plan #002) financial statements, which is the plan that this Plan merged into.

At December 31, 2021, the Plan's interest in the net assets of the Master Trust was 0.15%. Total investment income of the Master Trust is allocated to the participating plans based on each plan's participation in investment options within the Master Trust.

4 Fully Benefit-Responsive Investment Contracts

The Master Trust holds investments in synthetic guaranteed investment contracts (GICs) and other assets as part of the Stable Value Fund.

A synthetic GIC, also known as a wrapper contract, is an investment contract issued by an insurance company or other financial institutions designed to provide a contract value wrapper around a portfolio of bonds or other fixed income securities that are owned by the fund.

The fair value of each synthetic GIC contract is calculated based on the fair value of the investments underlying the contract, which are valued using the market approach. The fair value of each synthetic GIC wrapper is calculated using the replacement cost approach by discounting the difference between indicative replacement cost and the current annual fee multiplied by the contract value times the duration of the contract.

The contract value of synthetic GICs represents contributions made under the contract and reinvested income, less any withdrawals plus accrued income. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are currently no reserves against contract values for credit risk of the contract issuers or otherwise.

The synthetic GICs provide a fixed return on principal over a specified period of time through fully benefit-responsive contracts or wrapper contracts issued by a third party which are backed by underlying assets owned by the Stable Value Fund. The portfolio of assets underlying the synthetic GICs includes collective trust funds, U.S. government and agency securities, municipal bonds, and corporate notes and bonds.

4 Fully Benefit-Responsive Investment Contracts (continued)

The relationship of future crediting rates and the adjustment to contract value reported on the statements of net assets available for benefits is provided through the mechanism of the crediting rate formula. The difference between the contract value and the fair market value of the investment of each contract is periodically amortized into each contract's crediting rate. The amortization factor is calculated by dividing the difference between the fair market value of the investment and the contract value by the duration of the bond portfolio covered by the investment contract.

Key factors that could influence future average interest crediting rates include but are not limited to: Plan cash flows, changes in interest rates, total return performance of the fair market value bond strategies underlying each synthetic GIC contract, default or credit failures of any of the securities, investment contracts, or other investments held in the fund, and the initiation of an extended termination of one or more synthetic GIC contracts by the manager or the contract issuer.

There are certain events not initiated by the Plan participants that could limit the ability of the Plan to transact with the issuer of a synthetic GIC at its contract value. Specific coverage provided by each synthetic GIC may be different from each issuer and can be found in the individual synthetic GIC contracts held by the Plan. Examples of such events include but are not limited to: the Plan's failure to qualify under the Code; full or partial termination of the Plan; involuntary termination of employment as a result of a corporate merger, divestiture, spin-off or other significant business restructuring, which may include early retirement incentives or bankruptcy; changes to the administration of the Plan which decreases employee or employer contributions, the establishment of a competing Plan by the plan sponsor, the introduction of a competing investment option or other plan amendment that has not been approved by the contract issuers; dissemination of a participant communication that is designed to induce participants to transfer assets from the Stable Value Fund; and events resulting in a material and adverse financial impact on the contract issuer, including changes in the tax code, laws or regulations.

The Plan administrator does not believe that the occurrence of any of the aforementioned events, which will limit the Plan's ability to transact with the issuer of a GIC at its contract value with participants, is probable.

Due to the merger of the Plan as described in Notes 1 and 7, the Plan no longer holds an investment in the Stable Value Fund as of November 30, 2022.

5 Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;

5 Fair Value Measurements (continued)

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

CISC Self-Directed Brokerage Account investments are brokerage accounts through which participants may invest in a variety of securities, including stocks, bonds, exchange traded funds, mutual funds, and money market funds. These investments are valued at quoted market prices, which represent the net asset values of the shares held by the Plan at year-end.

As of November 30, 2022, there were no investments held by the Plan as a result of the plan merger as discussed in Notes 1 and 7.

As of December 31, 2021, all Master Trust investments and The Northern Trust common collective trust fund were measured at NAV practical expedient. In accordance with Subtopic 820-10, investments that were measured at net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The collective trust funds are redeemed on a daily basis and do not have any redemption restrictions. Additionally, there are no unfunded commitments as of December 31, 2021. The following table sets forth by level, the fair value hierarchy, a summary of investments held outside the Master Trust at fair value as of December 31, 2021:

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

6 Information Certified by the Plan's Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Northern Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements is complete and accurate:

- a. Investments, fully benefit-responsive investment contracts, and notes receivable from participants, as shown in the statements of net assets available for benefits.
- b. Net investment gain (loss) and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

7 Plan Termination and Merger

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

The Plan Sponsor voted to merge the Plan into the Koch Industries Employees' Savings Plan (EIN 48-0484227 Plan #002) during 2022. The participant accounts merged in July 2022 and residual plan assets relating to forfeited non-vested accounts and the expense account transferred in September 2022. The final transactions occurred in November 2022 to close the trust. In total, \$14,644,884 in assets were transferred out of the Plan.

8 Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by letter dated August 11, 2011, that the Plan and the related trust are designed in accordance with the applicable sections of the Code. The Plan has been amended since receiving the determination letter; however, the Plan administrative committee believes that the Plan and related trust were designed and operated in compliance with the applicable requirements of the Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, the Plan is not currently under audit with respect to any tax periods in progress.

9 Risks and Uncertainties

The Plan, through the Master Trust, invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10 Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments were units of a common collective trust fund managed by The Northern Trust Company. The Northern Trust Company is the trustee for the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Certain fees incurred by the Plan were included in net investment (loss) from the Plan's interest in the Koch Companies Defined Contribution Master Trust, as they are paid through revenue sharing, rather than direct payment. The Plan paid certain expenses related to the Plan's operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Plan Sponsor paid directly any other fees related to the Plan's operations.
