The financial statements comprise the statements of net assets in liquidation available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets in liquidation available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of KPC Media Group Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

### **Note 1. Description of Plan**

The KPC Media Group Inc. 401(k) Retirement Plan (the "Plan") is a defined contribution plan covering substantially all employees of KPC Media Group Inc. (the "Company"), who are age 21 and are not a member of a unit of employees covered by a collective bargaining agreement. The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information.

On May 31, 2022, KPC Media Group Inc. was acquired. No further contributions were made under the Plan and all participant account balances were either rolled over into another Plan or IRA, or were distributed to the participants. The Plan was amended effective September 9, 2022 to terminate the Plan. All distributions were completed by March 2023.

#### Participant Contributions:

Participants may make pre-tax and roth contributions to their individual accounts each Plan year up to 100% of their compensation not to exceed the maximum permitted under the Internal Revenue Code. The Plan also allows catch-up elective deferral contributions for those participants who have attained age 50 by the close of the Plan year. Participants may enter the Plan immediately after reaching the age of 21, and may change the amount of their contribution each pay period.

#### Company Contributions:

The Plan provides for a Company matching contribution to be made at the employer's discretion. In addition, the Company may, at its discretion, make profit sharing contributions to the Plan in an amount determined by the Company's management. No discretionary profit sharing or matching contribution was paid for the year ended December 31, 2022.

#### Participants' Accounts:

Each participant's account is credited with participant contributions, Company contributions (if any), and Plan earnings, and charged with administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Investment Options:

Participants have the option of investing in a variety of investment options offered through John Hancock Life Insurance Company & US Bank, N.A., the recordkeeper of the Plan. The Plan also has a self-directed brokerage account option through U.S. Bank, N.A. All amounts in participant accounts are participant-directed.

#### Vesting:

Participants begin vesting in any Company discretionary contribution plus earnings thereon based on years of continuous service. Participants are 20% vested after two years of service, increasing 20% each year until fully vested in all Company contributions after 6 years.

### **Note 1. Description of Plan (Continued)**

#### Forfeitures:

Participants who terminate employment prior to becoming fully vested must forfeit a percentage of their Company contributions. These forfeitures are used to reduce future Company contributions or pay for administrative expenses. For the year ended December 31, 2022, \$9,503 in forfeitures was used to reduce Company contributions or pay for administrative expenses. The amount of forfeitures held at December 31, 2022 and 2021, was \$0 and \$4,682, respectively.

#### Notes Receivable from Participants:

The Plan allows participants to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The Plan allows for one note to be outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at a fixed rate determined by the plan administrator. The loan plus interest must be repaid to the participant's account based upon terms of the loan agreement. Principal and interest is paid ratably through regular payroll deductions. The balance of the loan becomes due upon termination of employment of the participant.

#### Payment of Benefits:

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum amount, rollover into another qualified plan or remain in the Plan as an inactive participant. If the balance in the participant's account is under \$5,000, the balance will automatically be distributed.

Hardship withdrawals are also allowed from the participant's fully vested account balance with certain restrictions, as outlined in the Plan document.

#### Termination:

Upon the termination of the plan, participants became fully vested in their accounts.

### **Note 2. Significant Accounting Policies**

#### Basis of Financial Statements:

The accompanying financial statements have been prepared on the liquidation basis of accounting as required by accounting principles generally accepted in the United States of America in accordance with Plan termination as described in Note 1. The 2021 financial statements were presented on the going concern basis.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets in liquidation available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### **Note 2. Significant Accounting Policies (Continued)**

#### Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### Investment Valuation and Income Recognition:

John Hancock Life Insurance Company (U.S.A) serves as the Plan's custodian and holds all investments of the Plan, except for the self-directed brokerage account, which is held by U.S Bank, N.A. The brokerage account consists primarily of common stock, mutual funds and interest - bearing cash. John Hancock Life Insurance Company (U.S.A) certifies the completeness and accuracy of the U.S. Bank, N.A. self-directed brokerage account.

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Gains and losses realized upon the sale of a security are calculated by using the average-cost method. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### Notes Receivable from Participants:

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the loan will be deemed distributed and the loan balance will become taxable to the participant.

#### Payment of Benefits:

Benefit payments to participants are recorded when paid.

#### Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net depreciation of fair value of investments.

#### Subsequent Events:

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through September 11, 2023, the date the financial statements were available to be issued.

### **Note 3. Information Certified by the Plan's Recordkeeper**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the recordkeeper, John Hancock Life Insurance Company & US Bank, N.A., and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total investments as shown in the accompanying statements of net assets in liquidation available for benefits.
- b. Net investment income, as shown in the accompanying statement of changes in net assets in liquidation available for benefits, including dividend income and net realized and unrealized depreciation in fair value of investments.

### **Note 4. Fair Value Measurements**

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

### Note 4. Fair Value Measurements (Continued)

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Pooled separate accounts ("PSA"):* Valued at net asset value ("NAV") at the end of the Plan year. PSA's are made up of a wide variety of underlying investments such as equities, preferred stock, bonds, real estate and mutual funds. The NAV is based on the value of the underlying assets owned by the PSA, minus any liabilities, and then divided by the number of shares outstanding. The NAV of a PSA is not a publicly quoted price in an active market, therefore, the NAV is used as a practical expedient to estimate fair value. The Plan's PSA investments have a daily redemption frequency, do not require a redemption notice period, and have no unfunded commitments as of December 31, 2022 and 2021, respectively.

*Stable value fund:* Composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds, common stock and exchange traded funds that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth, by level within the fair value hierarchy, the Plan's investment assets at fair value on a recurring basis as of December 31, 2022 and 2021.

### Note 6. Transactions With Parties-in-Interest

The Company provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation. Administrative expenses for legal, accounting, and other services are rendered by parties-in-interest and are paid by the Company.

### Note 7. Income Tax Status

The Plan, which is a prototype plan, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan as then designed, was in compliance with the applicable requirements of Section 401(a) of the Internal Revenue Code (IRC) and therefore, not subject to tax. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRC. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.
