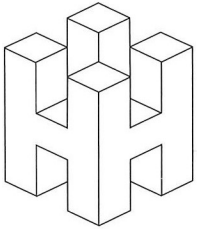

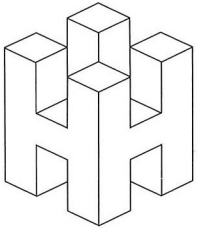

NOTES TO FINANCIAL STATEMENTS

DECEMBER 1, 2022 AND DECEMBER 31, 2021

Note 1 - DESCRIPTION OF PLAN

The following description of Morningside University Tax-Deferred Annuity Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering employees, as defined in the Plan of Morningside University (the Employer) who are full-time or part-time and scheduled to work more than 20 hours per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute up to the maximum percentage of compensation and dollar amount permissible under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, participants with 15 or more years of service may make special 403(b) catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans and 403(b) plans (rollover). Participants direct the investment of all contributions into various investment and annuity options offered by the Plan.

Participant Accounts - Each participant's account is credited with the participant's contributions, as well as allocations of Plan earnings, and charged with withdrawals and an allocation of Plan losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's accounts.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon.

Note Receivable from Participants - Participants may borrow from their participant account balance. Principal and interest are paid ratably through payroll deductions. As of December 1, 2022 and December 31, 2021, the Plan had one loan receivable from participants of \$19,289 and \$3,537.

Plan Loans - Participants may take out plan loans, in which a portion of the participant's account is reserved, or held in collateral. The collateral is held in the TIAA Traditional Annuity.

Payment of Benefits - On termination due to retirement, disability or death, a participant or beneficiary may elect to receive the entire amount credited to the participant's account in either a lump sum or, at the participant's election, in annual installments. Upon termination, other than by retirement, disability, or death, a participant becomes eligible to receive the current value of the participants' vested account in a lump-sum.

Note 2 - SUMMARY OF ACCOUNTING POLICIES

The Plan follows accounting standards set by the Financial Accounting Standards Board, commonly referred to as the FASB. The FASB sets generally accepted accounting principles (GAAP) that the Plan follows to ensure we consistently report Net Assets Available for Benefits and Changes in Net Assets Available for Benefits. References to GAAP issued by the FASB in these footnotes are to the FASB *Accounting Standards Codification*, sometimes referred to as the Codification or ASC.

The following are the significant accounting policies followed by the Plan.

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures. Actual amounts could differ from those estimates.

Risks and Uncertainties - The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition - The Plan's investments in mutual funds and annuity contracts are stated at fair value, which is provided by TIAA-CREF. Net appreciation (decline) in the fair value of investments is based on the fair value of investments at the beginning of the year, or cost, if purchased during the year. Purchases and sales of securities are recorded on a trade-date-basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The plan distributed the 2022 excess contributions, if any, to the applicable participants prior to March 15, 2023.

Voluntary Withdrawals - Participants may be eligible for a hardship withdrawal for reasons stipulated in the Plan document. While an employee is employed by the Employer, he/she may withdraw the amount of elective deferrals credited to his/her account with written consent from the Plan Administrator.

Payment of Benefits - Benefits are recorded when paid.

Administration Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the Participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3 - INVESTMENTS (UNAUDITED)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from the trustees of the Plan that all of the information is complete and accurate. Information included in the accompanying financial statements as to investments, investment income, and all information in the supplemental schedule is presented in reliance solely upon those certifications.

Fair Value Measurements - FASB Accounting Standards Codification 820 defines fair value, establishes a framework for measuring fair value in Generally Accepted Accounting Principles and establishes a hierarchy that categorizes and prioritizes the inputs to be used to estimate fair value. The three levels of inputs used are as follows:

- * Level 1 - Quoted prices in active markets for identical assets or liabilities.
- * Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly such as outside comparable sales.
- * Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 1, 2022 and December 31, 2021.

Traditional Annuity: Valued using a discounted cash flow model.
Mutual Funds: Validate the daily closing price as reported by the fund.

The Real Estate Securities included in Pooled Separate Accounts are valued principally using external appraisals, which are estimates of property values based on a professional's opinion.

The Traditional Annuity accounts are group annuity contracts through TIAA-CREF. Participants enter the contract at a fixed income amount. The fair market value of the account is the value paid when funds are withdrawn prior to their maturity.

Note 4 - INVESTMENT CONTRACTS WITH INSURANCE COMPANY (UNAUDITED)

The Plan invests in unallocated guaranteed fixed annuity contracts with TIAA-CREF. TIAA-CREF maintains the contributions in the TIAA General Account. TIAA groups the premium dollars it receives over defined time periods into vintages, typically composed of one or more contiguous calendar months, for the purpose of determining the crediting rate to participant's accounts. The crediting rate for each vintage is determined, in part, by the net investment earnings rate of the TIAA assets supporting that vintage, minus a charge for administrative expenses and an amount set aside for contingency reserves. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

A portion of the guaranteed investment contracts with TIAA CREF is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to this guaranteed investment contract. The fully benefit-responsive portion of the investment contracts is included in the financial statements at contract value, as reported to the Plan by TIAA-CREF.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate, generally 3%, that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 3%. The TIAA Board of Trustees may declare additional amounts on a year-by-year basis. These additional amounts, when declared, remain in effect for the 12-month declaration year that begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities; they are not guaranteed for future years. The interest rate credited to participants for the fully benefit-responsive portion of the investment contracts for the Plan was 3% for the eleven months ending December 1, 2022.

Certain events limit the Plan's ability to transact at contract value with TIAA-CREF. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan's sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable occurring.

Note 5 - SAFE HARBOR

The University suspended the safe harbor match and any other matching contributions starting with the monthly payroll of July 31, 2020 due to the COVID-19 coronavirus pandemic. The suspension of the matching contribution was temporary in nature and was restarted on February 28, 2022. The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

Note 6 - TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan pays several vendors for record keeping, administrative services, claims processing, custodianship of its investments, benefit consulting services, legal services, and audit services. Transactions with the providers of these services would be considered to be transactions with parties in interest. Further, the Plan receives contributions from the participants' employers and those contributions would also constitute transactions with parties in interest.

Note 7 - FEDERAL INCOME TAX STATUS

The Plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain its tax exemption. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

The administrator has concluded that any uncertain tax positions would be immaterial to the financial statements taken as a whole. Accordingly, the accompanying financial statements do not include any provision for uncertain tax positions, and no related interest or penalties have been recorded in the statement of changes in net assets available for benefits or accrued in the statement of net assets available for benefits.

Note 8 - TERMINATED PARTICIPANTS

Account balances allocated to terminated participants that had not been paid at December 1, 2022 and December 31, 2021 totaled \$0 and \$18,385,372, respectively. These amounts represent terminated participants' vested account balances that had not been paid at year end. For financial statements purposes, these amounts are included in net assets available for benefits.

Note 9 - PLAN TERMINATION

The Plan was terminated and transferred into Iowa Association of Independent Colleges and Universities (IAICU) Multiple Employer Plan on December 1, 2022. As of that date, Morningside University Tax Deferred Annuity Plan no longer exists.

Note 10 - SUBSEQUENT EVENTS

In preparing the financial statements, the Plan has evaluated all subsequent events, for potential recognition or disclosure, through August 8, 2023, the date the financial statements were available to be issued.


