We have performed audits of the financial statements of the Pack Health 401k (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 1, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through November 1, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Emphasis of matter - plan merger

As discussed in Note 6 to the financial statements, Pack Health was acquired by Quest Diagnostics Incorporated in 2022, and as a result, the Pack Health 401k was amended to merge with the Quest Diagnostics Profit Sharing Plan effective November 1, 2022.

NOTES TO FINANCIAL STATEMENTS

November 1, 2022 and December 31, 2021

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Pack Health 401k (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established on January 1, 2017, is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Certain employees of Pack Health LLC (the "Company") who are at least 21 years of age and have completed three months of service are eligible to participate in the Plan. The Plan excludes nonresident aliens and residents of Puerto Rico. Plan management is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's management. Reliance Trust Company (the "Trustee") is the trustee of the Plan.

Pack Health was acquired by Quest Diagnostics Incorporated in 2022. As part of the acquisition, the Plan merged into the Quest Diagnostics Profit Sharing Plan effective November 1, 2022. There was approximately \$742,000 of assets transferred into the Quest Diagnostics Profit Sharing Plan by November 1, 2022 (see Note 6). The following outlines the provisions of the Plan prior to the merger with the Quest Diagnostics Profit Sharing Plan.

Contributions

Each year, participants may contribute up to 90% of their eligible compensation, as defined by the Plan, in accordance with the Internal Revenue Code ("IRC"), subject to certain limitations. Participants may also contribute after tax compensation (Roth contributions) as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan allows for Company discretionary matching and nonelective contributions. The Company did not elect to make any discretionary or nonelective contributions during the period from January 1, 2022, to November 1, 2022.

All contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocation of the Company's discretionary matching and nonelective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and nonelective contributions of their accounts is based on years of continuous service. The Company's discretionary matching and nonelective contributions vest based upon a six-year graded schedule. Participants become 20% vested only after rendering two years of employment and then become 20% vested each year until rendering a full six years of employment. Participants become fully vested upon death or becoming disabled.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at a time. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 2% at inception of the loan. Principal and interest are paid over a maximum five-year maturity schedule unless the loan is for a primary residence which allows for a maturity up to thirty years. Principal and interest are paid ratably through payroll deductions.

Forfeitures

Forfeited accounts will be used to pay plan expenses and reduce future employer discretionary contributions. There were no forfeited accounts during the period from January 1, 2022 to November 1, 2022, and there were no unallocated forfeitures as of November 1, 2022 and December 31, 2021.

Payments of Benefits

On termination of service due to death, disability or retirement, a participant or their beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or in installment payments. For termination of service for other reasons, a participant may elect to defer payment until normal retirement age, provided the participant's vested account is greater than \$5,000, or receive a lump-sum payment, installment payments or a direct rollover to another qualified plan or IRA. If a participant terminates employment for any reason and his or her vested account balance does not exceed \$5,000, the Plan Administrator may distribute such amount in a lump-sum payment to the participant without consent of the participant.

Participants may take an in-service distribution if they have attained age 59½. Participants may also take a hardship distribution in accordance with the hardship provisions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP") and in compliance with Department of Labor Rules and Regulations for Reporting and Disclosures.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in common collective trusts. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis and dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses. If a participant ceases to make his or her loan payments, and the Plan Administrator deems the participant's loan balance to be in default, the participant's loan balance is reduced, and a benefit payment is recorded. There were no outstanding notes receivable from participants as of November 1, 2022 or December 31, 2021.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 1, 2022 and December 31, 2021.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset values ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Valued at the NAV of the collective trust as reported by the collective trust managers. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. These funds seek to maximize total return through capital appreciation and current income.

As a result of the Plan merger, all Plan investments were transferred over to the Quest Diagnostics Profit Sharing Plan by November 1, 2022, therefore, there are no investments balances to disclose as of such date. NOTE 4 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified that the following data included in the financial statements is complete and accurate:

- Investments at fair value as shown in the statements of net assets available for benefits as of November 1, 2022 and December 31, 2021.
- Investment income as shown in the statement of changes in net assets available for benefits for the period from January 1, 2022 to November 1, 2022.

The Plan's independent certified public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

NOTE 5 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Fees incurred by the Plan for the investment management services are included in administrative expenses. The Plan made direct payments to the custodian of \$541. The Company pays directly any other fees related to the Plan's operations. In addition, notes receivable from participants also qualify as party-in-interest transactions.

NOTE 6 - PLAN MERGER

Pack Health LLC was acquired by Quest Diagnostics Incorporated in 2022. As a result of this acquisition, effective May 1, 2022, Pack Health became an employer participating in the Quest Diagnostics Profit Sharing Plan and Pack Health employees ceased further participation in the Plan. All participants in the Plan had their account balances transferred into the Quest Diagnostics Profit Sharing Plan as of November 1, 2022. The Plan amendment and merger were signed on April 29, 2022 with an effective date as of May 1, 2022. There was approximately \$742,000 of assets transferred into the Quest Diagnostics Profit Sharing Plan by November 1, 2022.

NOTE 7 - TAX STATUS

The plan document, which the Plan has adopted via a non-standardized adoption agreement, obtained its latest opinion letter on October 6, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress as of November 1, 2022 and December 31, 2021.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 15, 2023, the date for which the financial statements were available for issuance. Management noted no events subsequent to November 1, 2022 requiring disclosure in the financial statements.
