INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Wingate Healthcare Investment Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Wingate Healthcare Investment Plan Company's 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2022 AND 2021

1. DESCRIPTION OF THE PLAN

The following description of the Wingate Healthcare Investment Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a participant directed defined contribution plan covering all employees of Wingate Healthcare, Inc. (the “Company”). The Plan was established on January 1, 1988. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Employees must be at least age 21 and have completed one month of service to be eligible for salary deferral contributions, employer match, and profit-sharing contributions. Employees may enter the Plan the first day of the month following satisfaction of eligibility requirements. Officers of the Company are responsible for oversight of the Plan and determine the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions – Each year, participants may contribute 1% up to the maximum statutory limit of their annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Discretionary employer matching contributions may be made as determined by the Company, provided that the amount to be contributed shall not be in excess of the maximum amounts deductible under the Internal Revenue Code (“IRC”). The Plan also provides for discretionary profit-sharing contributions to be made by the Company. Employees become eligible for the match upon completion of 1,000 service hours. There were no employer match contributions during 2022 and 2021.

Participants’ Accounts – Each participant’s account is credited with the participant and Company’s contributions as well as allocations of net Plan earnings and expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which the participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are vested immediately in their contributions and company qualified non-elective contributions plus actual earnings thereon. Vesting in the Company’s matching contributions and earnings thereon is based on continuous years of services. In the event of retirement, permanent disability, or death, a participant’s employer contribution account becomes fully vested. A participant is 100% vested after 6 years of credited service as follows:

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest as determined by the plan administrator based on prevailing market conditions at the time of the loan and fixed over the life of the loan. The Plan does not permit loan terms to exceed five years unless the loan is for the purchase of a principal residence.

Administrative Expenses – If not paid by the Company, administrative expenses of the Plan are paid by the Plan. Any expenses paid by the Company are excluded from these financial statements. Certain recordkeeping and administrative expenses paid by the Plan are allocated to participants.

Forfeitures – Forfeitures represent the non-vested interest in the Plan. These amounts are applied to reduce future employer matching contributions to the Plan or to pay Plan expenses. At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$198 and \$135, respectively. During 2021, \$4,490 of the forfeited non-vested account was used to pay plan expenses. There were no forfeited balances used to pay plan expenses during 2022.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value (except for fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Officers of the Plan determine the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Plan Termination – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

In 2021 and 2022, the Company has made divestitures of certain facilities resulting in a partial plan termination. Participants affected by the divestitures have been fully vested in their accounts.

3. INFORMATION CERTIFIED AND PROVIDED BY NATIONWIDE TRUST COMPANY

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net (depreciation) appreciation in fair value of investments, dividend income and interest income on notes receivable from participants for the years ended December 31, 2022 and 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company, FSB (the trustee of the Plan).

4. TAX STATUS

The IRS has determined and informed the Company by a letter dated June 7, 2021, that the Plan and related trust are designed in accordance with applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe the Plan is qualified. Therefore, no provision for income taxes has been recorded.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation method include: quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

5. FAIR VALUE MEASUREMENTS (CONTINUED)

- Level 3: Inputs to the valuation method are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021:

Mutual funds – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. GUARANTEED INTEREST ACCOUNT

The Plan invests in an indexed fixed contract which is fully benefit responsive as the contract does not restrict the frequency or amount of participant-directed exchanges. Nationwide Trust Company, FSB (Nationwide) maintains contributions in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate which is reset quarterly and is guaranteed to the Plan. The contract value is \$1,129,881 and \$1,075,184 at December 31, 2022 and 2021, respectively. The average yield was 2.59% and 1.29% in 2022 and 2021, respectively.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Nationwide, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Participant transactions (purchases and sales) may occur daily, and there are no unfunded commitments. In the event the Plan initiates a full redemption of the investment contract, Nationwide reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

7. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments consist of a guaranteed investment fund managed by Nationwide (and affiliates). Nationwide is the trustee for the Plan and therefore, these transactions qualify as party-in-transactions. Notes receivables from participants also qualify as party-in-interest transactions.

8. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. SUBSEQUENT EVENTS

Effective August 2023, the Plan changed custodian from Nationwide Trust Company to Fidelity Management Trust Company ("Fidelity"). As a result of this transfer, participants were no longer able to contribute to investment options offered by Nationwide. The Plan Sponsor and Fidelity completed a mapping of the previous investment options to the new investment options provided by Fidelity. A total of \$27,258,175 was transferred to Fidelity on August 1, 2023, which consisted of \$26,925,092 in investments from participant accounts, and \$333,083 in notes receivable from participants.

The Plan has evaluated subsequent events through August 21, 2023, the date the financial statements were available to be issued.
