Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Geotechnology Holdings, Inc. Retirement Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the year ended October 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Empower Annuity Insurance Company of America and Empower Trust Company, LLC (a qualified institution) as of and for the year ended October 31, 2022, and from Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC (a qualified institution) as of and for the year ended December 31, 2021, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Geotechnology Holdings, Inc. Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. NOTE A - DESCRIPTION OF PLAN

The following description of the Geotechnology Holdings, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all non-union employees of Geotechnology Holdings, Inc. and subsidiaries. The Plan was amended and restated effective January 1, 2021. The name of the Plan was changed to Geotechnology Holdings, Inc. Retirement Plan, and the plan sponsor was changed to Geotechnology, LLC (a subsidiary of Geotechnology Holdings, Inc.).

On June 30, 2021, Geotechnology Holdings, Inc. was acquired by Universal Engineering Sciences. Subsequent to the acquisition, on November 1, 2022, the accounts of Geotechnology Holdings, Inc. Retirement Plan were transferred out of the Plan to the Universal Engineering Sciences 401(k) Plan (an existing plan controlled by the acquiring company), and the Geotechnology Holdings, Inc. Retirement Plan was effectively terminated. Transfers totaled \$23,229,650 and consisted of diversified investments, after applicable expenses and distributions were made.

Employees are eligible to participate in the Plan if they are age twenty-one or older and have completed 3 months of service.

Upon reaching the eligibility requirements, employees can begin to participate on the first day of the month coinciding with or following the date the eligibility requirements are satisfied.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute up to 75% of pretax annual compensation subject to certain limits, as defined in the Plan.

Eligible participants will automatically defer 3% of included compensation for each payroll period, unless the eligible participant makes a contrary salary reduction agreement within a reasonable period following the participant's entry date. If the participant does not provide a contrary election, the automatic deferrals will apply. For those participants whose entry dates are on or after February 1, 2021, the automatic deferral percentage will automatically increase 1% per year up to a maximum of 6% of compensation on the anniversary of the participant's entry date.

Additionally, the employer may make discretionary matching contributions to the Plan based on participants' elective deferrals. For the year ended October 31, 2022, the Company elected to make matching contributions based on 50% of salary deferrals, not to exceed 6% of compensation.

The Company may also make discretionary profit-sharing contributions. The amount, if any, is determined each year by the Company. For the year ended October 31, 2022, the Company made no discretionary profit-sharing contributions.

Participants' Accounts - Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and the Plan earnings (losses) thereon, and charged with an allocation of investment expenses. Allocations are based on participant account balances. The benefit to which a participant is entitled is based on the participant's vested account balance.

The contributions to the Plan, both employee and employer, are allocated to the various funds at the direction of the participant. The Plan provides for various investment options for participants' elective and employer contributions. Participants should refer to each fund's prospectus for a description of the fund's investment objectives.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions plus earnings is based on years of continuous service. Company contributions and earnings are vested in accordance with the following schedule:

Notes Receivable from Participants - Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account. Interest rates on the loans are set at rates as determined by the Plan Administrator.

Distributions - In the case of normal retirement or termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or a joint and survivor annuity. Distributions upon the death of a participant prior to receiving any benefits shall be made pursuant to the election of the participant or beneficiary.

The Plan Administrator will direct the Trustees to make a lump sum distribution if the vested account balance is less than or equal to \$5,000 regardless of whether a request for a distribution is made. Written consent will be required for any distribution if the vested account balance is greater than \$5,000. In the event of a distribution greater than \$1,000 that is made without the participant's consent, the Plan Administrator shall pay the distribution in a direct rollover to an individual retirement plan.

Forfeited Accounts - The non-vested balance is forfeited upon termination of service. At October 31, 2022 and 2021, forfeited non-vested accounts totaled \$0. Forfeitures are used to reduce employer contributions. For the year ended October 31, 2022, forfeitures transferred to the acquiring plan with plan assets totaled \$20,125.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. As such, fully benefit-responsive investment contracts are measured, presented, and disclosed only at contract value.

Notes Receivable from Participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of October 31, 2022 and 2021, no allowance for credit losses has been recorded. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

At October 31, 2022 there were no notes receivable from participants. The Plan had notes receivable from participants totaling \$168,860 at December 31, 2021.

Excess Contributions Payable – Amounts payable to participants for contributions in excess amounts allowed by the IRS are recorded as a liability on the statements of assets available for benefits and as corrective distributions on the statement of changes in assets available for benefits. There were no excess contributions payable at October 31, 2022. The Plan distributed the 2021 excess contributions to the applicable participants on April 5, 2022.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investments in collective trust funds are valued based on calculated net asset value per share. In accordance with FASB ASC 820, *Fair Value Measurement*, the Plan has elected to measure the fair value using net asset value per share as a practical expedient. As a result, the investment in collective trust funds is not categorized in the fair value hierarchy (see Note D).

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Operating Expenses - Expenses of maintaining the Plan are paid by the Company and the Plan (see Note F).

Concentrations - The Plan had an investment in one investment fund, Great-West Lifetime 2035 Trust, sponsored by Great-West Trust Company, LLC, which represented approximately 14% of net assets available for plan benefits as of December 31, 2021.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value, except for the Guaranteed Interest Fund which is reported at contract value, in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement and accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs consist of quoted prices for similar assets in active markets and Level 3 inputs are only used when Level 1 or Level 2 inputs are not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2022 or December 31, 2021.

Level 1 Fair Value Measurements - The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are considered to be actively traded.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended October 31, 2022, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3.

NOTE E - GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan has a benefit-responsive investment contract with Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Empower).

Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Guaranteed Interest Fund (GIF) issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan for a specified period of time as outlined in the Group Annuity Contract.

Because the Guaranteed Interest Fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The GIF is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the GIF at October 31, 2022 and December 31, 2021 was \$0 and \$657,207, respectively. The average yield and crediting interest rate was approximately 1.40% for December 31, 2021. Such interest rates are reviewed at least as frequently as annually for resetting.

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable.

NOTE F - PARTIES-IN-INTEREST AND RELATED PARTY

Certain plan investments are shares of investments managed by the Empower Annuity Insurance Company of America and Empower Trust Company, LLC, which are the Trustees of the Plan. Fees paid amounted to \$32,533 for the year ended October 31, 2022.

The Plan incurs expenses related to general and administration and recordkeeping. The Plan Sponsor pays certain accounting and auditing fees relating to the Plan.

Additionally, the Plan has service providers which are considered parties-in-interest under ERISA.

NOTE G - PLAN TERMINATION

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

As stated in Note A, the Plan was terminated on November 1, 2022, when the accounts were transferred out of the Plan to Universal Engineering Sciences 401(k) Plan.

NOTE H - TAX STATUS

The Internal Revenue Service has determined and informed the Trustees by opinion letter, dated March 31, 2014, that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J – COMPLIANCE TESTING FAILURE AND REMEDY

The Plan failed the following compliance test with the associated corrective amount for the year ended October 31, 2022:

Corrective refunds for the plan were not completed prior to the transfer of plan assets and were processed by the new plan in April 2023. The IRS levies a 10% excise tax on excess contributions that have not been distributed within 2 ½ months after the plan year end. As the corrective distributions for the plan were not made within the prescribed time limit, a Form 5330 was filed on August 25, 2023, including payment of \$1,525 tax due.
