The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

1. Description of Plan

The following description of the Interceramic, Inc. 401(k) Retirement Plan (the Plan) provides only general information. The Plan is sponsored by Interceramic, Inc. (the Company or Employer). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was formed effective July 1, 1988, is a defined contribution plan. The Plan was most recently restated effective January 1, 2017. The Plan excludes nonresident aliens and employees covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Custodian and Administration of the Plan

The custodian and recordkeeper of the Plan is Voya Retirement Insurance and Annuity Company (Voya, VRIAC, or the Custodian). The administrator of the Plan is the Company. The Custodian holds all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees who are 21 years of age or older are eligible to participate in the Plan upon completion of 60 days of service and may enter the plan on the first day of the next month upon meeting eligibility requirements.

Contributions

The Plan allows for the following types of contributions:

- *Pre-Tax Compensation Deferral 401(k) Contributions* - Participants may contribute on a pre-tax basis up to 100% of their eligible compensation each pay period, including catch-up contributions, once eligible, subject to certain annual Internal Revenue Code (IRC) limitations. Participants may terminate or change their contributions as of each payroll periods according to procedures and limitations as determined by the Plan Document.
- *Discretionary Employer Matching and Profit-Sharing Contributions* - The Plan also provides for discretionary employer matching contributions. During the year ended December 31, 2020 and through March 21, 2021, the Company matched \$0.50 per every dollar up to 6% of the participant's eligible compensation each payroll period. Effective March 22, 2021, employer matching contributions were suspended due to economic impacts from COVID-19 and the Company's need to reduce expenses.

The Company may also make discretionary employer profit sharing contributions at the option of the Company's Board of Directors. No additional discretionary or employer profit sharing contributions were made in 2022 and 2021.

- *Rollover Contributions* - Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts

Participants' accounts are credited with participant pre-tax, rollover, discretionary employer matching, and discretionary employer profit sharing contributions, as well as an allocation of plan earnings or losses. Participants are charged with certain administrative fees that are paid by the Plan. Earnings or losses from investment funds are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option. Participant accounts are also credited or debited with participant-initiated transactions. Participants may direct the investment of their account balances into various mutual funds and fixed-rate group annuity contracts offered by the Plan. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are always 100% vested in their contributions and any earnings thereon as well as any rollover contributions to the Plan and any earnings thereon. Vesting in the Company contribution portion of their accounts plus actual earnings thereon vest in accordance with the following schedule:

Upon death, total and permanent disability, or the first day of the following month after reaching the age 55 (Early retirement age) prior to termination, participants become 100% vested.

Forfeited Accounts

Forfeitures may be used to reduce future plan expenses or to offset Employer contributions. As of December 31, 2022 and 2021, forfeited non-vested accounts totaled \$25,822 and \$17,758, respectively. The Plan used \$8,401 and \$8,131 of forfeitures to reduce the Company's administrative expenses for the years ended December 31, 2022 and 2021, respectively.

Payment of Benefits

Upon termination of service, death, disability, or retirement, the participant will receive the value of the vested interest in his or her account in the form of a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 59½, has been employed for at least five years and the amounts being distributed have accumulated in the Plan for at least two years.

For terminated participants whose vested account balance is less than \$1,000, a lump-sum cash distribution will be made, if the participant does not elect another form of distribution. For terminated participants whose vested account balance is greater than \$1,000 but less than \$5,000, the account balance will be rolled over into an individual retirement account (IRA) in the name of the participant, if the participant does not elect another form of distribution. Payment shall be made as soon as administratively feasible following severance of employment.

A participant may receive a hardship distribution if certain criteria as defined within the Plan are met.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan and up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Each participant may not have more than one loan outstanding at any time. Loans are secured by the participant's account and bear an interest rate at prime rate plus 1%, charged by the Company's principal financial institution, as of the date of the loan. Interest rates on outstanding loans at December 31, 2022 ranged from 4.25% to 6.50%.

The notes are repaid ratably through check for prepayment or through payroll deductions over a period of five years or less, unless used for the purchase of a primary residence, in which case the term may extend up to 20 years. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Administrative Expenses

Administrative expenses of the Plan are paid by the Company, except for certain expenses that are charged to participant accounts, including loan and withdrawal fees. Certain investment expenses which are charged within investments are presented net of the appreciation (depreciation) in fair value of investments. All other expenses of the Plan for the year ended December 31, 2022 were paid by the Company and are excluded from these financial statements.

Investment Options

Upon enrollment in the Plan, a participant may direct employer and employee contributions of any percentage, subject to Internal Revenue Service's (IRS) limitations, in any of the investment options. Participants may change their investment options daily.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note 5 for further details related to the Plan's valuation methods under Accounting Standards Codifications (ASC) 820. Net appreciation or depreciation represents the

difference between the aggregate fair value of investments at year-end and the values at the beginning of the year (or date purchased during the year), and includes any realized gains and losses in shares that were bought and sold during the year and reinvested capital gain distributions on those investments.

Purchases and sales of investments are recorded on a settlement-date basis, which approximates investments recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Contributions

Participant deferral contributions and related discretionary matching contributions are recognized in the plan year during which the Company makes the respective payroll deduction from the participant's compensation. Discretionary employer profit sharing contributions, if any, are recognized in the plan year to which the participant's compensation relates.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan document. There was no allowance at December 31, 2022 or 2021 as the loans are fully collateralized by the participants' accounts.

3. Fully Benefit-Responsive Guaranteed Investment Contracts

The Plan has adopted ASC 962, *Reporting of Investment Contracts Held by Health and Welfare Benefit Plans and Defined Contribution Pension Plans*. The Plan holds fully benefit-responsive investment contracts through its investments in the Voya Fixed Account and Voya Fixed Account A. As of December 31, 2022 and 2021, the total contract value of these investments is \$2,725,161 and \$2,455,325, respectively.

Generally, contract value of these accounts is equal to participant deposits minus participant withdrawals plus credited interest. Interest credited is net of expenses. Contract value may be subject to adjustments in connection with contract holder directed withdrawals that are subject to a market value adjustment. Under limited circumstances, (certain in-service participant withdrawals) contract value may be adjusted as a result of a market value adjustment. The fair value of these accounts is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations.

The average yields based on actual earnings for the contract and the crediting interest rate to participants for both of the years ended December 31, 2022 and 2021 were 3.0% for the Voya Fixed Account and Voya Fixed Account A, respectively. VRIAC makes this guarantee, and although VRIAC may credit a higher interest rate, the credited rate will never fall below the lifetime guaranteed minimum of 3.0% (Voya Fixed Account) or 1.0% (Voya Fixed Account A).

VRIAC's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market value adjustment may apply to amounts withdrawn at the request of the contract holder. The underlying contract has no restrictions on the use of Plan assets and there are no valuation reserves recorded to adjust contract amounts. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (ii) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. VRIAC, the GIC issuer, has the option to pay out the current value of the contract only after completion of five contract years.

4. Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya, a qualified institution, has certified that the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as reflected in the Statements of Net Assets Available for Benefits as of December 31, 2022 and 2021.
- Total investment income (loss) as reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2022.
- Investment information included in the Schedule H, line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2022, as reflected in the ERISA-required supplemental schedule.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule are in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

5. Fair Value Measurements

ASC 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual Funds

Mutual funds represent investments with various investment managers. The fair value of these investments is determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the quoted asset value as of December 31, 2022 and 2021.

Notes to Financial Statements

6. Related Party and Party-In-Interest Transactions

The Plan invests in shares of mutual funds and a fully benefit responsive investment contract with Voya. Voya acts as Custodian for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from prohibited transaction rules. In addition, notes receivable from participants are also considered party-in-interest transactions.

7. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

8. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts. On March 23, 2023, the Plan Administrator approved the termination of the Plan, with an effective date of September 30, 2023. See Note 10.

9. Income Tax Status

The Plan is a Prototype non-standardized Plan sponsored by VOYA. The IRS has determined and informed the Custodian by a letter dated June 30, 2020, that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the IRC. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, there was no provision for income taxes as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

10. Subsequent Events

On March 21, 2023, the Company decided to close its U.S. operations. As a result of this decision, on March 23, 2023 and by mail on August 15, 2023, the managers of the Plan approved the termination of the Plan, with an effective date of August 31, 2023.

The Plan has evaluated subsequent events through September 18, 2023, the date the financial statements were available to be issued.
