INDEPENDENT AUDITOR'S REPORT

SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT

We have performed audits of the financial statements of Agilitas USA, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets in liquidation available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets in liquidation available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2022 and 2021 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

OPINION

In our opinion, based on our audits and on procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

BASIS FOR OPINION

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

EMPHASIS OF MATTER - PLAN TERMINATION AND LIQUIDATION BASIS OF ACCOUNTING

As further discussed in Notes 1 and 9 to the financial statements, the Board of Directors of Agilitas USA, Inc. 401(k) Plan approved a plan of liquidation in August 2022, and management determined liquidation is imminent. As a result, Agilitas USA, Inc. 401(k) Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

AUDITOR'S RESPONSIBILITIES FOR THE AUDIT OF THE FINANCIAL STATEMENTS

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

DECEMBER 31, 2022

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of Agilitas USA, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

Prior to liquidation, the Plan was a participant directed defined contribution plan, covering substantially all eligible employees of Agilitas USA, Inc. (the "Employer"), as a member of a control group. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan Oversight Committee was responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Effective August 2, 2021, the Employer was acquired by Rehab Employee Services, LLC ("Rehab"). From the acquisition date through December 31, 2021, plan participants continued to participate in the Plan. On January 1, 2022, employees of the Employer became employees of Rehab and were eligible to participate in the Rehab Employee Services 401(k) Plan, a defined contribution plan, at which time no further contributions were made to the Plan. On May 25, 2022, the Plan was terminated, and all participants became 100% vested in their Employer contributions. Effective August 1, 2022, the Employer and Rehab, and their respective defined contribution plans, entered into a Merger and Transfer Agreement (the "Agreement") whereas the Employer agreed to transfer all the Plan assets into Rehab Employee Services 401(k) Plan, remove the Employer as the plan sponsor and plan administrator and name Rehab as the plan sponsor and plan administrator. The Agreement appoints a new plan service provider, Empower Retirement, LLC ("Empower"), to provide investment options as well as certain third-party administrator functions for the Plan. Plan assets were transferred from AdvisorTrust, Inc. to Empower as soon as administratively practical from the Agreement date. The merger did not impact participant benefits as the benefit provisions were incorporated in the Rehab Employee Services 401(k) Plan and as protected under the Internal Revenue Code ("IRC").

Eligibility

Prior to liquidation of the Plan, all employees were eligible to participate in the Plan beginning the month after reaching age 21 and completing 1 month of service, as defined in the plan document.

Contributions

Prior to January 1, 2022, participants elected to defer up to 100% of their compensation, as defined in the plan document. Participants could also contribute amounts representing distributions from other qualified plans. Participants could change their salary deferral percentage at any time. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions.

Contributions to the Plan ceased effective January 1, 2022 in accordance with the Agreement.

The Plan was amended effective April 1, 2019, to provide an Employer match contribution on a quarterly basis, however, participants had to be employed on the last day of the calendar quarter to receive a match allocation. The Employer match was equal to 25% of deferrals up to 4% of compensation with a cap of \$250 each quarter. The Employer made a discretionary match of \$335,425 during 2021. The Employer did not make any discretionary match contributions or an Employer discretionary profit sharing contribution for the 2022 Plan year.

Effective March 1, 2021, the Plan was restated to allow automatic enrollment whereby employees were automatically enrolled in the Plan at 4% of compensation unless the participant made an election otherwise.

Contributions were subject to certain limitations in accordance with applicable regulatory requirements.

Participant accounts

Prior to liquidation, each participant's account was to be credited with the participant's contributions, allocations of Employer contributions and plan earnings, and reduced by an allocation of administrative expenses, any distributions and plan losses. Allocations were based on participant earnings, account balances or specific participant transactions, as defined by the plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Investment options

Prior to liquidation, participants directed the investment of their contributions into various investment options offered by the Plan.

Vesting

Prior to liquidation, participants were immediately vested in their contributions, plus actual earnings thereon. Vesting in Employer contributions was based on years of service equal to 1,000 hours. Participants vested ratably over 6 years, resulting in 100% vesting after 6 years of credited service. Irrespective of years of service, a participant was 100% vested if they were employed on or after normal retirement age of 65 or if they died or became disabled.

On May 25, 2022, all participants became 100% vested in their Employer contributions in accordance with the Agreement.

Notes receivable from participants

Notes receivable from participants were not permitted.

Payment of benefits

Prior to liquidation of the Plan, benefit distributions were payable to the participant or beneficiary upon normal retirement (age 65), death, disability or termination of employment. The method of distribution shall be determined by the Plan Administrator in accordance with the provisions of the Plan. Participants who are eligible to receive a benefit distribution due to normal retirement, death or disability will receive 100% of their account balance. Benefit distributions due to termination are limited to the participant's vested account balance.

In-service withdrawals

Prior to the liquidation of the Plan, in-service withdrawals were permitted by participants who had reached the age of 59 1/2. Early withdrawals could also be made in the case of financial hardship, as determined by the Employer.

Forfeitures

Forfeitures result from termination of employment under circumstances which do not entitle the participant to be fully vested in their Employer contributions. Forfeitures remaining at December 31, 2022 and 2021, amounted to \$0 and \$4,762, respectively, and were available to be used to pay Plan expenses or offset Employer contributions. Forfeitures of \$4,762 were used to pay Plan expenses during 2022.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

Due to the decision to terminate the Plan during 2022, management determined that liquidation of the Plan is imminent and the financial statements for 2022 have been prepared using the liquidation basis of accounting. The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates

The preparation of financial statements in conformity with GAAP requires the Plan to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Prior to liquidation, investments were stated at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determined the valuation policies utilizing information provided by the Trustee.

All investments reported in the Statement of Net Assets in Liquidation Available for Benefits as of December 31, 2022, are reported at liquidation value. For all investments fair value approximated the amount the Plan expected to collect upon liquidation.

Purchases and sales of securities were recorded on a trade-date basis. Interest income were recorded on the liquidation basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefit payments were recognized when paid.

Expenses

Expenses of maintaining the Plan were paid by both the Plan and the Employer. Expenses paid by the Employer were excluded from these financial statements.

Excess contributions payable

Prior to liquidation of the Plan, amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") were recorded as a liability with a corresponding reduction to contributions. The Plan distributed 2021 excess contributions to the applicable participants in 2022.

Events occurring after reporting date

The Plan has evaluated events and transactions that occurred between December 31, 2022 and September 15, 2023, the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

NOTE 3 - INFORMATION CERTIFIED BY TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements including investments held at December 31, 2022 and 2021, and investment income for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified by AdvisorTrust, Inc., the Trustee of the Plan.

NOTE 4 - FAIR VALUE

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using unadjusted quoted prices from active markets for identical assets), Level 2 (not traded on an active market, but for which observable market inputs are readily available) and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value:

Mutual funds	Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
Exchange traded funds	Valued at the daily closing price as reported by the fund. Exchange traded funds held by the Plan are open-end exchange traded funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The exchange traded funds held by the Plan are deemed to be actively traded.
Money market fund	Valued at the NAV of shares held by the Plan at year end and normally transact at \$1.

There have been no changes in the valuation methodologies used at December 31, 2022 and 2021.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invested in investment securities which are exposed to various risks, such as interest rate, credit and overall market risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

At December 31, 2021, the Plan had a concentration of investments two funds, which represented approximately 33% of total investments.

NOTE 6 - INCOME TAX STATUS

The Plan adopted a pre-approved plan document (Pre-Approved Plan). The Pre-Approved Plan received its latest opinion letter on June 30, 2020, in which the IRS stated the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not applied for a separate determination letter.

The Plan Administrator and the Plan's tax counsel believe the Plan and Pre-Approved Plan are designed and have been operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been provided in the financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

NOTE 7 - PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Plan investments are held by the Trustee, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in administrative expenses.

These party-in-interest transactions are exempt from the prohibited transactions provisions of ERISA and the IRC.

NOTE 8 - EXCESS CONTRIBUTIONS PAYABLE

In accordance with applicable discrimination testing rules, certain participants exceeded the maximum allowable contributions for the year ended December 31, 2021. Accordingly, excess contributions amounted to \$31,599 in 2021 were accrued and recognized as a liability in the accompanying statement of net assets available for benefits as of December 31, 2021. The Plan reimbursed participants for these contributions and earnings in 2022.

NOTE 9 - PLAN MERGER AND TERMINATION

As discussed in Note 1, the Employer discontinued employee and employer contributions into the Plan as of January 1, 2022. The Employer has the right to terminate the Plan subject to provisions of ERISA. Liquidation was imminent at the end of the Plan year end and substantially all of the assets of the Plan merged into Rehab Employee Services 401(k) Plan during the year ended December 31, 2022.
