## **REPORT OF INDEPENDENT AUDITORS**

To the Participants and Administrator  
Off Duty Services, Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Off Duty Services, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of Off Duty Services, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan, sponsored by Off Duty Services, Inc., is a safe harbor defined contribution plan covering substantially all employees of Off Duty Services, Inc. and OD Payroll Services, Inc. (collectively, the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 30, 2022, all participants were transferred out of the Plan to the Protos Security 401(k) Plan. The amount of the transfer was \$2,666,159.

The Plan is designed as a 401(k) “safe harbor” plan. Accordingly, the Company is required to make an employer qualified safe harbor contribution. The 401(k) “safe harbor” plan design provides for, among other things, the exemption from certain annual compliance testing.

**Eligibility**

Substantially all employees of the Company are eligible to participate in the Plan after completion of one year of service with at least 1000 hours.

**Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also make Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe harbor matching contributions equal to 100% of participant contributions that do not exceed 3% of compensation plus 50% of contributions between 3% and 5% of compensation. The Company has the discretion to make additional matching contributions and/or profit-sharing contributions. There were no additional matching or profit-sharing contributions made for participants for the year ended December 31, 2022. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company safe harbor matching contributions, as well as discretionary additional matching and profit-sharing contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant’s contributions, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions and employer safe harbor matching contributions plus actual earnings thereon. Regardless of the vesting schedule, a participant will become fully vested in Company discretionary additional matching and profit-sharing contributions upon death or total and permanent disability.

Except as otherwise stated above, participant vesting in discretionary additional matching and profit-sharing contributions is as follows:

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lessor of \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at any time. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service for any reason, participants with a vested account balance less than \$5,000 will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account as soon as administratively feasible. Terminated participants with a vested account balance greater than \$5,000 may elect to receive a single lump-sum payment or partial withdrawals or installments if required to receive required minimum distributions.

Withdrawals from a participant's account may also be made in the event of financial hardship, in accordance with the provisions specified in the Plan.

**Forfeited Accounts**

At December 31, 2022 and 2021, forfeited non-vested account balances totaled \$0 for each year. These accounts were to be used to reduce future employer contributions or to pay Plan expenses. During 2022, \$0 of forfeited non-vested account balances were used to offset employer contributions and expenses.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by investment advisors, trustees and insurance companies. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits**

Benefits are recognized when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in depreciation of fair value of investments.

**SUBSEQUENT EVENTS**

The plan has evaluated subsequent events through September 12, 2023, the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1 Inputs**

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2 Inputs**

Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3 Inputs**

Inputs are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodology used at December 31, 2022 and 2021:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – CERTIFIED INVESTMENTS**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Great-West Life & Annuity Insurance Company (GWLA), an affiliate of Empower Retirement, the insurance company and record keeper of the Plan has furnished certain financial information to the Plan administrator and certified as to its completeness and accuracy. These certifications are as of December 31, 2022 and 2021 and for the year ended December 31, 2022 and includes investment information related to fair value of investments, notes receivable from participants, interest and dividend income, interest income on notes receivable from participants and net depreciation in fair value of investments that are included in the Plan’s financial statements and supplemental schedule.

**NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan held a separate account guaranteed interest account which was a fully benefit-responsive investment contract with MassMutual (fixed interest fund). The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. MassMutual was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting interest rate was based on a formula established by the contract issuer but may not be less than 3.00%. The crediting rate was reviewed on a semi-annual basis for resetting. The guaranteed investment account did not permit the insurance company to terminate the agreement prior to its scheduled maturity date. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

**NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (Continued)**

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan; (2) changes to the Plan's prohibition on competing investment options or deletion of equity washing provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract insurers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of a termination, participants would become 100% vested in their discretionary additional employer matching contributions and profit-sharing contributions. On December 30, 2022, the Plan merged into Protos Security 401(k) Plan. All participants and their account balances were transferred to the Protos Security 401(k) Plan.

**NOTE 7 — RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by GWLA, which is the Plan's insurance company and record keeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid to this party-in-interest were \$1,870 for the year ended December 31, 2022.

**NOTE 8 – TAX STATUS**

The underlying non-standardized prototype plan has received an opinion letter from the IRS dated November 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the “Code”). In accordance with Revenue Procedure 2002-6 and Announcement 2001-77, the Plan Sponsor has determined that it is eligible and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
