Subject: Reasonable Cause Letter – Late 5500 filing (2022)

Background: Effective July 1, 2022, CGC was sold and by October 31, 2022 all participants of our 401k plan rolled their accounts over to the new employer or an IRA. Max Rubin, who had taken over duties as Plan Administrator for several years, chose not to stay with the new company and resigned in September 2022.

I (Raymond Rudek) resumed Plan Administrator duties at that time. At some point in December 2022, the new company discontinued my email address ([rudek@thinkcgc.com](mailto:rudek@thinkcgc.com)). I established a new one ([chiefbean1943@outlook.com](mailto:chiefbean1943@outlook.com)) and am confident I changed my contact information on the 401k ADP site.

Reasonable Cause: My understanding was that the 5500-filing deadline was 7/31/2023. I routinely checked our ADP 401k site for the 5500's. None were posted. At some point in July 2023, I contacted Julie Skinner (ADP 401k contact) who advised me of the new site/login requirements. I attempted to login numerous times near the end of July 2023, without success. On 8/1/2023 I went on an extended vacation, returning late last week. Again, I contacted Julie Skinner and she emailed me new login info yesterday. Today after failed attempts to login, I called and was referred to the "Consultation Team".

In conclusion, I proactively attempted to file the 5500's on time. If information was sent to me regarding the new process, I never received it – but was informed of it at some point in July 2023 by Julie Pritchard. My attempts to login and file the 5500's under the new procedure have not been successful. I respectfully submit this information as "reasonable cause". Most likely there is an audit trail of my login attempts at both the original and new 5500 processing site.
