### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of CMTA, Inc. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (in liquidation) as of November 1, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits (in liquidation) for the period January 1, 2022 through November 1, 2022, and the year ended December 31, 2021, and the related notes (in liquidation) to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to the Plan's assets held for investment (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the period January 1, 2022 through November 1, 2022 and the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section—

all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).

- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Basis of Accounting**

As discussed in Note 2 to the financial statements, the Plan's governing body approved a plan of liquidation effective August 9, 2021, and management determined plan liquidation was imminent. As a result, the Plan used the liquidation basis of accounting in presenting the accompanying financial statements. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audits of the Financial Statements**

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

### NOTES TO FINANCIAL STATEMENTS (IN LIQUIDATION)

Period January 1, 2022 through November 1, 2022 and Year ended December 31, 2021

---

#### 1. Plan description

The following brief description of the CMTA, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions. Copies of the Plan Agreement are available from CMTA, Inc. (the Company).

**General** – The Plan was a contributory defined contribution plan covering substantially all the Company's employees who were age 21 or older. The Plan was subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan's governing body authorized the Plan's termination effective August 9, 2021 (termination date). As a result, the Plan's participants became fully vested in their accounts as of the termination date. The Plan's management distributed all plan assets in accordance with ERISA rules and regulations.

**Contributions** – Through the Plan's termination date, participants were allowed to contribute up to the maximum salary deferral set by law and to contribute amounts representing rollover distributions from other qualified plans. The Plan was subject to a safe harbor matching provision which required the Company to contribute 3% of each participant's annual compensation as defined in the Plan Agreement. The Plan also allowed the participants to make after-tax Roth deferrals, and the Company to make discretionary contributions which were determined by the Company's management based on each participant's compensation. The Company made no discretionary contributions for the period January 1, 2022 through November 1, 2022. The Company made discretionary contributions totaling approximately \$730,000 for the year ended December 31, 2021. The Company was required to make certain contributions to the Plan during the period January 1, 2022 through November 1, 2022 to comply with nondiscrimination rules and regulations.

**Participant accounts** – Through the Plan's termination date, all contributions were allocated at the discretion of the participant among selected investments. Each participant's interest in each of the investment accounts was accounted for in four separate accounts: one each relating to the participant's pre-tax contributions, the participant's Roth contributions, the Company's matching contributions, and the Company's discretionary contributions. Each participant's account was credited with the participant's contributions and allocations of the Company's contributions and plan earnings, and charged with allocations of investment-related fees and administration expenses. Allocations of plan earnings, investment-related fees, and administration expenses were based on the value of each participant's account balance compared to the value of all participants' account

balances. Through the Plan's termination date, the benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**Vesting** – Through the Plan's termination date, participants were immediately vested in their contributions, the Company's safe harbor contributions, and related earnings. Vesting in the Company's discretionary contributions portion of their accounts and the related earnings was based on years of service. A participant was fully vested with regard to the Company's discretionary contributions and related earnings after six years of credited service. Participant rollover contributions from previous plans were fully vested. A participant became fully vested in the event of death, disability, or attainment of early retirement age, as defined in the Plan Agreement.

**Participant loans** – Through the Plan's termination date, participants could borrow from their account a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance during the one-year period immediately preceding the date the loan was made, or 50% of their account balance. Participants could have only one loan outstanding at any given time. Loan terms could not exceed 60 months unless the loan was for the purchase of a primary residence. Loans were secured by the balance in the participant's account and bore interest at the prime interest rate available at the loan issuance date. Participant loan interest rates ranged from 3.25% to 6.5% as of December 31, 2021 and through the date the Plan's assets were distributed.

**Payment of benefits** – Through the Plan's termination date, in the event of death, disability, retirement, or termination, a participant's benefit was distributed in accordance with specific provisions of the Plan Agreement. In-service and hardship distributions were also permitted upon meeting certain requirements as defined in the Plan Agreement.

**Forfeitures** – Nonvested portions of the Company's discretionary contribution accounts were applied to reduce the Company's administration expenses or future contributions. Forfeitures totaling \$44,633 and \$76,066 were applied to reduce the Company's contributions for the period January 1, 2022 through November 1, 2022 and the year ended December 31, 2021, respectively. No forfeitures were applied to pay plan administration expenses for the the period January 1, 2022 through November 1, 2022 and the year ended December 31, 2021. There are no forfeited nonvested amounts as of November 1, 2022 and December 31, 2021.

**Administration** – Certain administrative functions were performed by the Company's officers and employees. No such officers or employees received compensation from the Plan. Certain accounting, legal, and other expenses to maintain the Plan's records were paid by the Company and were therefore not reported as expenses on the accompanying statements of changes in net assets available for benefits. Administration expenses reported on the accompanying statements of changes in net assets available for benefits represent recordkeeping and transactional fees charged by the Plan's third-party administrator.

## 2. Summary of significant accounting policies

**Basis of accounting** – The Plan’s financial statements are prepared on the liquidation basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP) due to the Plan’s governing body’s authorization to terminate the Plan.

**Estimates** – The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Contributions** – Through the Plan’s termination date, participant contributions were recorded when the Company computed payroll deductions. The Company’s contributions were recorded based on amounts actually received or committed to be paid for the period.

**Participant loans** – Loans to participants were reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. No allowance for credit losses was recorded as of December 31, 2021 as delinquent loans would have been reclassified as benefit payments. Delinquent status was based on a participant’s failure to follow the related loan’s payment terms.

**Investment valuation and income recognition** – The Plan’s investments were held under contract with Principal Life Insurance Company (PLIC) and its affiliates, Principal Global Investors Trust Company (PGITC), and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (PTC), the Plan’s investment custodians.

The Plan’s Guaranteed Interest Account (GIA) was not considered a fully benefit-responsive investment contract under GAAP because, even though a contract value was promised for a benefit event (termination, death, disability, and retirement), a possible surrender charge may have occurred when funds were withdrawn prior to maturity. Accordingly, the GIA was valued at fair value based on transactional information as more fully described in Note 4.

The Plan’s investments in mutual funds were valued at fair value based on quoted market prices on the measurement date as more fully described in Note 4.

The Plan’s investments in pooled separate accounts and common collective trusts represented units of underlying investments which were valued at fair value based on quoted market prices or by a third-party valuation agent on the measurement date as more fully described in Note 4.

Realized gains and losses on investments were recognized upon the sale of the related investments, and unrealized appreciation or depreciation was recognized at period end when the carrying values of the related investments were adjusted to their estimated fair values. Net realized and unrealized appreciation or depreciation in fair value of the Plan’s investments included gains and losses on investments bought and sold, as well as held

during the period. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Certain investment-related fees charged to the Plan were deducted from income earned on investments and are not separately reflected on the accompanying statements of changes in net assets available for benefits. Consequently, investment return is reflected net of those investment-related fees on the accompanying statements of changes in net assets available for benefits.

***Benefit and withdrawal payments*** – Benefit and withdrawal payments were recorded when paid.

***Fair value measurements*** – The Plan applied the *Fair Value Measurement* topic of the Accounting Standards Codification (ASC) which requires determination of fair value based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The *Fair Value Measurement* topic emphasizes that fair value is a market-based measurement, not an entity-specific measurement, and it applies in conjunction with other ASC topics that require or permit fair value measurements and disclosures. Impacted assets and liabilities were measured and disclosed in one of three categories based on the significance and source of the inputs to their valuation. The hierarchy consists of three broad levels: Level 1, Level 2, and Level 3. Level 1 inputs have the highest priority and consist of observable unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Level 2 inputs include: a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices that are observable for the asset or liability; and d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs have the lowest priority, are unobservable, and include judgments about the assumptions that market participants would use in pricing the asset or liability.

An asset's or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to its fair value measurement. Valuation techniques used maximized the use of observable inputs and minimized the use of unobservable inputs. The Plan's management used specific valuation techniques based on the available inputs to measure the fair values of the Plan's impacted assets and liabilities. When available, the Plan's management measured fair value using Level 1 inputs because they generally provided the most reliable evidence of fair value.

These methods may have produced fair value calculations that may not have been indicative of net realizable values, or reflective of future fair values. Furthermore, while the Plan's management believes the valuation methods utilized were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair values of certain assets and liabilities could have resulted in different fair value measurements.

**Subsequent events** – The Plan’s management has evaluated subsequent events through September 19, 2023, the date the financial statements were available for issue.

### **3. Certified investments**

The Plan’s administrator has elected the method of annual reporting as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements, including investments held as of December 31, 2021, and net realized and unrealized (depreciation) appreciation in fair value of investments, and interest and dividend income for the period January 1, 2022 through November 1, 2022 and the year ended December 31, 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by PLIC, PGITC, and PTC, the Plan’s investment custodians. This information has not been audited by the Plan’s independent auditors.

### **4. Investments, contract with insurance company, and fair value measurements**

The Plan’s investments were credited with earnings on the underlying investments, and charged for plan withdrawals, investment-related fees, and administration expenses.

The GIA balance represented the amount plan participants would receive if they were to withdraw or transfer funds within the Plan prior to their maturity. The GIA’s fair value represented contract value adjusted to reflect current market interest rates but only to the extent such market rates exceeded crediting rates (Level 3 input). The GIA could be redeemed on a daily basis, however, any transfers to a pooled separate account may have occurred only on a valuation date of the pooled separate account. There were no unfunded commitments related to the GIA.

The Plan’s shares in mutual funds were publicly traded and were valued at the last sale price on the measurement date of the security reported on the principal exchange on which traded (Level 1 input). The mutual funds could be redeemed on a daily basis. Unfunded commitments were not applicable to mutual funds.

The Plan’s pooled separate accounts were valued at fair value using readily determinable fair values. While the pooled separate accounts typically had publicly quoted Level 1 pricing inputs, the pooled separate accounts were not publicly traded, and therefore, were classified as Level 2 investments in the fair value hierarchy. Amounts allocated within a pooled separate account were credited to a participant’s account in the form of accumulation units. The fair value of an accumulation unit of each pooled separate account was determined and published at the close of each business day and was directly related to the fair value per share of the underlying investments adjusted for any contributions, dividends and/or distributions received, withdrawals made on that day, and the daily equivalent of any fee

charged pursuant to the contract. The pooled separate accounts could have been redeemed on a daily basis. Unfunded commitments were not applicable to pooled separate accounts.

The Plan's collective investment trusts were valued at fair value using readily determinable fair values, and generally invested in mutual funds, PLIC's pooled separate accounts, and other collective trust funds. The collective investment trusts were not publicly traded, and therefore, were classified as Level 2 investments in the fair value hierarchy. Amounts allocated within a collective investment trust were credited to a participant's account in the form of accumulation units. The fair value of an accumulation unit of each collective investment trust was determined and published at the close of each business day, and was directly related to the fair value of the underlying investments adjusted for any contributions, dividends and/or distributions received, withdrawals made on that day, and the daily equivalent of any fee charged to the trust. The collective investment trusts could have been redeemed on a daily basis. There were no unfunded commitments related to the collective investment trusts.

## 5. Income tax status

The Plan operated under a volume submitter profit sharing plan sponsored by Trinity Pension Consultants, Inc. (Trinity). The Internal Revenue Service (IRS) ruled in an opinion letter dated March 31, 2014 that the volume submitter plan was qualified under applicable sections of the Internal Revenue Code (IRC). The Plan was amended since the date of the IRS opinion letter. However, the Plan's trustee, sponsor, and administrator are not aware of any occurrences that would adversely affect the Plan's qualified status, and believe the Plan was designed and operated in compliance with the applicable IRC requirements, was qualified, and the related trust was tax-exempt.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of November 1, 2022 and

December 31, 2021, there are no uncertain positions taken, or expected to be taken, that would require recognition of a tax liability, or disclosure in the financial statements. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress. The Plan's administrator believes the Plan is no longer subject to income tax examinations for years prior to the year ended December 31, 2019.

## **6. Party-in-interest assets and transactions**

The Plan's investments were managed by PLIC, PGITC, and PTC, the Plan's investment custodians. Therefore, the Plan's investments qualified as party-in-interest assets. Participant loans also qualified as party-in-interest assets. In addition, transactions conducted by PLIC, PGITC, PTC, and the Company's contributions qualify as party-in-interest transactions. Also, certain fees paid to Trinity for plan administration services, and Kestra Investment Services, LLC, and Wilshire Associates, Incorporated for investment advisory and other investment-related services through revenue-sharing agreements with PLIC rather than direct payments from the Plan, qualify as party-in-interest transactions and were deducted from income earned on investments. These transactions are permitted under the plan provisions and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

## **7. Risks and uncertainties**

The Plan's Form 5500 for the period January 1, 2022 through November 1, 2022 was not filed timely. Accordingly, the Department of Labor and/or the IRS may take any action authorized by law, including assessment of penalties. The Plan's administrator cannot provide a reasonable estimate regarding the range of loss, if any, related to this matter. The accompanying financial statements do not include any adjustments that might result from this uncertainty.
