#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of the **Breaking Bread Corporation 401(k) Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which comprise the statement of net assets in liquidation available for benefits as of December 31, 2022, and the related statement of changes in net assets in liquidation available for benefits for the year then ended, and the statement of net assets available for benefits as of December 31, 2021, (ongoing), and the related statement of changes in net assets available for benefits for the year then ended (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2022 and 2021, and for the years ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements, in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter - Plan Termination**

As described in Note 7, the Breaking Bread Corporation (Plan Sponsor), elected in July 2022 to terminate the Plan effective November 1, 2022. All funds were distributed prior to December 31, 2022. As a result, the Plan changed its basis of accounting from the ongoing basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

**Note 1. Description of Plan**

The following description of the Breaking Bread Corporation 401(k) Plan (the Plan) is provided for general information purposes only. Effective February 27, 2020, the Plan name changed from Blue Ridge Foods 401(k) Plan to Breaking Bread Corporation 401(k) Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Termination

In July, 2022, the Plan Sponsor elected to terminate the plan effective November 1, 2022. In accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting to the liquidation basis beginning with the year ended December 31, 2022. See Note 2.

General

The Plan is a 401(k) defined contribution plan covering all full-time employees of Breaking Bread Corporation and members of a controlled group of businesses under common control or ownership (collectively, the Company). Each employee is eligible to participate in the Plan on the first plan entry date following the attainment of age 21 and the completion of a one-year service period in which a minimum of 1,000 hours is credited. Plan entry dates are the first day of January, April, July, and October of each calendar year. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974.

The Plan trustees oversee the governance of the Plan, including determining the appropriateness of the investment offerings and monitoring investment performance.

Administration

The Company is the Plan administrator. ERISA Services, Inc. serves as the third-party administrator for the Plan, and John Hancock Life Insurance Company (U.S.A) (John Hancock) serves as the record keeper for the Plan as well as the insurance contract holder for the Plan's group annuity contract (Note 4). All transfers of funds to the Plan are wired directly to John Hancock.

Contributions

Each year participants may contribute a percentage of their pretax annual compensation, excluding bonuses and certain fringe benefits as defined by the Plan, subject to the limitations as defined in the Internal Revenue Code (IRC).

Matching contributions are determined annually by the Company and are allocated to certain contributing participants who are employed on the last day of the plan year and who are credited with more than 1,000 hours of service, died, became disabled, or reached retirement age during the plan year. The Company elected not to make a matching contribution for the years ended December 31, 2022 and 2021.

Discretionary profit-sharing contributions may be made by the Company. Discretionary profit-sharing contributions are allocated to every Plan participant who is employed on the last day of the plan year and who is credited with more than 1,000 hours of service, died, became disabled, or reached retirement age during the plan year. The allocation is based on the same ratio as each participant's compensation bears to the total of all participants' compensations. For the years ended December 31, 2022 and 2021, the Company made no discretionary profit-sharing contributions.

Contributions (continued)

Qualified non-elective contributions may be made by the Company in order to satisfy the nondiscrimination tests described in the IRC. Qualified non-elective contributions are allocated to all non-highly compensated employees who are employed on the last day of the plan year and who are credited with more than 1,000 hours of service, died, became disabled, or reached retirement age during the plan year in the same manner as discretionary profit-sharing contributions. The Company did not make any qualified non-elective contributions for the years ended December 31, 2022 and 2021.

Rollover and transfer contributions to the Plan are permitted upon meeting certain requirements.

Participant accounts

Individual accounts are maintained for each participant to reflect the participant's contributions and related Company contributions. Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution, and allocations of (a) the Company's discretionary profit-sharing and qualified non-elective contributions, (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and qualified non-elective contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 20% vested after two years and is vested on a graduated basis until completion of six years of continuous service.

Investment options

Upon enrollment in the Plan, participants may direct their contributions, the Company's discretionary matching and profit-sharing contributions, and qualified non-elective contributions, if any, into various investment options offered by the Plan. Participants may change their investment options at any time.

Forfeitures

Forfeited discretionary profit-sharing contributions are allocated as additional non-elective contributions for the plan year in which the forfeitures occur. Forfeited matching contributions may be used to reduce the Company's matching contribution for any plan year subsequent to the plan year in which the forfeitures occur or pay administrative expenses as directed by the Plan administrator. Forfeited discretionary profit-sharing and matching contributions were insignificant to the Plan during the years ended December 31, 2022 and 2021.

Withdrawal and payment of benefits

On termination of service, if a participant's vested account balance does not exceed \$5,000 (excluding rollover contributions and earnings thereon), the Plan will automatically distribute the participant's vested account balance in a lump sum. If the participant's balance exceeds \$5,000 (excluding rollover contributions and earnings thereon), a participant may leave their balance in the Plan or elect to receive the value of the participant's vested interest in their account in the form of a single lump sum, partial payments, or roll over the vested balance into an IRA or other qualified plan.

Withdrawal and payment of benefits (continued)

Participants still employed may withdraw all or part of their account balance attributable to the participant's contributions, excluding earnings, upon furnishing proof of financial hardship, however, not more than once in any plan year.

**Note 2. Summary of Significant Accounting Policies**

Basis of accounting

The financial statements of the Plan are prepared under the liquidation basis of accounting as of and for the year ended December 31, 2022, and the ongoing basis of accounting as of and for the year ended December 31, 2021.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis; interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment returns.

Contributions

Employee contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings.

The Company's discretionary matching, profit-sharing, and qualified non-elective contributions are accrued and paid based on amounts to be funded for each year under the Plan provisions and the applicable requirements of the IRC.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Personnel within the Company perform many administrative duties of the Plan, including maintenance of personnel files and reconciliation of payroll records, at no charge to the Plan. Certain administrative expenses are paid by the Company; other administrative expenses are paid from the Plan.

**Note 3. Information Prepared and Certified by Insurance Contract Holder**

Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock (the insurance contract holder for the Plan's group annuity contract).

**Note 4. Group Annuity Contract with Insurance Company**

In 2014, the Plan entered into a group annuity contract with John Hancock. John Hancock maintains the contributions in pooled separate accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is not considered to be fully benefit responsive because no specified interest rate is guaranteed to the Plan.

**Note 5. Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2022 and 2021.

- *Pooled separate accounts*: Stated at estimated fair value as determined by the fair value of the underlying assets of the account. The account values of separate accounts are not publicly quoted and are therefore classified as Level 2 investments.

**Note 6. Income Tax Status**

The Plan adopted a pre-approved plan. The volume submitter practitioner, ERISA Services, Inc., received a volume submitter program letter from the Internal Revenue Service (IRS) dated March 31, 2014, stating that the Plan was qualified under Section 401(a) of the Internal Revenue Code (the Code) and, therefore, was exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Subsequent to the approval by the IRS, the Plan was amended. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan as amended is qualified and is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Plan Termination**

On November 1, 2022, the Plan was terminated. Benefits were accrued through November 1, 2022, and were considered to be fully vested for all participants, and no additional service was earned after November 1, 2022. The final distributions were made from the Plan on December 27, 2022.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9. Party-In-Interest Transactions**

The Plan's investments are in various funds, certain of which are managed by John Hancock. Total fees paid to John Hancock by the Plan for the years ended December 31, 2022 and 2021, were approximately \$6,000 and \$6,000, respectively. No amounts were due to John Hancock at December 31, 2022, and 2021.

ERISA Services, Inc., the third-party administrator for the Plan, assists the Company with the administration of the Plan. Total fees paid to ERISA Services, Inc. by the Company for administrative services for the years ended December 31, 2022 and 2021, were approximately \$2,700 and \$1,500, respectively. No amounts were due to ERISA Services, Inc. at December 31, 2022 and 2021.

In 2022, and 2021, the Plan paid MML Insurance Agency, LLC commissions of approximately \$1,100 and \$1,300, respectively. No amounts were due to MML Insurance Agency, LLC at December 31, 2022 and 2021.

All of these party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

**Note 10. Subsequent Events**

The Plan has evaluated subsequent events through August 29 2023, the date the financial statements were available to be issued. There were no subsequent events requiring disclosure as of this date.
