## Independent Auditors' Report

To the Participants and Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of KCS Companies 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of February 1, 2023, December 31, 2022 and 2021, and the related Statements of Changes in Net Assets Available for Benefits for the period from January 1, 2023 to February 1, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of February 1, 2023, December 31, 2022 and 2021, and for the period January 1, 2023 to February 1, 2023 and for the years ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

As discussed in Note 1 to the financial statements, effective February 1, 2023, the Plan was merged into the MarineMax, Inc. 401(k) Profit Sharing Plan. As a result, all investments were transferred from the Plan into the MarineMax, Inc. 401(k) Profit Sharing Plan on that date. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## 1. Description of the Plan

The following description of the KCS Companies 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan established by KCS International, Inc. (the Company). All employees at least 19 years of age who have completed at least 6 months of service with the Company, defined as the passage of time with no hours requirement, are eligible to participate in the Plan. Eligible employees may enter the Plan on the first day of each quarter upon completion of the service requirement.

The Company has designated certain executives as Plan fiduciaries who are responsible for oversight of the Plan. These Plan fiduciaries, working with an independent outside fiduciary investment advisor, determine the appropriateness of the Plan investment offerings and monitor investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective February 1, 2023, the Plan merged into the retirement plan of its parent company, the MarineMax, Inc. 401(k) Profit Sharing Plan. As a result, all investments were transferred from the Plan into the MarineMax, Inc. 401(k) Profit Sharing Plan. The following provisions of the Plan were based on the plan document prior to the merger.

### Contributions

Each year, participants may contribute up to 100% of their annual compensation, as defined by the Plan, up to the maximum limits of the Internal Revenue Code (IRC). Contributions can be in the form of pretax or Roth 401(k) contributions. Participants may contribute amounts representing distributions from other qualified plans (rollover contributions). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The Company may provide a matching contribution at the discretion of the Company's Board of Directors. During the year ended December 31, 2022, the match was 50% of participant contributions up to 4% of eligible compensation. During the period January 1, 2023 to February 1, 2023, no matching contribution was made and participant contributions ceased.

In addition, the Company may contribute a profit sharing contribution at the discretion of the Company's Board of Directors. During the period January 1, 2023 to February 1, 2023 and the year ended December 31, 2022, no discretionary profit sharing contributions were made to the Plan.

Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, the Company's matching contributions and an allocation of the Company's profit sharing contributions and Plan earnings thereon (net of administrative expenses). Allocations are based on the participant's eligible compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Company's matching and profit sharing contributions and earnings thereon vest in accordance with provisions of the Plan as follows:

Participants who leave the Plan because of death, attainment of normal retirement age or disability retirement, as defined by the Plan, are considered 100% vested.

### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 8.00% as of December 31, 2022, which are commensurate with local prevailing rates at inception of the loan as determined quarterly by the Plan administrator. Principal and interest is paid ratably through bi-weekly payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence.

### Payment of Benefits

Participants whose vested account balance exceeds \$5,000 upon death, disability, retirement or termination of employment, as defined by the Plan, may elect to receive the value of the vested interest in their account in the form of a lump-sum payment or installment payments. Any terminated participant whose vested account balance does not exceed \$5,000 will receive a lump-sum distribution or direct rollover of the vested amount. Participants who have reached the age of 59 1/2 may take in-service withdrawals of all or any part of their vested account. In addition, the Plan allows for hardship distributions if certain criteria are met.

### Forfeited Accounts

As of February 1, 2023, December 31, 2022 and 2021, forfeited nonvested accounts totaled \$0, \$34,915 and \$6,651, respectively. In accordance with the Plan's provisions, participant forfeitures are used to pay administrative expenses or reduce Company contributions. Forfeitures were used to pay administrative expenses of \$1,447 and \$23,116 during the period January 1, 2023 to February 1, 2023 and for the year ended December 31, 2022, respectively. There were no forfeitures used to reduce Company contributions during the period January 1, 2023 to February 1, 2023 and for the year ended December 31, 2022.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors and the custodian. Refer to Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of February 1, 2023, December 31, 2022 and 2021.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

### **Subsequent Events**

The Plan has evaluated subsequent events for recognition or disclosure through September 18, 2023, the date the financial statements were available to be issued.

## **3. Information Certified by the Custodian**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA as of February 1, 2023, December 31, 2022 and 2021 and for the period January 1, 2023 to February 1, 2023 and the year ended December 31, 2022. Accordingly, Charles Schwab Trust Bank, the custodian of the Plan, has certified to the completeness and accuracy of all cash, investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of February 1, 2023, December 31, 2022 and 2021, the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2022, and the related investment activity reported in the Statements of Changes in Net Assets Available for Benefits for the period January 1, 2023 to February 1, 2023 and the year ended December 31, 2022.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no changes in the methodologies used at February 1, 2023, December 31, 2022 and 2021.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds are valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### 5. Related-Party and Party in Interest Transactions

Fees incurred by the Plan for the investment manager services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### 6. Tax Status

The Plan adopted a pre-approved plan offered by Schwab Retirement Plan Services, Inc. The pre-approved plan received an opinion letter dated September 21, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2022 and 2021, the Plan had investments of \$6,392,047 and \$11,180,480 that were concentrated in three and four funds, respectively.

### 8. Administration of Plan Assets

The Plan's assets are administered under a contract with the custodian of the Plan. The custodian invests funds received from contributions, investment sales, interest and dividend income and makes distribution payments to participants.
