### Note 1 - Plan Description

The following description of Advanced Laser Machining, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

Effective January 1, 2023, Advanced Laser Machining, Inc. 401(k) Plan was merged (the "Merger") into Cadrex 401(k) Savings & Retirement Plan as the result of a business combination of the plan sponsor. Effective January 1, 2023, assets totaling \$5,243,099 were transferred out of Advanced Laser Machining, Inc. 401(k) Plan and into Cadrex 401(k) Savings & Retirement Plan. The financial statements and accompanying footnotes are for the one-day period ended January 1, 2023 and for the year ended December 31, 2022.

Prior to the Merger, the Plan was a defined contribution plan covering all eligible employees of Advanced Laser Machining, Inc. (the "Company") who have completed 60 days of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may contribute an amount up to a maximum of 100 percent of their eligible annual compensation, as defined by the Plan, on a before-tax and/or Roth basis, subject to maximum deferral limitations established by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company provides a safe harbor matching contribution of 100 percent of the participant's contribution, not to exceed 3 percent of the participant's deferred compensation. The Company may, at its discretion, make matching and nonelective profit-sharing contributions to be allocated to the accounts of the participants who have completed one year of service. There were no discretionary matching or nonelective profit-sharing contributions for 2022 or during the period ended January 1, 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings (or losses) and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately 100 percent vested in employee salary deferrals, safe harbor matching contributions, rollover contributions, and any income or loss thereon. Vesting in the Company's discretionary matching and nonelective profit-sharing contribution portion of their accounts is based on years of service. Participants vest in discretionary matching and nonelective profit-sharing contributions made by the Company 20 percent after two years of continuous service and an additional 20 percent for each year thereafter until they become fully vested after six years of continuous service.

#### **Forfeitures**

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

**Note 1 - Plan Description (Continued)**

***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates determined in accordance with the Plan. Principal and interest are paid ratably through monthly payroll deductions.

***Benefit Payments***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. Participants may also make withdrawals from their account balances upon reaching age 59½.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

***Party-in-interest Transactions***

For the year ended December 31, 2022, certain plan assets are in investment funds managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. Additionally, certain administrative expenses are paid by the Company.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible. There were no outstanding participant notes receivable as of January 1, 2023 and December 31, 2022.

***Benefit Payments***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Administrative Expenses***

Administrative expenses of approximately \$44,000 for the year ended December 31, 2022 were paid by the Company. There were no administrative expenses paid by the Company for the period ended January 1, 2023.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 7, 2023, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

John Hancock Life Insurance Company (U.S.A.) (the "Custodian") holds the Plan's investments and participant notes receivable, except for the real estate investments, and executes all related transactions. The investment and participant notes receivable balances as of December 31, 2022 and 2021 and related income and losses for the year ended December 31, 2022 included in the accompanying financial statements are based solely on information certified by the Custodian, except for the real estate investments. The real estate investments included in the accompanying financial statements have a total ending balance of \$208,000 as of December 31, 2021. There are no real estate investments held by the plan as of January 1, 2023 and December 31, 2022.

**Note 4 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

**Note 5 - Fair Value Measurements (Continued)**

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

***Pooled Separate Accounts***

The pooled separate accounts are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' net underlying net assets.

***Unallocated Contract***

The group annuity contract is not considered benefit responsive and is presented at fair value. The unallocated contract invests in the general assets of John Hancock Life Insurance Company (U.S.A.) (John Hancock); however, since there are no specific securities in John Hancock's general account related to this contract and due to the contract terms, including the frequency of the interest rate reset intervals, contract value approximates fair value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

***Real Estate***

The real estate investments are valued at fair value based upon an independent appraisal. The appraisal was based on observable market data of comparable real estate sales that occurred within nine months of the valuation date.

There were no investments held as of January 1, 2023 and December 31, 2022. Investments measured at December 31, 2021 were as follows:

**Note 6 - Plan Termination**

The plan sponsor had the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of plan termination, participants would remain 100 percent vested in their accounts. See Note 1 related to the Merger.
