Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of NorthStar Memorial Group, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about NorthStar Memorial Group, LLC 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 – Description of Plan

The following description of the NorthStar Memorial Group, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General – The Plan is a defined contribution plan covering substantially all employees of NorthStar Memorial Group, LLC, and its participating affiliates, and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As of December 31, 2022, the participating affiliates include Chapel of the Chimes, Skylawn Insurance Agency, Smart Cremation, LLC, and Skylawn, Sunset Memorial Park. NorthStar Memorial Group, LLC (the Company) is the Plan's sponsor and serves as plan administrator.

The Plan was adopted effective January 1, 2007 and modified January 1, 2011 to establish a savings and investment plan for the exclusive benefit of the employees of NorthStar Memorial Group, LLC and its participating affiliates.

Effective January 1, 2012, the Plan was amended to approve the merger of the Valley of the Temples, LLC, Cemetery Union 401(k) Plan, formerly Hawaii Services Mgmt, Inc. 401(k) Plan, into the Plan. These participants had the option to transfer their account balances to the Plan.

Effective January 1, 2014, the Plan adopted the 401(k) Safe Harbor Matching Employer Contributions. The 401(k) Safe Harbor Matching Employer Contributions will be made on behalf of eligible participants as defined by the Plan. The Safe Harbor Matching Employer Contributions will match 100% of the first 3% of the eligible participant's compensation contributed to the Plan plus 50% of deferral between 3% to 5% of eligible compensation made to the Plan.

Effective January 1, 2017, the Plan was amended to permit forfeitures to be used to reduce any employer contributions, Qualified Nonelective Contributions (QNECs), Qualified Matching Contributions (QMACs), and ADP test safe harbor contributions.

Effective June 9, 2022, the Plan was amended to bring the Plan into compliance with legislative and regulatory changes set forth in IRS Notice 2017-37 and other legal requirements.

Eligibility – Employees of the Company are eligible to participate in the Plan upon reaching age 21 and after completing one year of service. Participants must be employed as of the last day of the Plan year, to be eligible to receive any employer paid profit sharing contributions.

Contributions

Participant contributions – Each year, participants may contribute between 1% and 80% of pretax annual compensation, as defined in the Plan, subject to annual individual statutory deferral limitations of \$20,500 under the Internal Revenue Code (IRC) for 2022. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$6,500 for the 2022 Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer profit sharing contributions – The Company may elect to make discretionary profit-sharing contributions to the Plan. Profit sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. There were no profit-sharing contributions for the year ended December 31, 2022.

Employer safe harbor – The Company also makes safe harbor contributions equal to 3% of the participant's eligible compensation, plus 50% of deferral between 3% to 5% of eligible compensation, regardless of the employee's hours of service or employment on the last day of the Plan year. Maximum annual addition, including employer contributions, shall not exceed the lesser of \$50,000 or 100% of the participant's compensation, or cause the Plan to exceed the maximum amount allowable as a deduction to the employer under provisions of the IRC. All of the contributions made by the employer during the Plan year ended December 31, 2022 were related to safe harbor.

Employer discretionary contributions – The Company may also make additional contributions, in an amount determined solely at the discretion of the managing body of the Company. Such discretionary contributions, if any, are allocated pro rata to all eligible participants based upon the proportion of the participant's compensation to the total compensation of all eligible participants. There were no discretionary contributions during the Plan year ended December 31, 2022.

Participants' salary deferrals and Employer contributions are self-directed in the investment funds of the Plan.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant's account is credited with the participant's contributions and Company matching, safe harbor, and discretionary contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. The Investment Committee voted to charge the \$78 per account balance administrative fees to pass through to the participants at \$19.50 per quarter effective January 1, 2022. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their contributions and the Employer's safe harbor contributions, plus actual earnings thereon. Vesting in the Company's contribution to their accounts is based on years of continuous service. Employer discretionary contributions and employer profit sharing contributions become fully vested after three full years of service. Upon separation, Participants are entitled to the vested portion of their accounts.

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time. A Participant may have only one loan outstanding at a time from the Plan. The loans are secured by the Plan and secured by the balance in the participant's account and bear interest rates commensurate with prevailing rates. Principal and interest are paid ratably through payroll deductions. As of December 31, 2022, the rates of interest on outstanding loans ranged from 4.25% to 8.50%, with various maturities through July 2037.

Payment of benefits – On termination of service due to death, discharge, resignation, proven hardship, disability, or retirement, a participant (or their beneficiary) may elect to receive benefit payments in the amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or have the payment paid as a direct rollover to a participant's individual retirement account or another employer's tax qualified plan. If a participant leaves the Company and the value of his or her vested account balance is \$5,000 or less the Plan reserves the right to require the participant to take a lump sum distribution. If a participant's account balance is greater than \$5,000, a participant may defer receiving payments until age 70½.

If a participant chooses to defer payments, his or her account will continue to be invested the way he or she directs and will be adjusted for any gains or losses which occur.

A participant may withdraw all or part of his or her contributed account balance once reaching age 59½. A participant may also withdraw all or part of his or her rollover contributions in the Plan, as well as any after-tax contributions that may be held in his or her account in the Plan at any time and at any age.

Forfeitures – Forfeitures are the nonvested portion of a participant's account that are lost upon termination of employment. As of December 31, 2022 and 2021, forfeited nonvested accounts totaled \$5,002 and \$2,588, respectively. For the years ended December 31, 2022 and 2021, forfeitures used to reduce Employer contributions were \$2,500 and \$0, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. The Plan's trustee, Reliance Trust Company, certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net depreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2022 or 2021.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative Plan fees. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events – Subsequent events are events or transactions that occur after the statements of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statements of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through September 13, 2023, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NorthStar Memorial Group, LLC 401(k) Plan Notes to Financial Statements

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2022 and 2021.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Collective trusts – Units held in collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding.

Common stock – Valued at the closing price reported on the active market on which the individual securities are traded.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The plan administrator evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

Note 4 – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated October 26, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

Note 6 – Information Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of the following:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2022 and 2021.
- Net depreciation in fair value of investments, realized gain on sale of common stock, other income, dividends and interest, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2022.
- Investments reflected on the schedule of assets (held at end of year).

Note 7 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan’s operations and investment management to various service providers. Certain Plan investments are managed by NorthStar Memorial Group, LLC. Reliance Trust Company is the trustee of the Plan and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant’s account become fully vested.
