Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of Eco-Movers 401(K) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets in liquidation available for benefits as of December 29, 2022, and the related statement of changes in net assets in liquidation available for benefits for the period of January 1, 2022 to December 29, 2022, and the related notes to the financial statements. In addition, we have performed an audit of the statement of net assets available for benefits of the Plan as of December 31, 2021.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from Principal Life Insurance Company as of December 29, 2022 and December 31, 2021, and for the period from January 1, 2022, to December 29, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the financial statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion for the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the financial statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

As described in Note 1 to the financial statements, the Trustee of the Plan approved the termination of the Plan effective November 7, 2022. In accordance with accounting principles generally accepted in the United States, the Plan has changed its basis of accounting used to determine the amounts at which assets and liabilities are stated, from the ongoing basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements.

Note 1 - Description of Plan

The following description of the Eco-Movers 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan’s provisions.

General and Plan Termination

The Plan is a defined contribution plan established January 1, 2015. The Plan covers eligible employees of Eco-Movers. (“the Company”). The Plan is subject to the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Trustee of the Plan approved the termination of the Plan effective November 7, 2022. Upon the decision to terminate the Plan, unvested balances of all participants became 100% vested. Additionally, contributions to the Plan ceased and no new participants were allowed into the Plan after the effective termination date. The distribution of all account balances to participants was completed by December 29, 2022, which is the date the termination of the Plan was completed.

Eligibility

Prior to the effective date of the termination of the Plan, employees were eligible to participate in the Plan once they had completed 1,000 hours of service in a 12-month eligibility computation period (“one year of service”), provided they are at least 21 years of age.

Contributions

Prior to the effective date of the termination of the Plan, participants may contribute up to 100% of their compensation (as defined in the Plan Document), subject to the maximum dollar amounts allowed by law. Contributions from participants can be either pre-tax deferrals or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollover contributions”).

Prior to the effective date of the termination of the Plan, the Company contributed a safe harbor matching contribution of 100% on the first 3% of compensation, plus a 50% match on participant contributions between 3% and 5% of compensation. In addition, the Plan also allowed for a Company discretionary contribution; however, no such discretionary contribution was made for the period ended December 29, 2022.

Vesting

Participants are immediately vested in their contributions and Company safe harbor matching contributions. Prior to the decision to terminate the Plan, any Company discretionary contributions and related net earnings become vested to the participant based on the following schedule of years of service:

Additionally, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's safe harbor matching contribution and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants have full discretion to direct their proportionate share (vested and non-vested) of Plan assets to a variety of investment funds.

Benefit Payments

Upon termination of employment, death, disability, or retirement (age 65), the participant will receive the value of the vested interest in his or her account in the form of a lump-sum distribution or in installment payments, depending on the type of distribution. The Plan allows for in-service distributions if a participant reaches age 65, as well as hardship distributions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent.

Forfeited Accounts

The use of forfeited nonvested accounts is based on the discretion of the Plan. Forfeited nonvested accounts may be used to reduce administrative expenses or used to reduce future Company contributions. There are no forfeited nonvested account balances as of December 29, 2022, and December 31, 2021.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

As the decision to terminate the Plan was made, the liquidation basis of accounting was used for the preparation of the financial statements for the period from January 1, 2022 to December 29, 2022. The financial statements of the Plan are prepared on the accrual basis of accounting as of December 31, 2021. Based on the nature of the Plan's assets and liabilities, there was no significant difference in these account bases.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Contributions from participants are recorded in the period in which they are withheld from the participant's compensation. Safe harbor matching contributions from the Company are recorded in the period in which the related participant contributions are recorded.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation of investments represents the change in fair value of assets from one period to the next and includes realized gains and losses on investments.

Administrative Expenses

The Plan provides that certain expenses of the Plan may be paid by the Plan or the Company. Certain expenses incurred to maintain the Plan are paid directly by the Company and are excluded from these financial statements.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through September 14, 2023, the date the audited financial statements were available to be issued.

Note 3 - Fair Value Measurements

Fair value is defined as an exit price, representing the amount that would be used to sell an asset or paid to transfer a liability in an orderly transaction between market participants. As such, fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability.

There are three levels that prioritize the inputs used in measuring fair values as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level 2: Observable market inputs, other than quoted prices in active markets, that are observable either directly or indirectly.
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodology used for the Plan's assets measured at fair value.

Pooled Separate Accounts: Investments in pooled separate accounts are stated at fair value based on quoted prices, but in a market not considered active. The fair value is determined based on the value of the underlying investments (mutual funds whose fair value is generally determined based on Level 1 inputs in the fair value hierarchy), adjusted for such things as fund dividends and administrative charges. This value

is referred to as the unit value. These investments are classified within Level 2 of the fair value hierarchy. There are generally no restrictions on redemption or the ability to sell the investments and redemption notice periods are almost immediate. There are no unfunded commitments related to investments.

Collective Trust Funds: Reported at fair value using the NAV, which is determined by the administrators of the funds and is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets held by the collective trust fund (primarily fully benefit responsive investment contracts), less any liabilities, and then divided by the number of units outstanding. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Withdrawals, other than for benefit payments and participant transfers to noncompeting investment options, require 12 months advance written notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments related to these investments.

Note 5 - Tax Status

The Plan adopted a volume submitter plan developed by the volume submitted sponsor. Based in part on a favorable opinion letter received for the volume submitter plan dated December 31, 2018, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Party-In-Interest Transactions

Plan investments as of December 31, 2021, consist entirely of pooled separate accounts and common collective trusts managed and/or sponsored by Principal Life Insurance Company. The Plan has engaged Principal Life Insurance Company for recordkeeping, custodian, and consulting services. Therefore, transactions with Principal Life Insurance Company are party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.
