## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Pennsylvania State Employees Credit Union  
Bargaining Unit 401(k) Retirement Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Pennsylvania State Employees Credit Union Bargaining Unit 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 17, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period January 1, 2022 through November 17, 2022, and the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 17, 2022 and December 31, 2021, and for the period January 1, 2022 through November 17, 2022, and the year ended December 31, 2021, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

## ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## ***Emphasis of Matter – Plan Merger***

As discussed in Note 1 to the financial statements, the Board of Directors of Pennsylvania State Employees Credit Union approved the merger of the Plan into the Pennsylvania State Employees Credit Union 401(k) Retirement Plan effective November 17, 2022. Our opinion has not been modified with respect to this matter.

## ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

**1. DESCRIPTION OF THE PLAN**

The following description of the Pennsylvania State Employees Credit Union Bargaining Unit 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a participant-directed defined contribution plan covering all employees of the Pennsylvania State Employees Credit Union (the Company) who are covered by the collective bargaining agreement. Employees begin participation in the Plan the first day of the month following two months of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's Executive Group is responsible for oversight of the Plan.

Effective January 1, 2022, the Plan was amended and restated via adoption of the new non-standardized pre-approved defined contribution plan sponsored by Schwab Retirement Plan Services.

***Plan Merger***

Effective November 17, 2022, the Plan was merged into the Pennsylvania State Employees Credit Union 401(k) Retirement Plan. The assets transferred out of the Plan related to the merger totaled \$15,075,009 and are included in Transfers to Pennsylvania State Employees Credit Union 401(k) Retirement Plan on the statement of changes in net assets available for benefits for the period January 1, 2022 through November 17, 2022.

***Contributions***

Each year, a participant can contribute up to 80% of their pretax annual compensation, as defined, up to the annual limitation established by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). During 2022 and 2021, participants rolled over \$61,972 and \$8,714, respectively, from other qualified plans.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Company provides an employer matching contribution of 50% of the participant's elective deferrals, not to exceed 6% of the participant's compensation. Active participants in the Pennsylvania State Employees Credit Union Retirement Plan are excluded from receiving the matching employer contribution. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Plan automatically enrolls eligible employees into the Plan, with a deferral percentage of 4%, unless an eligible employee affirmatively elects otherwise. Automatically enrolled participants have their contributions invested in the Vanguard Target Retirement Fund that corresponds to their date of birth and expected retirement date until changed by the participant. Participant deferral percentages will be increased annually each May 1<sup>st</sup> by 1%, not to exceed 6%, while an active participant. The participants may elect to change their elections at any time after enrollment.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and Company matching contributions and allocations of Plan earnings. Allocations of Plan earnings are based on the participant's account balance, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon and are vested in the employer match after (a) three years of credited service, (b) total disability, or (c) death. Participants are credited with a year of service for each plan year in which they have at least 1,000 hours of service.

***Notes Receivable from Participants***

Notes receivable from participants must be a minimum of \$1,000 and may not exceed the lesser of \$50,000 or 50% of the participant's vested account balance. Notes receivable bear interest at the prime rate plus 2% as determined on the date of loan origination and must generally be repaid in five years. However, the repayment period for principal residence loans can be extended up to 30 years. The notes receivable are secured by the balance in the participant's account. Interest rates ranged from 5.25% to 7.50% as of November 17, 2022. Expenses attributable to the administration of the notes receivable are paid from the participants' accounts. Principal and interest are paid ratably through biweekly payroll deductions.

***Payment of Benefits***

Upon retirement, disability, separation from service, or death, participants may elect to receive a lump-sum amount equal to their vested account balance. Provisions are available to allow withdrawals of benefits prior to termination of employment as defined in the Plan agreement and in compliance with the IRC. The Plan generally requires distributions of account balances less than \$1,000 without the participant's consent.

***Forfeited Accounts***

Forfeited balances of terminated participants' nonvested accounts are used to reduce employer contributions. At December 31, 2021, there was \$23,127 in forfeitures to be used to offset future employer contributions. During 2022 and 2021, employer contributions were reduced by \$37,054 and \$23,127, respectively, from forfeited nonvested accounts.

***Plan Transfers***

The Company maintains a separate 401(k) plan for both management and bargaining unit classifications. Upon transfer of an employee from one class to another, the participant's account is also transferred. This activity is reflected in the transfer of funds, net to related plan line item on the statements of changes in net assets available for benefits.

***Retirement Investment Committee***

The role of the Retirement Investment Committee (RIC) is to monitor Plan investments so that they maintain compliance with the adopted Investment Policy Statements (IPS). In addition, the RIC also reviews and addresses any fund change suggestions made by Charles Schwab Trust Bank, the trustee, to determine whether it would be in the best interest of the Plan and participants to make the suggested changes.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's RIC determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date and reinvested into the Plan. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year, and indirect investment expenses.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as notes receivable from participants' maintenance fees and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 17, 2022 or December 31, 2021. If a participant ceases to make loan repayments, the Plan Administrator deems the participant loan to be in default, and a distributable event has occurred, the participant loan balance is reduced, and a benefit payment is recorded.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain administrative expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and payment of benefits are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

***Subsequent Events***

The Plan has evaluated subsequent events through September 11, 2023, the date the financial statements were available to be issued.

**3. INVESTMENTS**

Charles Schwab Trust Bank (CSTB) holds the funds for the Plan and maintains an individual account for each participant. Contributions made on a participant's behalf under the Plan are directly allocated to that participant's account and are invested, based on the participant's direction, in registered investment companies, interest-bearing cash, or participant-directed brokerage accounts.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered Investment Companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end investments that are registered with the U.S. Securities and Exchange Commission. These investments are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Interest-bearing Cash:* Valued at cost and classified within Level 1 of the valuation hierarchy.

*Participant-Directed Brokerage Accounts:* Accounts primarily consist of mutual funds, cash equivalents, and common stocks that are valued on the basis of readily determinable market prices.

- Investments and notes receivable from participants balances included in the statements of net assets available for benefits at November 17, 2022 and December 31, 2021, and in the notes to the financial statements.
- Investment income (loss), net and interest income on notes receivable from participants included in the statements of changes in net assets available for benefits for the period January 1, 2022 through November 17, 2022, and the year ended December 31, 2021, and in the notes to the financial statements.

**6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain administrative functions of the Plan are performed by management, employees of the Company, third party administrators, and the trustee, and therefore, these transactions qualify as party-in-interest transactions. No members of management or employees receive compensation from the Plan.

The Charles Schwab Corporation (CSC) provides services to the Plan through separate but affiliated companies, including CSTB and Schwab Retirement Plan Services, Inc. CSTB is the trustee of the Plan investments, and Schwab Retirement Plan Services, Inc. is the record keeper for the Plan. CSC (and affiliated companies) transactions are party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. If the revenue received by the trustee exceeds the amount owed, the trustee remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2022 and 2021, the trustee remitted \$344 and \$843 back to the participants, respectively. Fees paid to the trustee for administrative expenses amounted to \$5,217 and \$5,586 for the period January 1, 2022 through November 17, 2022, and the year ended December 31, 2021, respectively. As described in Note 2, the Company pays directly any other fees related to the Plan's operations.

The Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions.

**7. PLAN TERMINATION**

As discussed in Note 1, the Plan was merged into the Pennsylvania State Employees Credit Union 401(k) Retirement Plan effective November 17, 2022.

**8. TAX STATUS**

As discussed in Note 1, the Plan adopted an ERISA non-standardized pre-approved profit sharing plan sponsored by Schwab Retirement Plan Services effective January 1, 2022. The IRS issued an opinion letter for the non-standardized pre-approved profit sharing plan on September 21, 2020. As such, effective January 1, 2022, the Plan began relying on this letter as evidence that the Plan is being

operated in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
