**Note 1: Description of the Plan**

***General***

The following description of the Western Oil 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan’s provisions, which are available from the Plan Administrator. The Plan was formed effective January 1, 2018 and was terminated on December 13, 2022.

The Plan was a defined contribution plan sponsored by Western Oil, Inc. (“Company”) for the benefit of its employees who had at least one year of service, worked at least 1,000 hours in that one year of service, and are age 21 or older. The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (“Principal”) was the Trustee and Custodian of the Plan.

***Contributions***

The Plan permitted eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation. The Plan Document also included an automatic deferral feature whereby a participant was treated as electing to defer 4% of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provided for an annual increase each January 1 of 1% in the percentage deferred and was ultimately capped at 10%. Employee rollover contributions were also permitted. Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions.

The Company made a matching contribution in an amount equal to 100% of elective deferral contributions up to 1% of each participant’s covered compensation plus 50% of elective deferral contributions on the next 5% of each participant’s covered compensation. The Company could make additional discretionary contributions as determined by the Company’s Board of Directors. There were no such contributions in 2022 or 2021. Contributions were subject to certain limitations.

***Participant Investment Account Options***

Investment account options available included various funds. Each participant had the option of directing their contributions into any of the separate investment accounts and could change the allocation daily.

***Participant Accounts***

Each participant’s account was credited with the participant’s contribution, the Company’s contribution and Plan earnings and was charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefits to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

***Vesting***

Participants were immediately vested in their voluntary contributions, qualified nonelective contributions and rollover contributions plus earnings thereon.

Vesting in the Company's contribution portion of their accounts plus earnings thereon was based on years of continuous service. A participant was fully vested in the Company's matching contributions after 2 years of continuous service and fully vested in the Company's discretionary contributions after 3 years of continuous service.

The nonvested balance was forfeited upon termination of service. Forfeitures of \$2,450 and \$7,422 were used to offset Company contributions during 2022 and 2021, respectively.

***Payment of Benefits***

Upon termination of service, an employee could elect to receive a lump-sum amount equal to the value of their account.

***Notes Receivable from Participants***

The Plan Document included provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan was \$1,000. The maximum amount of a participant's loans was determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans were covered by demand notes and were repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant was paying the loan in full. Interest on the loans was based on local prevailing rates as determined by the Plan Administrator.

***Plan Termination***

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

On May 18, 2022, the Board of Directors of the Company approved termination of the Plan. Eligible employees were transitioned and allowed to participate in the Western Oil Transportation, Inc. Plan. A transfer out of \$391,802 was made to the Western Oil Transportation, Inc. Plan during 2022. The Plan was fully liquidated on December 13, 2022.

**Note 2: Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Notes Receivable from Participants***

Notes receivable from participants were reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan Document.

***Investment Valuation and Income Recognition***

Investments were reported at fair value. Quoted market prices, if available, were used to value investments. Mutual funds were valued at the net asset value (NAV) of shares held by the Plan at year-end. Pooled separate accounts were valued at estimated fair value as provided by Principal. The Plan held an interest in a common collective trust fund, which invested in investments that pursue multiple strategies to provide preservation of principal while maintaining stable interest rates. The fund could invest in securities or a combination of other collective funds. The NAV of the fund was determined daily utilizing the values of the underlying assets.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

***Plan Tax Status***

The Plan operated under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Principal Life Insurance Company. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan was designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

***Payment of Benefits***

Benefit payments to participants were recorded upon distribution.

***Administrative Expenses***

Administrative expenses could be paid by the Company or the Plan, at the Company's discretion.

**Note 3: Party-in-Interest Transactions**

Party-in-interest transactions included those with fiduciaries or employees of the Plan, any person who provided services to the Plan, an employer whose employees were covered by the Plan, a person who owned 50% or more of such an employer or relatives of such persons.

The Plan Sponsor paid certain administration and recordkeeping fees relating to the Plan.

Certain Plan investments were managed by Principal. Therefore, these transactions qualified as party-in-interest transactions. Fees paid by the Plan for the investment management services were included in net appreciation (depreciation) in fair value of investments.

**Note 4: Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value hierarchy measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets
