## **Independent Auditor's Required Communications with the Plan Administrator**

We have completed our audit of the financial statements of Cogent Bank 401(k) Plan (the "Plan") as of and for the year ended December 31, 2022. Professional standards require that we provide you with information about our responsibilities under auditing standards generally accepted in the United States of America ("GAAS"), as well as certain information related to the planned scope and timing of our audit. Information about our responsibilities is included in our Engagement Letter dated April 11, 2022. The following comments summarize the results of our 2022 audit.

### **Audit Report**

Management elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier, that is regulated, supervised and subject to periodic examination by a state or federal agency, a qualified institution, that prepared and certified the investment information in accordance with 29 CFR2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. We have determined that an ERISA Section 103(a)(3)(C) audit is permissible under the circumstances. We have also determined that the investment information is prepared and certified by a qualified institution as described by 29 CFR2520.103-8, that the certification meets the requirements in 29 CFR2520.103-8 and, that the certified investment information is appropriately measured, presented, and disclosed in accordance with accounting principles generally accepted in the United States of America ("GAAP").

The purpose of an ERISA Section 103(a)(3)(C) audit is to express an opinion on whether the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with GAAP and that the assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the certified investment information.

### **Qualitative Aspects of Accounting Practices**

The Plan's management is responsible for the financial statements and for selecting and using appropriate accounting policies. The significant accounting policies are described in the Summary of Significant Accounting Policies note. The quality of these accounting policies and the clarity of the financial statements are adequate.

We noted no transactions entered into during the year for which there is a lack of authoritative guidance or consensus.

All significant transactions recognized in the financial statements have been properly recorded and recognized in the proper period.

Accounting estimates are an integral part of the financial statements. Such estimates are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. We have concluded that the methodologies used by management to develop estimates are appropriate. Further, we believe that the amounts reflected in the financial statements are reasonable.

### **Areas Identified as Significant and/or Fraud Risks**

As anticipated, we identified in our risk assessment revenue recognition and management override of internal controls over financial reporting as fraud risks.

### **Difficulties Encountered in Performing the Audit and Changes in Audit Scope**

We encountered no difficulties in dealing with management in performing and completing our audit. Everyone cooperated fully with us; the account schedules and analyses provided were appropriately prepared and timely.

There were no significant changes from our audit plan. We focused our audit efforts on, among other matters: 1) benefit payments; 2) contributions; 3) participant data; 4) review of individually significant and/or nonrecurring transactions; 5) accrued liabilities, commitments and contingencies; 6) revenue recognition; 7) expense recognition; and the form, content and clarity of the presentation of the financial statements. Please note that we did not audit and express no opinion on the internal control over financial reporting.

### **Corrected and Uncorrected Misstatements**

Professional standards require us to accumulate all known, judgmental and projected misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. There were no adjustments proposed in connection with our audit.

### **Disagreements with Management**

In the context of auditing, professional standards define a disagreement as a difference of opinion on any matter of accounting principles or practices, financial statement disclosure, or auditing scope or procedures, which if not resolved to the auditor's satisfaction would have caused the auditor to refer to the subject matter of the disagreement in the auditors' report. (Preliminary differences of opinion that are based on incomplete facts are not disagreements if the differences are resolved by obtaining more complete factual information.) There were no disagreements about auditing, accounting or disclosure matters.

### **Management Representations**

We obtained certain written representations from the Plan's management that are included in a letter to us.

### **Management Consultations with Other Independent Accountants**

In some cases, management may decide to consult with other accountants about auditing or accounting matters, similar to obtaining a "second opinion." If such consultation involves the application of an accounting principle to the financial statements or a determination of the type of auditors' opinion that may be expressed on those statements, our professional standards require the consulting accountant to communicate with us to determine that the consulting accountant has all the relevant facts. Management has advised us there were no such consultations with other accountants.

### **Fraud or Possible Illegal Acts**

We noted no instances of fraud or possible illegal acts (all as defined under current auditing standards) which have a direct effect on the financial statements. Ms. Calhoun and Ms. Turnage have represented to us that they are not aware of any material errors or fraud or possible illegal acts.

### **Emphasis of Matter – Transfer of Plan Assets**

As discussed in Note 1 to the financial statements, the Board of Directors of the Company adopted the resolution to the Cogent Bank Master Pooled 401k Plan for Cogent Bank and transferred into a Multiple Employer Plan. Accordingly, net assets held by the Plan were transferred to the Cogent Bank Master Pooled 401k Plan on October 3, 2022. Our opinion is not modified with respect to this matter.

**Independence**

There were no relationships between any of our representatives and the Plan that in our professional judgment may reasonably be thought to bear on our independence.

Since our appointment as independent auditors we discussed a variety of accounting and auditing matters with management in the normal course of our professional relationship. No such matters were discussed as a condition of our appointment.

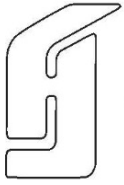

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### (1) Description of Plan

The following description of the Cogent Bank 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General and Transfer of Plan Assets.** The Plan is a defined contribution plan covering all employees of Cogent Bank (the "Company") who have completed two months of service and have attained age twenty-one. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA").

On September 1, 2022, the Board of Directors of the Company adopted the resolution to the Cogent Bank Master Pooled 401k Plan for Cogent Bank and transfer into a Multiple Employer Plan. In addition, on October 3, 2022 the Plan changed its trustee from Reliance Trust Company to Charles Schwab Trust Bank. All assets held by the Plan were transferred to the Cogent Bank Master Pooled 401k Plan on October 3, 2022.

**Contributions.** Participants may contribute up to 90% of their base compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company's matching contribution is discretionary at the option of the Company's management. Participants direct the investment of their contributions into various investment options offered by the Plan. All employer contributions are invested ratably in the investment options selected by the participants and are subject to the vesting guidelines discussed below. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

**Participant Accounts.** Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocation of Plan earnings (loss). Allocations are based on participant earnings (loss) or account balances, as defined in the Plan. Participants are charged a fee for distributions from the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Forfeitures.** Forfeitures are used to pay plan expenses and reduce future employer contributions, if any. At December 31, 2022 and 2021, there were no forfeited nonvested accounts. There were no forfeitures used during the year ended December 31, 2022.

**Vesting.** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching contributions is based on years of continuous service. A participant is 100% vested after four years of service.

### (1) Description of Plan, Continued

**Investment Options.** Upon enrollment in the Plan, a participant may direct their contributions in 1% increments in any of the Plan's investment options. Participants may change their current or future investment options periodically.

**Payment of Benefits.** On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or periodic payments. Upon termination of service for other reasons, a participant will receive a lump-sum amount equal to the value of his or her vested account.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms can be up to 5 years or 30 years for the purchase of a primary residence. These loans are collateralized by the balance in the participant's account and bear interest at prevailing rates as determined by the trustee. Principal and interest is paid by payroll deduction in substantially equal payments over the life of the loan, with payments not less frequently than quarterly.

### (2) Summary of Significant Accounting Policies

**Basis of Presentation.** The Plan's financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP"). The following is a summary of the significant accounting policies:

**Subsequent Events.** Management has evaluated all significant events occurring subsequent to the financial statements date through September 25, 2023, which is the date the financial statements were available to be issued, determining no events require additional disclosure in the financial statements.

**Estimates.** The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.** The Plan has investments that are stated at fair value and net asset value ("NAV"). Fair value is the exchange price that would be received for an asset or paid to transfer a liability (at exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### (2) Summary of Significant Accounting Policies, Continued

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

**Contributions.** Contributions from participants are accrued and credited to participants' accounts as of each pay period.

**Benefits.** Benefit payments to participants are recorded when paid.

**Expenses.** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net depreciation of fair value of investments.

### (4) Fair Value Measurements

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The fair value hierarchy requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy describes three levels of inputs that may be used to measure fair value:

Level 1: Observable inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2: Inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities that are not active; and model-driven valuations whose inputs are observable or whose significant value drivers are observable. Valuations may be obtained from, or corroborated by, third-party pricing services.

Level 3: Unobservable inputs to measure fair value of assets and liabilities for which there is little, if any market activity at the measurement date, using reasonable inputs and assumptions based upon the best information at the time, to the extent that inputs are available without undue cost and effort.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation method used for assets measured at fair value. There have been no changes in the method used at December 31, 2021.

**Mutual Funds.** Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

**Common/Collective Trusts.** Valued at the NAV of shares held by the Plan at year-end based on the underlying investments held by the fund less its liabilities. NAV is used as a practical expedient for estimating fair value of common/collective trusts.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### (5) Tax Status

The Internal Revenue Service has determined by a letter of opinion dated October 6, 2020, that the Plan prototype and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan administrator and Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management has analyzed the tax positions taken by the Company, and has concluded that at December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Company believes it is no longer subject to income tax examinations for years prior to 2019.

### (6) Related Party Transactions

The Company provides certain accounting and administrative services to the Plan for which no fees are charged.

### (7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Additionally, some investments held by mutual funds are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.
