Note 1. Description of the Plan

The following description of the Wood Gutmann & Bogart Insurance Brokers 401(k) Profit Sharing Plan (the "Plan") provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all employees of the Company who had completed three months of service and were age twenty-one or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act ("ERISA"). As further discussed in Note 7, the Company resolved to terminate the Plan effective as of November 30, 2021.

Contributions

Each year, participants could contribute up to 100 percent of their pre-tax annual compensation, subject to Internal Revenue Code dollar limits, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make additional catch-up contributions. Participants could also contribute (rollover) amounts representing pre-tax distributions from other qualified defined benefit or defined contribution plans. All contributions to the plan were invested at the direction of the participants. The Company could also contribute a discretionary amount to each qualified participant's account. The Company made a single contribution in the amount of \$5,660 for the correction of the 2021 late deposits for the year ended December 31, 2022. The Company's discretionary contributions for the year ended December 31, 2021 was \$25,649.

Investment Elections and Transfers

The Plan allows participants to make daily transfers of their account balances among the funds, subject to the Plan's investment transfer policy. The amount of the transfer may be all or any portion of the participant's account balance.

The Plan has an investment transfer policy that places waiting periods on transfers and reallocations into and out of all of the investment funds. If a participant makes a transfer or fund reallocation out of a fund other than the stable value fund, the participant cannot transfer money into that same fund for up to twenty calendar days. If funds are transferred or reallocated into and out of the stable value fund, the number of units that the money represents on the day of the transfer or reallocation transaction is locked in and cannot be transferred out of the stable value fund for up to twenty calendar days. Participants are permitted to reallocate or transfer money into and out of the stable value fund at any time.

Participant Accounts

Each participant's account was credited or charged with his or her contributions and allocations of Company contributions, investment earnings or losses and trustee administrative fees. Allocations were based on participant earnings, account balances, or account activity. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions adjusted by actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon was based on years of service.

Notes Receivable from Participants

Participants could borrow from their account balances, provided that the note receivable does not exceed the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding note receivable balance during the preceding 12 months. The notes receivable were secured by the vested balance in the participant's account and bear interest at a rate commensurate with the prevailing rate charged by commercial lenders for a note receivable of similar duration, repayment terms and security, as determined by the Plan administrator. There were no notes outstanding at December 31, 2022. Interest rates on the notes outstanding at December 31, 2021 were 4.25% to 7.25%. Borrowers repaid principal and interest over five years or less via regular payroll deductions.

Withdrawals

The Internal Revenue Service (IRS) places certain restrictions on withdrawals in order to retain the special tax-saving benefits associated with the Plan. The Plan allowed withdrawals at retirement, disability, and separation of service or upon death, as defined by the Plan. Other withdrawals were available only in cases of immediate and heavy financial hardship subject to IRS regulations.

Payment of Benefits

On termination of service due to death, permanent disability or retirement, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments, or partial payments. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also allowed in-service hardship withdrawals before retirement age for qualifying circumstances.

Forfeitures

Forfeitures were based on the nonvested portion of the Company's contribution upon employee termination. Forfeited amounts were used to reduce Employer contributions or Plan expenses. During the year ended December 31, 2021, the Company used \$6,924 to reduce Employer contributions and \$5,758 to pay Plan expenses. There were no forfeitures used to reduce Employer contributions or pay plan expenses during the year ended December 31, 2022. The balance of unallocated forfeitures available to offset future Employer contributions or Plan expenses amounted to \$0 at December 31, 2022 and 2021.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

As described in Note 7, the Company elected to terminate the Plan effective November 30, 2021. The financial statements of the Plan are prepared under the liquidation method of accounting in accordance with the accounting principles generally accepted in the United States of America and present the net assets available for benefits as of December 31, 2022 and 2021 and the changes in those net assets for the years ended December 31, 2022 and 2021.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles required the plan administrator to make estimates and assumptions that affect reported amounts. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in registered investment companies were stated at fair value or an approximated fair value, which approximates liquidation value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. (See Note 4)

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held at the end of the year.

The Plan presents, in the Statement of Changes in Net Assets Available for Plan Benefits in Liquidation, the net appreciation in the fair value of its investments, which consists of the realized and unrealized gains on those investments.

Notes Receivable from Participants

Notes receivable from participants were reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent loan receivables from participants were classified as distributions based upon the terms of the plan agreement.

Distributions to the participants of the Plan were recorded when paid.

Administrative Expenses

Investment transaction expenses were offset against the related investment income. Other administrative and non-investment expenses of the Plan were either paid by the Plan Sponsor, which is a party-in-interest, or through the Plan expense account. Expenses paid by the Plan Sponsor, which were not reflected in the accompanying financial statements, constitute exempt party-in-interest transactions under ERISA. Expenses paid through the Plan expense account are included in Administrative expenses in the Statement of Changes in Net Assets Available for Plan Benefits in Liquidation. For the years ended December 31, 2022 and 2021, the administrative expenses paid by the Plan were \$23,234 and \$56,220, respectively.

Plan Management's Review of Subsequent Events

The Plan has evaluated subsequent events through September 14, 2023, the date the financial statements were available to be issued.

Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC"), *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of fair value hierarchy under FASB ASC, *Fair Value Measurements* are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 - Inputs to the valuation methodology are observable other than level 1 prices, such as quoted prices for similar assets and liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 - Inputs to the valuation measurement are unobservable, supported by little or no market data, and are significant to the fair value of the assets and liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Registered investment companies: Valued at the number of shares of the underlying fund multiplied by the closing net asset value (NAV) per share quoted by that fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investments at Contract Value

The Plan entered into a traditional fully benefit-responsive stable value option with Transamerica Life Insurance Company ("Transamerica") totaling \$0 for 2022 and \$505,638 for 2021. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The stable value option issuer is contractually obligated to repay the principal and a specified interest rate credited to the Plan. The crediting rate is based on a formula established by the contract issuer and has no minimum guaranteed rate. The crediting rate is reviewed every six months for resetting. As of and during the year ended December 31, 2022, the crediting interest rate was 1.10%.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory development.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. As of December 31, 2022, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value by providing an advance written notice of at least 30 days. Such events include (1) the Plan is changed so as significantly affect the issuer's obligations under the Contract, (2) the Contract can no longer be treated as a Pension Plan Contract and is determined that it is not practical to continue the provision of benefits under the Contract, (3) the Plan is terminated, (4) the Plan fails to comply with the requirements of the Contract, (5) the Plan, except by unintentional omission, fails to give the information needed under the Contract. (6) the Plan, except by unintentional omission, fails to furnish copies of any plan amendments or annual report records or (7) the sum of the Contract Account values at any time equals \$20,000 or less.

Note 6. Related Party Transactions and Party in Interest Transactions

The Plan, through its participation in the Master Trusts, may invest in shares of mutual funds, collective trust funds or a stable value fund provided through Transamerica and Reliance. Transamerica and Reliance are the trustees for the Plan and, therefore, these transactions qualify as party in interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

Note 7. Plan Termination

The Company resolved to terminate the Plan effective as of November 30, 2021 and, in the case of such termination, all participants who were active employees became fully vested in their accrued benefits to the extent funded. The Plan began the liquidation process in December 2021 and was closed in January 2023.

Note 8. Tax Status

The Company adopted a Prototype Non-Standardized Profit Sharing Plan which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Department of Labor.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits (in liquidation) at December 31, 2022 and 2021.

During 2020, the global outbreak of the Coronavirus (COVID-19), which was declared a pandemic by the World Health Organization in March, has led to significant volatility in financial markets. The ultimate impact of COVID-19 on the Plan, which may be material, is uncertain and will depend on future developments.

Note 10. Concentration Risk

The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such instruments. The Plan's concentration of credit risk and market risk was dictated by the Plan's provisions as well as those of ERISA and the participants' investment preferences.

Note 11. Prohibited Transactions

During 2021 and 2020, the plan sponsor became aware that they inadvertently failed to deposit \$121,258 and \$103,243, respectively, representing contributions and loan payments, within the required time frame as stated by ERISA. These deferrals and loan repayments were deposited beyond the earliest expected date on which the assets could be segregated from the employer's assets. The Department of Labor (DOL) considers late deposits to be prohibited transactions. The plan sponsor is required to file Form 5330 and the pay the excise tax relating to the prohibited transactions from the plan sponsor's assets and not from the assets of the Plan, in addition to calculating the lost earnings on these deferrals. Both the 2021 and 2020 contributions have been corrected by the Plan. There were no late deposits for 2022.

Note 12. Subsequent Events

On January 5, 2023, the Plan was closed.
