## Independent Auditors' Report

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of South Florida ENT Associates, P.A. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 3, 2022 (in liquidation) and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through October 3, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from an agent on behalf of a qualified institution as of October 3, 2022 and December 31, 2021 and for the period from January 1, 2022 through October 3, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. As discussed in Note 1 to the financial statements, the Board of Directors of the Company approved a plan of liquidation on February 10, 2022 and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

*Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

*Auditors' Responsibilities for the Audit of the Financial Statements*

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. ### **(1) Plan Description**

The following description of the South Florida ENT Associates, P.A. 401(k) Plan (The Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **(a) General**

The Plan is a Safe Harbor 401(k) Profit Sharing Plan covering all full-time employees of South Florida ENT Associates, P.A. (the Company) who are age 21 or older and that have completed one year of service or period of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the Internal Revenue Code (IRC). The Company has medical offices in Miami-Dade, Broward, and Palm Beach Counties.

Effective February 27, 2019, the Plan was frozen and ENT Physician Holdco, LLC became the Plan sponsor. Employee contributions, employer safe-harbor contributions and profit-sharing contributions, and new participant loans ceased, and participants became 100% vested in the employer discretionary profit-sharing contributions and earnings thereon.

Effective April 20, 2020, the Plan was operationally amended to implement certain changes provided for under the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), including allowing certain eligible individuals to (a) receive coronavirus-related distributions, (b) temporarily suspend required minimum distributions, and (c) delay certain participant note repayments for up to one year.

On February 10, 2022, the Board of Directors voted to terminate the Plan as of October 3, 2022, and to distribute the Plan assets as soon as administratively possible. The Plan's assets were distributed to participants by October 3, 2022. As discussed above, participants have been fully vested in their accounts since 2019.

#### **(b) Participant Accounts**

Each participant's account is credited with participant's contribution and allocations of the Company's contribution and Plan earnings and losses. Additionally, all participants are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit provided by the participant's vested account balance.

#### **(c) Investment Options**

Upon enrollment in the Plan, each participant may direct the investments of all their contributions as well as account balances into investment funds offered by the Plan. Participants may change their investment options on a daily basis.

If participants do not direct the investment of their applicable Plan accounts, the accounts will be invested in accordance with the default investment alternatives established under the Plan. These default investments will be made in accordance with specific rules under which the fiduciaries of the Plan, including the company, the trustee of the Plan, and the Plan administrator, will be relieved of any legal liability for any losses resulting from the default investments. The Plan administrator provides

participants with a separate notice, which details these default investments and their rights to switch out of the default investment if they so desire.

#### **(d) Notes Receivable from Participants**

As discussed in Note 1, new participant loans ceased on February 27, 2019. Prior to that date, participants could borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Applications for a loan were made in writing and approved by the Plan administrator. The loans are secured by the balance in the participant's vested account. The loan interest rate was determined by Branch Banking & Trust Company Prime Rate published on the date of the loan application plus 1%. Principal and interest is paid ratably through bi-weekly payroll deductions.

#### **(e) Payment of Benefits**

Prior to the Plan's termination, each participant could elect a distribution in the form a single sum cash payment, at normal (65 years old) retirement age as defined by the Plan. On termination of service due to death, disability, or retirement, the full value of the participant's account was payable to their beneficiary in the form of a single payment.

Upon termination of the Plan, participants were permitted to rollover their balance to an individual IRA or elect to receive a cash distribution. Current employees with a balance in the Plan were also permitted to rollover their balance to the Elevate ENT's 401(k) Plan.

#### **(f) Forfeited Accounts**

Forfeitures of the nonvested account balances may be used by the employer to reduce future Safe Harbor contributions and reduce Plan expenses. At October 3, 2022 and December 31, 2021, the forfeiture account amounted to zero.

### **(2) Summary of Accounting Policies**

#### **(a) Basis of Accounting**

The financial statements of the Plan for 2021 have been prepared using the accrual method of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP). As a result of the February 10, 2022 decision to terminate the Plan, the Plan's financial statements as of October 3, 2022 and for the period from January 1, 2022 through October 3, 2022, have been prepared on the liquidation basis, in accordance with U.S. GAAP. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process. The adoption of liquidation basis accounting did not have a material effect on the carrying values of the Plan's assets and liabilities since the fair value of the Plan's investments approximated the liquidation value and any costs incurred during the liquidation process will be paid by the Employer.

#### **(b) Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures of assets and liabilities, the disclosure of contingencies at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Accordingly, actual results may differ from those estimates.

#### **(c) Contributions**

Employee rollover contributions are recorded in the period during which they are received by the Plan. Participants direct how rollovers are to be allocated between investment funds offered by the Plan. As discussed in Note 1, all other forms of employee contributions ceased in 2019.

#### **(d) Administrative Expenses**

Certain administrative expenses of the Plan are paid directly by the Company and other expenses are allocated ratably to each participant's account balance. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

#### **(e) Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **(f) Payments of Benefits**

Benefits are recorded when paid.

#### **(g) Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 3, 2022 or December 31, 2021.

### **(3) Information Certified by the Plan's Trustees**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee of the Plan, Ascensus, as agent for Ascensus Trust Company, (Ascensus), has certified the completeness and accuracy of investments and notes receivable from participants reflected in the accompanying financial statements, including investments and notes receivable from participants held at

October 3, 2022 and December 31, 2021. Ascensus has also certified the completeness and accuracy of net depreciation in fair value of investments, dividends, and interest income on notes receivable from participants, for the period from January 1, 2022 through October 3, 2022. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

#### **(4) Related Parties and Parties in Interest**

Ascensus is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Ascensus for administrative expenses amounted to approximately \$18,000 for the period from January 1, 2022 through October 3, 2022.

In addition, see note 9 for a discussion of agreements with investment advisors. Those transactions also qualify as party-in-interest transactions.

#### **(5) Tax Status**

On June 24, 2014, the Plan adopted a Defined Contribution Prototype Plan sponsored by Branch Banking & Trust Company, which had received a favorable opinion letter from the Internal Revenue Service (IRS), dated March 31, 2014, which stated that the Prototype Plan and related trust are designed in accordance with applicable Sections of the Internal Revenue Code (IRC). Since this adoption of the Prototype Plan, the Plan has had several amendments. Effective May 1, 2021 the Plan transferred to an Ascensus pre-approved profit sharing plan with CODA, which also received an opinion letter in which the IRS stated that the form of the Plan was in compliance with the applicable requirements of the IRC. The Company has not applied for the Plan's individual determination letter; however, the Plan administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the requirements of Section 401 (a) of the IRC and, as such, is exempt from federal income tax. Therefore, no provision for income taxes has been made.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. There are no uncertain tax positions for the period from January 1, 2022 through October 3, 2022.

#### **(6) Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **(7) Fair Value of Financial Instruments**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to

unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following methods and assumptions were used to estimate the fair value of each class of financial instruments for which it is practicable to estimate that value:

*Mutual funds:* Valued at the daily closing price as reported by the fund; mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund:* Valued at the NAV of units of the collective trust; the NAV, as provided by the trustee, is a readily determinable fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### (8) Retirement Plan Service Agreement

On July 1, 2012, the Plan entered into a Retirement Plan Service Agreement (the Agreement) with Branch Banking & Trust Company to provide individual recordkeeping services for each participant. Under the Agreement, participants have the option to invest in a specified list of mutual funds and a collective trust fund. The Agreement can be terminated by either party, subject to certain provisions.

#### (9) Investment Advisory Agreements

On July 15, 2012, the Plan entered into an Investment Advisory Agreement (the Investment Agreement) with ProNvest, Inc. to provide retirement planning advice and investment education to participants. Under the Investment Agreement, ProNvest, Inc. will be paid an annual fee in the amount of six tenths of one percent (0.60%) of the market value of the securities in each participant's account, not to exceed \$5,000 per year. This fee is charged quarterly in arrears (0.15% each quarter) based on the fair market value of the securities in the participant's account on the last business day of the quarter. The Investment Agreement can be terminated by either party, subject to certain provisions. Fees paid by the Plan for investment advisory expenses amounted to \$0 for the period from January 1, 2022 through October 3, 2022.

On November 5, 2015, the Plan entered into an Investment Advisory Agreement' (the BB&T IIA Investment Agreement) with BB&T Institutional Investment Advisers, Inc. to provide discretionary investment advisory services to the Plan sponsor regarding assets of the Plan, including the authority to manage, acquire, and dispose of the assets held in the Plan, including any earnings, profits, increments, and accruals thereon, within the parameters of the Plan's investment policy statement. Under the BB&T IIA Investment Agreement, BB&T Institutional Investment Advisers, Inc. will be paid quarterly fees of five basis points (0.05%) of the market values of Plan assets. This fee is charged quarterly in arrears and payable no later than 30 days subsequent to the invoice date. Additional ancillary investment fees are based on standard hourly rates. The Investment Agreement can be terminated by either party, subject to certain provisions. Fees paid by the Plan for investment advisory and ancillary services amounted to approximately \$4,000 for the period from January 1, 2022 through October 3, 2022.

#### (10) Subsequent Events

Subsequent events have been evaluated through September 25, 2023, the date the financial statements were available to be issued.
