Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lauramar Corp 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion



Notes to Financial Statements

1. Description of Plan:

The following description of Lauramar Corp 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering substantially all employees of Lauramar Corp (the Company) and its affiliate, AP Flood and Water LLC. Employees who attain the age of 18 years and have been employed three months are eligible to make elective salary deferrals and receive employer matching contributions. At the age of 21 years employees are eligible for profit sharing contributions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participants may elect to contribute up to 92% of pretax annual compensation, as defined in the Plan, provided total additions to the account of participating employees for any plan year shall not exceed the amount permitted by Internal Revenue Service regulations. Additionally, participants age 50 or older may elect to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company provides safe-harbor matching contributions of 100% of the first 3% of a participant's contribution to the Plan then reducing to 50% for deferral's greater than 3% but less than or equal to 5%. The Company may make a discretionary profit-sharing contribution to the Plan. The contribution will be allocated to participant accounts in the same proportion that their compensation bears to the total compensation of all participants. The Company elected not to make discretionary profit-sharing contributions in 2022.

Participant Accounts:

Each participant's account is credited with the participant's contribution, earnings, and allocations of the Company's contribution. Allocations are based on employee compensation. The benefit to which an employee is entitled is the benefit that can be provided from the employee's vested account.

Vesting:

Participants are immediately vested in their salary deferral contributions and the Company's safe-harbor matching contributions, plus actual earnings thereon. Vesting in the Company's profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service, as defined. Employer profit sharing contributions vest over a six-year period.

Investment Options:

A participant may direct contributions into a variety of investment options offered by Mid Atlantic Trust Company, a trustee of the Plan.

Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan terms range from one to four and a half years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably generally through monthly payroll deductions.

Payment of Benefits:

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over other allowed periods. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan allows for in-service withdrawals for active employees that have reached normal retirement age, as defined by the Plan.

Forfeited Accounts:

At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$1 and \$6. These amounts are used to reduce future employer contributions. During 2022, \$5 of forfeitures were used to reduce employer contributions.

2. Summary of Significant Accounting Policies:

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Inputs to the valuation methodology for money market and mutual funds are unadjusted quoted prices for identical assets in active markets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation on investments is charged or credited to the net assets of the Plan.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan agreement.

Benefit Payments:

Benefits are recorded when paid.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events:

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through September 18, 2023 (the date the financial statements were available to be issued).

3. Financial Information Certified by the Trustee (Unaudited):

In accordance with the Department of Labor's Regulation 2520.103-8, certified "Statements of Account" for the Plan have been provided by Mid Atlantic Trust Company as of and for the years ended December 31, 2022 and 2021. The plan administrator has obtained certifications from the trustee that such information is complete and accurate as follows:

- Statements of Net Assets Available for Benefits - Investments.
- Statement of Changes in Net Assets Available for Benefits - Investment income.
- Schedule of Assets (Held at End of Year) - all items and amounts, excluding notes receivable from participants.

4. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100 percent vested in their employer profit sharing contributions.

5. Administrative Expenses:

At the discretion of the plan administrator, certain administrative expenses have been borne by the Company.

6. Tax Status:

The Internal Revenue Service has issued a favorable determination letter regarding the tax-exempt status of the Plan. Accordingly, no provision has been made for income taxes.

7. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
