Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Devon Title Agency Employees Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation as of October 31, 2022 and December 31, 2021, and the related statement of changes in net assets in liquidation for the period ended October 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2022 and December 31, 2021, and for the period ended October 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

As discussed in Note 1 to the financial statements, the governing body of the Devon Title Agency Employees Savings Plan approved a plan of liquidation on December 14, 2021, and management determined liquidation is imminent. As a result, the Devon Title Agency Employees Savings Plan's financial statements are being reported on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Devon Title Agency Employees Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan was a defined contribution profit sharing plan and trust with a qualified cash or deferred 401(k) arrangement covering all eligible employees of Eliseco, Inc. d/b/a Devon Title (the “Company”) who had one year of service and were age 21 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 15, 2021, the Plan Sponsor approved a resolution to terminate the plan effective October 31, 2022. As of October 31, 2022, plan assets were transferred into the Stewart 401(k) Savings Plan.

Reliance Trust Company was the Plan’s trustee. ADP Retirement Services provided recordkeeping services to the Plan. The plan administrator had overall responsibility for the operation and administration of the Plan. Plan management determined the appropriateness of the Plan’s investment offerings and monitored investment performance.

Restatement

Effective April 1, 2022 the Plan was restated to comply with regulatory requirements.

Contributions

Participants were able to contribute 80% of annual eligible compensation, as defined in the Plan, and designate those contributions as pre-tax. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 2% of eligible compensation and their contributions invested in a designated target date fund until changed by the participant. Participants were also able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Discretionary profit-sharing contributions were determined annually by the Company. Profit sharing contributions were allocated to each participant based upon the ratio of the participant’s compensation to the total compensation of the Company. There were no discretionary profit-sharing contributions for the period ended October 31, 2022.

Contributions (Continued)

Contributions were subject to certain IRS limits. Participants directed the investment of their contributions, including their employer contribution, into various investment options offered by the Plan.

Participant Accounts

Each participant's account was credited with the participant's contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that would be provided from the participant's vested account.

Vesting

Effective December 14, 2021 all participants were 100% vested.

Notes Receivable from Participants

Participants were able to borrow from their fund accounts a minimum of \$500 up to a maximum equal to \$50,000 or 50% of the participant's vested account balance, whichever was less. The loans were secured by the balance in the participant's account. The loan interest rate, determined quarterly, was set at 2% above the prime rate, as defined. Principal and interest was paid ratably through payroll deductions.

Payment of Vested Benefits

On termination of service due to death, disability or retirement, participants were able to elect to receive an amount equal to the value of the vested interest in their accounts in either a lump-sum amount or in installments, depending on the size of the participant's account balance at the time of termination. Participants with a vested account balance of less than \$5,000 had to take a lump-sum distribution. The account of a participant with a vested account balance between \$1,000 and \$5,000 who did not request a distribution would be rolled into an individual retirement account in the participant's name.

In-service distributions were allowed when a participant reached age 59½. Rollover contributions were able to be withdrawn at any time. The Company could authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals were subject to specific statutory and regulatory requirements.

Forfeitures

Forfeited nonvested accounts were able to be used to pay plan expenses or reduce employer contributions. For the period ended October 31, 2022, forfeitures in the amount of \$640 were used to pay plan expenses. There were no unallocated forfeitures at October 31, 2022. Unallocated forfeitures were \$114 at December 31, 2021.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan were prepared using the liquidation basis of accounting due to imminent termination of the Plan effective December 14, 2021, as described in Note 1.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Net depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. As of October 31, 2022 and December 31, 2021, no allowance for credit losses has been recorded. If a participant did not make loan repayments and the plan administrator considered the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan document.

Payments of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments to participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net depreciation of fair value of investments. Personnel and facilities of the Company were used by the Plan for its accounting and other activities at no charge to the Plan.

Subsequent Events

The plan sponsor has performed a review of events subsequent to the statements of net assets in liquidation date through September 20, 2023, the date the financial statements were available to be issued and has determined that there are no material events that have occurred during this period.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at October 31, 2022 and December 31, 2021, and net depreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the period ended October 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that were observable for the asset or liability;
- Inputs that were derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs

Following is a description of the valuation methodologies used for assets measured at fair value.

Money market fund: Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission (SEC). This fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund is deemed to be actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds must publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 1 day notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 – PARTY IN INTEREST TRANSACTIONS

The Plan allowed for transactions with certain parties who may have performed services or had fiduciary responsibilities to the Plan, including the Company. During the period ended October 31, 2022, there were direct fees of \$6,439 paid to ADP, Inc., a party-in-interest. During the period ended October 31, 2022 and the year ended December 31, 2021, there were transactions involving the investment of plan assets in investment funds maintained by Reliance Trust Company, a party-in-interest as defined in Section 3(14) of ERISA. Indirect fees paid by the Plan for investment management services were included in the net depreciation of the fair value of investments.

NOTE 6 – TAX STATUS

The Plan was a volume submitter document plan for which the Internal Revenue Service had issued an advisory letter dated October 6, 2020, stating that while they do not issue a determination as to whether a specific employer's plan is qualified, any employer who adopts this plan document will be considered to have had a plan qualified under code section 401(a) provided all the terms were not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan was operated in accordance with the terms provided in the volume submitter document.

The Plan was subject to examination by the Internal Revenue Service for the statutory period.
