NOTE A – DESCRIPTION OF PLAN

The following description of the Hospice Source, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) profit sharing plan sponsored by Hospice Source, LLC (the “Company”). The Plan, as amended, was established January 1, 2013, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Hospice Source, LLC maintains the Plan for the benefit of its eligible employees who elect to participate. The Company is the sponsor and administrator of the Plan. Reliance Trust Company is the trustee and custodian of the Plan. ADP Retirement Services is the third-party administrator.

The financial statements were approved for issuance on September 27, 2023, which is the date the financial statements are available to be issued.

Plan amendments

The Plan was amended and restated effective March 1, 2022 to bring the Plan into compliance with legislative and regulatory changes set forth in IRS Notice 2017-37.

Eligibility

Generally, the Plan covers all eligible employees of the Company who elect to participate. Employees are eligible to contribute once they are at least 21 years of age or older and have three months of service at the Plan entry date. The Plan entry dates are the first day of each month. Participating employees are eligible for matching contributions immediately upon entering the Plan.

401(k) provisions

Contributions are by salary reduction and are at the employee’s discretion within the limits imposed by the provisions of the Plan and the applicable Internal Revenue Code sections. The participant accounts are “participant directed accounts.”

NOTE A – DESCRIPTION OF PLAN

Salary deferral

The Plan is a defined contribution plan wherein participants elect to reduce their compensation and have such reductions contributed to the Plan on their behalf. The Plan also allows for rollovers from other plans.

The term “compensation” for calculation of deferral shall be W-2 wages excluding severance pay plus any amounts deferred under the Plan. Employees can elect to contribute to the Plan not less than 1% up to 90% of eligible earnings before taxes as defined by the Plan not to exceed the maximum contribution. The maximum contributions allowed by the Internal Revenue Service was \$20,500 and \$19,500 for 2022 and 2021, respectively. No after-tax contributions may be made to the Plan.

Participating employees are eligible to make catch-up contributions under the Plan provided the participating employees have attained or will attain the age of 50 before the close of the year. The amount of catch-up contributions allowed by the Internal Revenue Service was \$6,500 for 2022 and 2021, respectively. The catch-up contributions are excluded in calculating the matching contribution.

Employer contributions

The Company makes a safe harbor matching contribution of 100% of each participant’s contribution up to 4% of the participant’s eligible compensation.

Participant accounts

Each participant’s account is credited with the participant’s 401(k) contribution, if any, and (a) investment experience on those amounts and (b) the employer’s safe harbor matching contribution. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Vesting

A participant is always 100% vested on participant 401(k) contributions, employer safe harbor matching contributions, and rollover contributions.

Notes receivable from participants

The Plan allows participants to borrow a minimum of \$500 up to a maximum of 50%, or \$50,000, of their vested account balance from the Plan at any time. A participant may have up to three loans outstanding at a time. The maximum term of any loan is five years, or thirty years if the loan is to acquire a primary residence. The rate of interest is equal to the prime rate plus 2%. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions. Participant loans are valued at cost.

Termination

Although it has not expressed intent to do so, the sponsor has the right to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. Upon termination, the sponsor may elect to distribute to each participant, or the participant's beneficiary, the proportionate share of the Plan's assets as determined by the individual account balances on the date of termination, or continue the existence of the trust for the purpose of paying benefits as they become due under the terms of the Plan. In the event of Plan termination, participants would become 100% vested in their accounts.

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of his or her account.

Payment of benefits

Distributions of participants' account balances occur only upon retirement, death, hardship, in-service distribution or other termination of employment. A participant or participant's beneficiary may receive distributions under one of three options. The options allow for payment in lump-sum distributions of cash, transfer to an individual retirement account or other brokerage account or a fixed period and fixed installment option. Participants who have reached age 59 ½ may elect to withdraw all or a portion of their employee deferral contributions while they are still employed by the Company. Participants who have reached age 70 ½ may elect to receive installment payments sufficient to satisfy required minimum distributions as required by IRS regulations.

Investing options

Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options listed in Note C. Participants may change their investment options at any

time. The Plan also provides discretionary asset allocation services and investment recommendations to participants with respect to investment options made available by the plan sponsor.

Plan administrative costs

Certain expenses incurred maintaining the Plan are paid directly by the sponsor and are excluded from the financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Funding policy

It is the policy of the Plan sponsor to remit the employee and employer contributions as soon as administratively possible, but no later than five business days after the date of payroll.

CARES Act

The Plan adopted the applicable provisions of the Coronavirus Aid, Relief, and Economic Security Act (the “CARES Act”), which was signed into law March 27, 2020. The CARES Act took immediate effect and allows for qualifying participants who experience adverse effects due to COVID-19 to take Coronavirus Related Distributions with a repayment or rollover right during the three-year period beginning the day after the distribution date. The CARES Act also permits the Plan to postpone required minimum distributions for one year.

Hardship withdrawals

Participants may receive hardship withdrawals for reasons of financial hardship. The Plan adopted the provisions to allow participants to take COVID-19 eligible withdrawals under the CARES Act up to \$100,000 without penalty and the Plan granted several participant requests in 2020. The Plan was amended to incorporate these provisions when required.

Participant loans

Effective April 2020, the Plan suspended participant loan repayments for participants who requested a suspension subject to the CARES Act. Repayments could be halted through December 2020 if requested by a participant.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's administrator, who is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in conformity with U.S. generally accepted accounting principles (U.S. GAAP).

Use of estimates

The preparation of the financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities and changes in those assets and liabilities, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments in mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Common/collective trust investments are valued at their contract value. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note D for discussion of fair value measurements.

Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Distributions to participants or their beneficiaries are recorded when paid.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Notes receivable from participants

Participant notes receivable are valued at their unpaid principal balances, plus accrued but unpaid interest. Interest income on notes receivable from participants is recognized on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

These loan transactions are treated as transfers between the investment fund and the participant notes fund. The interest rate on loan transactions is commensurate with current rates. As of December 31, 2022 and 2021, the interest rates on outstanding loan balances ranged from 5.25% to 9.00%.

Expenses

Certain expenses incurred maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE D – FAIR VALUE MEASUREMENTS

Current authoritative literature, *Fair Value Measurements* (the Standard), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Standard are described as follows:

- Level 1 Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Adjusted quoted prices from active or inactive markets for identical or similar assets or liabilities; or valuation inputs that are directly or indirectly observable.
- Level 3 Unobservable inputs that are significant to the fair value of assets or liabilities.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE D – FAIR VALUE MEASUREMENTS

Stable value fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate the fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Common/collective trusts: The State Street common/collective trusts are general account products that are composed primarily of fully-responsive investment contracts that are valued at the net asset value of units of the common/collective trusts. The net asset value is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. These net asset based investments have been excluded from the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE H – RELATED-PARTY TRANSACTIONS AND PARTY IN INTERST TRANSACTIONS

These transactions are exempt party-in-interest transactions.

The Plan allows for participant loans. These loans are exempt party-in-interest transactions.

The Company provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged. These transactions are exempt party-in-interest transactions.

NOTE I – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE J – FIDELITY BOND

ERISA requires a fidelity bond at the beginning of each plan year in the amount of 10% of the assets of the Plan but must not be less than \$1,000 and need not be greater than \$500,000. The Plan has a fidelity bond up to \$184,000. The term of the fidelity bond is from January 1, 2022, through December 31, 2022.

NOTE K – INCOME TAX STATUS

The Plan obtained its most recent determination letter on March 31, 2008, in which the Internal Revenue Service stated that the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be

taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

NOTE L – SUBSEQUENT EVENTS

In 2023, the plan sponsor entered an agreement to sell the Company. The final transaction is expected to close September 30, 2023, with dissolution to follow by December 31, 2023.

The Plan Sponsor has evaluated subsequent events through September 27, 2023, the date which the financial statements were available to be issued.
