In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

**1. THE PLAN**

The following description of the Saratoga Bridges, NYSARC, Inc. Saratoga County Chapter 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution 403(b) plan established for employees of Saratoga Bridges, NYSARC, Inc., Saratoga County Chapter (the Company). The Plan is administered by management of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In July 2020, The Arc New York Board of Governors approved a resolution to create a single retirement plan for all NYSARC Chapters called "The ARC New York Affiliated Employers 401(k) Plan" (NYSARC Plan). As a result, all assets of the Plan were transferred to the NYSARC Plan on May 25, 2022. The total transferred net assets amounted to \$12,884,904.

**Eligibility**

All employees are eligible to begin salary deferrals upon their date of employment. Employees are also eligible to receive employer discretionary contributions upon attaining the age of 21 and the completion of two years of service, with a minimum of 1,000 hours each year.

**Contributions**

Participants may contribute a percentage of their annual compensation subject to certain Internal Revenue Services (IRS) limitations. At its discretion, the Company may contribute employer profit sharing contributions to the Plan for each employee that meets the eligibility requirements. During the Plan period and year ended 2022 and 2021, the Company's discretionary contribution was based on a percentage of the employee's prior year annual compensation, as defined. The percentage of the employee's annual compensation used in the calculation of the Company's discretionary contribution is set forth in the chart below:

<u>Employee Years of Service</u>	<u>Percentage</u>
2 - 5 years	3%
6 - 9 years	4%
10+ years	5%

**Vesting**

Participants are immediately fully vested in their voluntary contributions, Company contributions and actual investment earnings and losses thereon.

## 1. THE PLAN (Continued)

### **Participant Accounts**

Each participant's account is credited with the participant's contributions along with an allocation of (a) the Company's contribution, (b) Plan earnings and losses and (c) Administrative Expenses. Allocations are based on participant earnings and losses or account balances, as defined. The entitled benefit is the participant's account balance subject to vesting.

### **Investment Options**

The Plan currently offers several mutual funds through a regulated investment company. Participants may change their investment options daily.

### **Payment of Benefits**

Upon termination, a participant is entitled to receive an amount equal to the value of the participant's vested interest in their account. If the account is less than \$5,000, the benefit must be distributed in a single lump sum payment. If the account is \$5,000 or greater, participants may elect a single lump sum payment, partial withdrawal, or monthly installment payments. Benefits to terminated participants are recorded when paid.

### **Hardship Withdrawals**

Prior to age 59 ½, a participant may withdraw only his or her participant contributions for reasons of hardship. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

### **Administrative Expenses**

The Plan permits the payment of Plan expenses to be made from Plan assets. Substantially all administrative expenses associated with the Plan are paid by Plan participants as a reduction of investment income.

### **Notes Receivable from Participants**

Participants may borrow from their account up to a maximum amount that is equal to the lesser of \$50,000 or 50 percent of their account balance. No loans less than \$1,000 will be made. Generally, loan terms range from 1-5 years. The loans are secured by the balance in the participant's account and bear interest at the prime rate of interest, published by the Wall Street Journal at the time of the loan, plus 1%. Principal and interest is paid ratably through payroll deductions, which cannot be less frequently than quarterly. Should a participant default on the payments, the outstanding balance of the loan is deemed uncollectible and written off as a distribution of Plan assets. During 2022 and 2021, notes receivable from participants deemed uncollectible and included within benefits paid to participants on the statement of changes in assets available for benefits approximated to nil and \$28,700, respectively.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Investment Valuation and Income Recognition**

Investments are stated at fair value based upon quoted market prices for mutual funds. Changes in the current value of investments, including realized/unrealized gains and losses on assets sold/held during the year, are reflected in the statement of changes in assets available for benefits as net appreciation or depreciation in the fair value of investments. Dividends are recorded on the ex-dividend date and purchases and sales of securities are recorded on a trade-date basis (the date the order to buy or sell is executed). Interest income is recognized on the accrual basis.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Risks and Uncertainties**

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and those changes could materially affect the amounts of assets available for Plan benefits.

### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

### **Fair Value Measurements**

The Plan has financial instruments which are recorded at fair value in the accompanying statements of assets available for benefits. The Plan makes estimates regarding the valuation of assets and liabilities measured at fair value in the financial statements. These assets and liabilities include the investments in mutual funds.

#### Fair Value Measurement - Definition and Hierarchy

U.S. GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan uses various valuation techniques in determining fair value. U.S. GAAP establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's assumptions about the assumptions market participants would use in pricing the asset or liability, developed based on the best information available in the circumstances. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment. The Plan's investments in mutual funds are valued utilizing Level 1 inputs.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly. The Plan has no investments valued using Level 2 inputs.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement. The Plan has no investments valued using Level 3 inputs.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

The availability of observable inputs can vary and is affected by a wide variety of factors. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised by the Plan in determining fair value is greatest for instruments categorized in Level 3. In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes the level in the fair value hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level input that is significant to the fair value measurement in its entirety. A description of where the Plan's investments fall within the fair value hierarchy is provided in Note 4.

## 3. CERTIFIED INVESTMENTS

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Hand Benefits and Trust Company, the custodian, has certified that the following data included in the accompanying financial statements is complete and accurate as of and the period ended May 25, 2022, and as of and for the year ended December 31, 2021:

The following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds* - Valued based on quoted prices in active markets.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Company believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**6. TAX STATUS**

The Plan is exempt from federal income tax under Section 403(b) of the Internal Revenue Code. The Plan is required to operate in conformity with the Internal Revenue Code to maintain its tax exempt status for Plan participants. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

**7. PARTY-IN-INTEREST TRANSACTIONS**

The Plan allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants that have loans and the Plan qualify as party-in-interest transactions.

**8. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through August 25, 2023, which is the date the financial statements were available to be issued.
