## Notes to Financial Statements

### 1. Description of Plan

The following description of the PD Systems, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan is a multiple employer plan consisting of the following active participating employers, (collectively, “Company”): 1) PD Systems, LLC, 2) PD Power Systems, LLC and 3) TBF Group, Inc. These entities are related by common control to the sponsor company, PD Systems, LLC.

The Plan was amended effective May 1, 2021 in reaction to a corporate reorganization. PD Systems, LLC, was formed as a result of the reorganization of the former entity, PD Systems, Inc. The reorganization was a change in the legal organization, not a change in the reporting entity. PD Systems, LLC retained the FEIN of the former PD Systems, Inc. PD Systems, Inc. was the former plan sponsor.

During 2021, PD Power Systems, LLC (PD Power) created their own qualified retirement plan. The assets held by PD Power participants were transferred to the new plan. Subsequent to year end, the Plan was amended to remove PD Power as a participating employer.

#### **General**

The Plan is a defined contribution plan. The Plan covers all employees, who have completed one month of service and are eighteen years of age or older. The Board of Directors of the Company manages the operation and administration of the Plan. Reliance Trust Company serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Each year, participants may contribute up to 90% of annual compensation, as defined in the Plan agreement, subject to Internal Revenue Code (IRC) limitations. Participant salary deferrals may be traditional 401(k) (pre-tax) or Roth 401(k) (after-tax). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Company matches 100% of the first 3% of the Participant’s compensation and then also matches 50% of the compensation between 4% and 5%. The Company provides prevailing wage contributions for participants as required by certain government contracts. Contributions are subject to certain limitations.

#### **Investment options**

Participants direct the investment of their accounts into various investment options offered by the Plan. Currently, the Plan offers mutual funds and a common collective trust fund as investment options for participants.

#### **Participant accounts**

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions, and plan earnings and losses, and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and allocations of administrative expenses. Allocations are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are vested immediately in their contributions and Company prevailing wage contributions. Beginning on January 1, 2015, new participants are fully vested in the Company's matching contributions after three years of credited service.

***Notes receivable from participants***

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. At December 31, 2022, outstanding loans bore interest between 4.25% and 8.5%. Principal and interest are paid ratably through payroll deductions.

***Payment of benefits***

On termination of service, retirement, death, or disability, a participant or their beneficiary in the event of death, may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, substantially equal installments or partial withdrawals as provided by the Plan. Hardship withdrawals are available upon demonstration of financial hardship with limitations as defined in the Plan. In-service distributions are permitted from fully vested accounts after attaining age 59½.

***Forfeitures***

At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$21,706 and \$12,124, respectively. These accounts will be used to reduce future Company contributions or pay plan expenses. During 2022, forfeitures of \$22,134 were used to reduce Company contributions.

**2. Summary of Significant Accounting Policies**

***Basis of accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment valuation and income recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income from notes receivable from participants is recorded when received. Other interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciate includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes receivable from participants***

Notes receivable from participants are measured at their unpaid principal balance. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

***Payment of benefits***

Benefits are recorded when paid.

***Administrative expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

***Subsequent events***

The Plan has evaluated subsequent events and transactions for potential recognition or disclosure through September 12, 2023, the date the financial statements were available to be issued.

**3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1:** Observable inputs such as quoted prices in active markets.
- Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2022 or 2021. The following is a description of the valuation methodologies used for assets measured at fair value:

***Mutual funds***

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

***Common collective trust fund***

The Plan invests in a common collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value (NAV) per share provided by the trustee as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported

NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust funds, the respective issuers reserve the right to require 12-months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The collective trust funds are not required to be classified within a level on the fair value hierarchy.

#### **5. Exempt Party-In-Interest Transactions**

Reliance Trust Company (Reliance) is the trustee, and ADP, LLC (ADP) is the recordkeeper, as defined by the Plan; therefore, transactions with Reliance and ADP qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to ADP for recordkeeping services and participant-initiated transactions totaled \$10,685. The Plan paid \$23,063 to service providers who are not considered parties-in-interest for professional service including investment advisory, plan recordkeeping and third-party administration services.

#### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

#### **7. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (IRS) stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the non-standardized prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated October 6, 2020 that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
