Note 1. Description of the Plan

The following description of the Kerasotes Showplace Theatres 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General and eligibility

The Plan is a defined contribution plan, that is sponsored by Kerasotes Showplace Theatres LLC (the “Employer”) and covers all employees who are at least 21 years of age. Eligible employees may participate in the Plan on the first day of the month following their meeting the age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 60% of pre-tax annual compensation, as defined in the Plan. The Plan also allows participants to make after-tax Roth 401(k) deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. In addition, after completing one year of service and having attained age 21, employees become eligible for Employer safe harbor matching contributions. Safe harbor matching contributions are equal to 100% of a participant’s salary deferral that does not exceed 3% of their compensation, plus 50% of the participant’s salary deferral between 3% and 5% of the participant’s compensation. Contributions are also subject to certain limitations imposed by the Internal Revenue Code. Participants direct the investment of their contributions and the Employer safe harbor matching contribution into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective trust fund as investment options for participants.

Participant’s accounts

Each participant’s account is credited with (a) the participant’s contributions, (b) the Employer safe harbor matching contribution, and (c) earnings or losses on their individual investments. Participants may change their investment elections daily for both existing account balances and future contributions.

Vesting

Participants are immediately vested in their contributions, as well as the Employer safe harbor contributions, plus actual earnings thereon.

Note 1. Description of the Plan (continued)

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 6.50%. Principal and interest are to be paid ratably through payroll deductions, but may also be prepaid through a separate payment. See also Note 10 for changes brought about by the CARES Act and the SECURE Act.

Payment of benefits

Upon termination of service due to death, disability or retirement, a participant is eligible to receive for benefit payments based upon their vested interest in the Plan. Distributions may be made by lump-sum payment or through partial payments. A participant may also receive a hardship distribution upon a written request, provided they meet certain stated requirements and approval by the plan administrator. In-service distributions are permitted and may be made to a participant who has not separated from service provided they have attained age 59-1/2.

Note 2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis, and related fees are charged directly to the borrowing participant's account when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2022 or 2021.

Note 2. Summary of significant accounting policies (continued)

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. The Plan's investments (including gains and losses on investments bought, sold and held during the year) appreciated (depreciated) in value by \$(2,215,837) and \$754,747 during the years ended December 31, 2022 and 2021, respectively.

Payment of benefits

Benefits are recorded when paid.

Date of management's review

Subsequent events were evaluated through September 6, 2023, which is the date the financial statements were available to be issued.

Note 3. Fair value measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 or 2021.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan and as reported by the fund. The mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Investment measured at net asset value

The investment measured at net asset value (NAV) represents units in a stable value collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawals to ensure that securities liquidations would be carried out in an orderly business manner. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan. The Fund's objective is to preserve principal while generating earnings at competitive rates with short-term, high quality fixed income investments, while maintaining sufficient liquidity to provide participant directed withdrawals at their proportionate share of contract value (as denied in the Declaration of Trust).

It is the policy of the Plan to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2022 and 2021, there were no transfers in or out of Levels 1, 2 or 3.

Note 4. Plan termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 5. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 6. Administrative expenses and related party transactions

Certain administrative expenses of maintaining the Plan are paid by the Employer on behalf of the Plan. These expenses, however, are not material to the financial statements. In addition, investment-related expenses are included in net appreciation in fair value of investments, while fees for the administration of notes receivable and benefit payments are charged directly to the participant's account.

An employee of the Employer has been appointed as Plan Administrator for the Plan. This employee is also a participant in the Plan. The employee does not receive any compensation from the Plan for services performed as Plan Administrator.

Note 6. Administrative expenses and related party transactions (continued)

The Plan holds certain investments where Reliance Trust Company (the Plan trustee) also serves as the trustee and investment manager for the investment. These transactions, therefore, qualify as party-in-interest transactions.

In addition, Automatic Data Processing (ADP), the record keeper for the Plan, provides certain administrative services to the Plan pursuant to a trust agreement between the Employer and ADP. ADP receives revenue from mutual fund service providers for services that ADP provides to the funds. This revenue is then used to offset certain amounts owed to ADP for its administrative services to the Plan. The amount of such revenue received and offset against administrative expenses was \$20,034 and \$22,147 for the years ended December 31, 2022 and 2021, respectively.

Note 7. Income tax status

The Plan has adopted a non-standardized pre-approved plan sponsored by Automatic Data Processing (ADP). The prototype plan has received an opinion letter, dated October 6, 2020, from the Internal Revenue Service that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

The Plan previously implemented certain requirements of the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2021 (the SECURE Act). The provisions of these Acts changed the Plan to, among other things, allow certain eligible individuals to receive coronavirus-related relief for participant loan repayment, increase the allowable amount of participant loans, and delay the commencement date for required minimum distributions. The provisions within these Acts were implemented during 2022 and 2021, and formal amendments to the Plan, as needed, are expected to be adopted in 2023 accordance with applicable law and IRS guidance.
