To the Board of Directors of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Home Health Specialists, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for plan benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Home Health Specialists, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

1. DESCRIPTION OF THE PLAN

General

The following description of the Home Health Specialists, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

Eligibility

Each employee of Home Health Specialists, Inc. (the “Company”) becomes eligible to participate in the Plan after attaining age 21 and completing 1 year of service. To receive an allocation of the employer’s matching contribution the employee must also have completed one year of service. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan and subject to Internal Revenue Code restrictions and limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Certain participants are also eligible to make “catch-up” contributions in accordance with Internal Revenue Code regulations. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 50% of eligible elective deferrals up to 8% of compensation. The matching Company contribution is invested pursuant to the participant direction. Additional profit-sharing amounts may be contributed at the option of the Company’s Board of Directors. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the contributions and allocation of Plan earnings in accordance with their investment direction. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Benefits

On termination of service due to death, disability, retirement or termination, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or installments in accordance with the Plan document. In addition, benefits may be withdrawn from the Plan without terminating employment upon attaining age 59^{1/2}.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 4 years of credited service.

Forfeitures

Forfeited nonvested accounts shall be applied to reduce the employer’s contribution or pay plan expenses. Forfeitures used by the employer to pay plan expenses for the year ended December 31, 2022 and 2021 were \$0 and \$3,302, respectively. The forfeiture account balance as of December 31, 2022 and 2021 was \$1,737 and \$0, respectively.

1. DESCRIPTION OF THE PLAN (Continued)

Participant Loans

Participants may borrow from their fund account a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest is paid ratably through weekly payroll deductions. Participants may only have one loan outstanding at any time.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Method

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Administrative and Investment expenses

Administrative fees charged and deducted from the Plan assets totaled \$1,356 and \$4,000 for the years ended December 31, 2022 and 2021. Other administrative expenses incurred on behalf of the Plan including those expenses associated with accounting, legal, and other administrative services of the Plan are assumed by the Plan Sponsor.

Subsequent Events

Management has evaluated events and transactions occurring subsequent to December 31, 2022 for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through September 28, 2023, the date these financial statements were available for issue.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate, amend, modify or suspend the Plan in whole or in part at any time subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

4. INVESTMENT CERTIFICATION

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the financial information included in the Plan financial statements, except for contributions receivable, contributions, and distributions for withdrawals and terminations, has been derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, in accordance with Section 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available. An asset's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The three levels of the fair value hierarchy under ASC 820 are as follows:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets.
- Level 2: Quoted prices in markets that are not active, or inputs that are observable either directly or indirectly, for substantially the full term of the asset.
- Level 3: Prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable (i.e. supported with little or no market activity).

The following is a description of the valuation methodologies used for instruments measured at fair value:

The mutual funds and money market funds with are stated at fair value as reported to the Plan by Charles Schwab Bank, based on the quoted market prices of the mutual funds ("Level 1").

The fair values of the separate investment accounts is the net fair value of the underlying assets as determined generally by using commercial quotation services ("Level 2").

5. FAIR VALUE MEASUREMENTS (Continued)

Stable value collective trust fund. A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

For a description of the valuation methodologies used for assets measured at contract value see Note 7. There have been no changes in the methodologies used during the period.

6. INVESTMENT CONTRACT WITH INSURANCE COMPANY – SEPARATE INVESTMENT ACCOUNTS

The Plan has investment contracts with Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company maintains the contributions in pooled accounts. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses. The assets of the Separate Investment Accounts (SIA) are separate from Voya Retirement Insurance and Annuity Company's General Investment Account. Voya Retirement Insurance and Annuity Company invests these accounts according to the stated objectives of the various SIAs. The principal is not guaranteed. Contract holders are allocated units of the SIA, not specific securities. The value of the SIA units is the net fair value of the underlying assets as determined generally by using commercial quotation services.

The contracts are included in the financial statements at fair value. Fair value includes reinvested dividend and interest income, received and accrued, realized gains and losses, and unrealized gains and losses of the underlying SIA assets. SIA's do not pay dividends or interest to a plan. The underlying investments' performance (interest, dividends, and realized and unrealized gains) is reflected in the unit value.

7. INVESTMENT CONTRACT WITH INSURANCE COMPANY – GUARANTEED INTEREST ACCOUNTS

The Plan entered into a benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company maintains the contribution in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The contract is included in the financial statements at contract value as reported to the Plan by Voya Retirement Insurance and Annuity Company. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value at December 31, 2022 and 2021 was \$420,632 and \$373,847, respectively. The crediting interest rate is based on a formula agreed upon with the issuer and is guaranteed not to fall below the minimum percentage set at the beginning of the year. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events may limit the Plan's ability to transact at contract value with Voya Retirement Insurance and Annuity Company. Such events include, but may not be limited to the following: (a) temporary absence, (b) change in position or other occurrence qualifying as a temporary break in service under the Plan, (c) transfer or other change in position resulting in employment by an entity controlling, controlled by, or under other common control with the employer, (d) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business, (e) removal from the Plan of one or more groups of classifications of participants, (f) partial or complete Plan termination, or (g) Plan disqualification. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

8. PARTY-IN-INTEREST TRANSACTIONS

Home Health Specialists, Inc. 401(k) Plan, the participants, and the Trustees have all been identified as related party transactions. The Plan invests in shares of mutual funds managed by the Trustee. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Participant loans also qualify as party-in-interest transactions, which are exempt from prohibited transaction rules of ERISA. Fees paid by the Plan for the investment and administrative services amounted to \$3,063 and \$4,000 for the year ended December 31, 2022 and 2021, respectively.

Fees paid during the year for legal, accounting and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services and paid directly by the plan sponsor. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. TAX STATUS

The Internal Revenue Service has determined and informed the Company that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's trustee believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

11. PLAN AMENDMENTS AND MODIFICATIONS

There were no material amendments or modifications to the Plan during the year.

9. MERGER

The Plan sponsor was purchased by another company during 2022. Accordingly, the trustees of the Plan resolved to merge the Plan with the acquirers 401(k) plan. All remaining assets of the Plan were transferred on March 7, 2023 effectively terminating of the Plan.
