### NOTE 1 - DESCRIPTION OF PLAN

The following description of the HTI Cybernetics, Inc. 401(k) Plan (the "Plan") provides only general information. The complete terms of the Plan are provided in the Fidelity Basic Plan Document No. 17 ("Plan Agreement"). Information concerning the Plan, including benefits and vesting provisions, is also included in the Summary Plan Description and other materials distributed to participants.

Fidelity Management Trust Company is the Plan's third-party administrator and record keeper (the "Plan Administrator"). Fidelity Management Trust Company is also trustee of the Plan assets (the "Trustee").

*General* - The Plan was adopted on April 20, 2015, and is a defined contribution plan of HTI Cybernetics, Inc. (the "Plan Sponsor"). The Plan is subject to applicable provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

*Eligibility* - Employees who have attained age 19 and completed one month of service are eligible to participate in the Plan. Employees become participants in the Plan on the first day of the month following satisfaction of the eligibility requirements.

*Participant Contributions* - Participants may contribute up to 60% of their compensation, as defined in the Plan Agreement, through systematic payroll deductions up to the maximum amount allowable by the Internal Revenue Service ("IRS"), \$20,500 as of December 31, 2022, and an additional \$6,500 for those age 50 and above. Participants may also roll over distributions from other qualified retirement plans, or special individual retirement arrangements, to the Plan. Effective January 1, 2022, the plan permits participants to contribute any portion of their contributions after-tax to a Roth 401(k) account. The combined contribution to a Roth 401(k) account from their gross income and traditional pre-tax account is subject to the maximum allowable amounts mentioned above.

*Employer Contributions* - The Plan Sponsor has adopted a safe-harbor matching contribution program requiring the Plan Sponsor to match 100% of voluntary participant contributions up to 3% of compensation, and to match 50% of the next 2% of compensation to a maximum 4% matching contribution. The Plan Sponsor may make discretionary matching contributions equal to a uniform percentage of each participant's elective deferral contributions. The exact percentage, if any, is determined by the Plan Sponsor on an annual basis. Each year, the Plan Sponsor may also make discretionary profit-sharing contributions to the Plan. During the plan year ended December 31, 2022, the Plan Sponsor made no discretionary matching or profit-sharing contributions to the Plan. Total contributions to the Plan are subject to certain statutory limitations.

*Participant Accounts* - Each participant's account is credited with the participant's contributions and allocations of Plan Sponsor contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Roth 401(k) accounts are maintained separately as qualified withdrawals from these accounts are tax-free.

### NOTE 1 - DESCRIPTION OF PLAN *(Continued)*

*Vesting* - Participants are immediately vested in their elective deferral contributions, plus actual earnings thereon and contributions made by the employer under the safe-harbor provision of the Plan.

Vesting in the employer's discretionary matching contribution or profit-sharing contribution portion of their accounts, plus earnings thereon, is based on years of service as defined by the Plan as follows:

2	20%
3	40%
4	60%

6	100%

*Investment Options* - Participants may direct the investment of their contributions and the Plan Sponsor contributions into any of 44 different mutual funds offered by Fidelity. The Plan Sponsor may change specific investment options from time to time upon consulting with the Plan's independent investment advisors. Participants may change their individual investment options at any time.

*Notes Receivable from Participants* - Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid within 5 years, however, if the loan was used to acquire a principal residence or if the participant is on a leave of absence from the employer, the term may be extended. The loans are secured by the balance in the individual participant's account and bear interest at a current market-rate determined by the Trustee, which ranged from 4.25% to 7.25% for the year ended December 31, 2022.

*Payment of Benefits* - Upon termination of service due to death, disability, or retirement, a participant may elect to receive any amount up to the value of his or her individual account balance, payable in a lump sum or in installments. Upon reaching the age of 59½, a participant may elect to receive any amount up to the value of his or her individual participant contributions, prior to separation from employment, payable in a lump sum.

*Forfeitures* - Forfeited contributions are used to pay reasonable administrative expenses of the Plan, with the balance being used to reduce current matching or discretionary contributions from the Plan Sponsor. There were no forfeitures for the year ended December 31, 2022.

### NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

*Basis of Accounting* - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

*Notes Receivable from Participants* - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2022. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

*Payment of Benefits* - Benefits are recorded when paid.

*Expenses* - The cost of maintaining the Plan is absorbed by the Plan Sponsor and those expenses are excluded from these financial statements. Certain administrative expenses are charged directly to the Plan by the Trustee and are reported separately from investment income.

*Fair Value Measurements* - The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement* ("ASC 820") establishes a fair value hierarchy, which prioritizes the inputs to valuation techniques used to measure fair value in three broad levels. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). In some cases, the inputs used to measure fair value might fall in different levels of the fair value hierarchy.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Assessing the significance of a particular input may require judgment considering factors specific to the asset or liability and may affect the valuation of the asset or liability and its placement within the fair value hierarchy.

*Recently Issued Accounting Standards* - The Plan Sponsor has evaluated all Accounting Standards Updates ("ASUs") issued by the Financial Accounting Standards Board ("FASB") during the plan years ended December 31, 2022 and 2021 and determined that there were no ASUs issued that are applicable to the Plan.

*Subsequent events* - The Plan has evaluated subsequent events through September 27, 2023, the date the financial statements were available to be issued. The Plan Sponsor determined that no adjustments were necessary at December 31, 2022 (see Note 10).

### NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan Agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### NOTE 5 - TAX STATUS

The Plan adopted a Prototype Standardized Profit Sharing Plan with a cash or deferral arrangement, which received a favorable opinion from the Internal Revenue Service on March 31, 2014, which stated that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan Sponsor believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified, and the related trust is tax exempt.

### NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various marketable securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### NOTE 7 - FAIR VALUE MEASUREMENTS

ASC 820 requires that assets and liabilities be classified based on the lowest level of input that is significant to the fair value measurement in its entirety. The three levels of the fair value hierarchy under ASC 820 are described as follows: (Level 1) inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access; (Level 2) inputs to the valuation methodology including (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means; (Level 3) inputs to the valuation methodology are unobservable and significant to the fair value measurement. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Common Collective Trusts ("CCTs") are accounts maintained by a bank, trust company or similar institution that is regulated, supervised, and subject to periodic examination by a state or federal agency, for the collective investment and reinvestment of assets contributed from employee benefit plans. The purchase or redemption price of the units of participation are determined periodically by the trustee based on the current market value of the underlying assets of the trust.

CCTs do not pay interest or dividends, the interest and dividends received from the investments held by the trust are reinvested and included in the net appreciation or depreciation of the trust. Units of a common collective trust are measured at fair value using net asset value ("NAV") per share as a practical expedient and are excluded from the fair value hierarchy.

Registered Investment Companies ("Mutual Funds") are investment entities that are registered with the Securities and Exchange Commission which comply with certain stated legal requirements for the collective investment and reinvestment of assets contributed from investors. Each Mutual Fund has a stated investment objective. Ownership shares issued by a Mutual Fund are valued daily at net asset value ("NAV"). The NAV is calculated based on the fair value in the market of the underlying investment securities held by the Mutual Fund. Mutual Funds are Level 1 investments.

### NOTE 8 - STABLE VALUE FUND

Investments in the Managed Income Portfolio Class I Fund (the "Fund") are pooled funds that are invested in a portfolio of investment contracts such as guaranteed investment contracts ("GICs") or synthetic GICs issued by Fidelity. A synthetic GIC is an investment contract, also known as a wrapper contract, issued by an insurance company, bank, or financial institution, and backed by a portfolio of investments that are owned by the Fund. Contract value represents the cost of contributions made to the fund plus accrued interest credited at specified guaranteed rates for specified periods determined by the fund manager, less withdrawals and allocated administrative expenses. The Fund is not reported at contract value because although the contract is fully benefit-responsive, meaning participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, it does not meet the definition of a fully-benefit responsive contract as it is an indirect investment through a CCT. Accordingly, the contracts are included in the statements of net assets available for benefits at fair value, as determined by the fund manager.

Participant level transactions, such as withdrawals, occur daily. Early withdrawals may be subject to a market value adjustment. There were no unfunded commitments at December 31, 2022 and 2021. The crediting interest rates were 1.55% and 0.85% at December 31, 2022 and 2021, respectively. The average crediting rate observed by the Plan for 2022 was 2.55%. The Fund seeks to maintain a stable unit price of \$1.00 by adjusting the crediting rate as necessary. Accordingly, the Fund recognizes no appreciation or depreciation in fair value on an ongoing basis.

### **NOTE 9 - RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST**

The Plan investments are shares of mutual funds and common collective trusts managed by Fidelity Management Trust Company, the Plan Trustee. All transactions related to investments qualify as party-in-interest transactions. Participants' notes receivable also qualify as party-in-interest transactions.

### **NOTE 10 - SUBSEQUENT EVENTS**

Effective June 1, 2023, the Plan Sponsor appointed Principal Financial Group ("Principal") as the Plan's custodian, third-party administrator, and record keeper. Fidelity transferred \$6,745,808 to Principal. At this time, the minimum age requirement to participate was changed to 18 from 19, and maximum compensation that can be deferred to 100% from 60% subject to IRS maximum contribution requirements. In addition, all new employees are automatically enrolled to defer 5% of compensation subject to eligibility requirements. They can opt out, increase, or decrease the contribution percentage on Principal's website at any time.
