Independent Auditors' Report

To the Plan Administrator of

*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of the First Care Mgmt Company, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 22, 2022 (in liquidation) and December 31, 2021 (ongoing), the related statements of changes in net assets available for benefits for the period ended December 22, 2022 (in liquidation) and the year ended December 31, 2021 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

The plan administrator has obtained certifications from a qualified institution as of December 22, 2022 and December 31, 2021, and for the period ended December 22, 2022 and the year ended December 31, 2021, stating that the certified investment information provided, as described in Note 3 to the financial statements, is complete and accurate.

*Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. As discussed in Note 1(a) to the financial statements, the Plan Sponsor approved a plan of liquidation on July 15, 2022 and management determined liquidation to be imminent. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

### (1) Description of plan

The following description of the First Care Mgmt Company, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan was a defined contribution plan established to provide retirement benefits for employees of First Care, LLC and related entities (the "Plan Sponsor"). The Plan covered substantially all employees who had completed 1,000 service hours ("participants"). The Plan was subject to the provisions of the Employee Retirement Income Act of 1974.

The Plan was terminated on July 15, 2022. Participants became fully vested in their accounts upon plan termination. On December 22, 2022, the remaining assets of the Plan totaling approximately \$2,083,000 were distributed to participants. Distributions were made in the form of rollovers or lump-sum payments and are included in benefits paid on the accompanying statement of changes in net assets available for benefits for the period ended December 22, 2022.

#### (b) Contributions

Prior to Plan termination, participants could voluntarily make qualified retirement contributions to the Plan which were deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants could also make after-tax Roth 401(k) contributions and could contribute amounts representing distributions from other qualified defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. Participant contributions were permitted up to 100% of compensation not to exceed the maximum amount deductible for federal income tax purposes.

The Plan provided that the Plan Sponsor could make discretionary matching contributions and profit sharing contributions to all eligible employees. A participant must have been employed on the last day of the plan year to receive the profit sharing contribution. Allocations of the Plan Sponsor's discretionary matching contribution were equal to a uniform percentage of the participants' elective deferrals. The Plan Sponsor matching contributions totaled \$83,219 and \$150,010 in 2022 and 2021, respectively. The Plan Sponsor did not make any profit sharing contributions in 2022 and 2021. Plan Sponsor contributions could not exceed the maximum amount deductible for federal income tax purposes.

(c) Participant accounts

Prior to Plan termination, each participant's account was credited (charged) with the participant's contributions, allocations of Plan Sponsor contributions, investment earnings (losses) and administrative expenses. Allocations were based on a participant's compensation or account balances as defined in the Plan agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

(d) Vesting

Prior to Plan termination, participants were immediately vested in their elective salary deferrals plus actual earnings (losses) thereon. Participants were 20% vested in the Plan Sponsor's discretionary matching contributions and profit sharing contributions after two years of service, with the vesting increasing an additional 20% each year thereafter, until the participant was 100% vested after six years of credited service. Participants became fully vested in Plan Sponsor matching and profit sharing contribution upon Plan termination.

(e) Payment of benefits

Prior to Plan termination, upon termination of service, death, disability, or retirement, a participant could elect to receive a lump sum payment equal to the value of the participant's vested interest in his or her account. The Plan allowed for in-service distributions if a participant reached age 59½. If a participant terminated employment and the participant's account balance did not exceed \$5,000, the plan administrator could authorize the benefit payment without the participant's consent. The Plan did not allow involuntary cash-outs for terminated participants whose account balances were over \$5,000.

(f) Forfeited accounts

Prior Plan termination, forfeitures were created when participants terminated employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures were used to reduce the Plan Sponsor's contributions to the Plan or to pay Plan expenses. There were \$18,963 of forfeited nonvested accounts as of December 31, 2021. Forfeitures of \$42,557 and \$49,289 were used to reduce the Plan Sponsor's contribution in 2022 and 2021, respectively.

(g) Hardship withdrawals

Prior to Plan termination, the Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subjected to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(h) Administrative expenses

Prior to Plan termination, certain administrative expenses were paid directly by the Plan Sponsor while certain administrative expenses and investment expenses were paid by the Plan. Certain fees incurred by the Plan for the investment management services were netted within the net appreciation (depreciation) in the fair value of investments, as they were paid through revenue sharing rather than a direct payment.

(2) Summary of significant accounting policies

(a) Basis of accounting

As described in Note 1 of the financial statements, the Plan Sponsor terminated the Plan effective July 15, 2022. In accordance with accounting principles generally accepted in the United States of America ("GAAP"), the financial statements of the Plan were prepared under the liquidation basis of accounting for the period ended December 22, 2022. The financial statements of the Plan were prepared under the ongoing basis of accounting for the year ended December 31, 2021.

(b) Investment valuation and income recognition

Investments are stated at fair value as reported by John Hancock Life Insurance Company (USA) ("John Hancock"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determined the Plan's valuation policies utilizing information provided by the investment advisers and John Hancock. The investment values are discussed more fully in Note 4.

Purchases and sales of securities were recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(c) Payment of benefits

Benefits were recorded when paid.

(d) Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Events occurring after the reporting date

The Plan has evaluated events and transactions that occurred between December 22, 2022 and September 21, 2023, which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Information related to investments reported and disclosed in the accompanying financial statements, including investments held at December 22, 2022 and December 31, 2021 and net appreciation (depreciation) in fair value of investments for the period ended December 22, 2022 and the year ended December 31, 2021, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock.

(4) Investments measured at net asset value using the practical expedient

The Plan's investments (pooled separate accounts) were measured at net asset value ("NAV") as a practical expedient to estimate fair value and, therefore, have not been classified in the fair value hierarchy. The NAV is based on the market value of the underlying investments held by the pooled separate accounts at year end. This practical expedient would not be used if it is determined to be probable that an account will sell the underlying investment for an amount different from the reported NAV. Participant transactions (purchases and sales) could occur daily. If the Plan initiated a full redemption of the pooled separate accounts, the issuer reserved the right to temporarily delay withdrawal from the pool in order to ensure that securities liquidations would be carried out in an orderly business manner.

The following table summarizes investments for which fair value was measured using NAV as a practical expedient as of December 31, 2021. There were no participant redemption restrictions for these investments.

The Plan held various pooled separate accounts that were not direct filing entities. These pooled separate accounts had investment strategies that included: various target date funds, international and sector funds, equity and index funds.

(5) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on November 30, 2020, which stated that the pre-approved profit sharing plan was designed in accordance with the applicable sections of the IRC. The pre-approved profit sharing plan has been amended since receiving the opinion letter and the Plan itself has not received an opinion letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the adopted pre-approved profit sharing plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 22, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Untimely remittance of participant contributions

The Plan Sponsor was required by Department of Labor regulation to remit participant contributions as soon as practicable but by no later than the fifteenth business day following the end of the month in which the amounts were withheld from wages. For certain contributions withheld in 2022 and 2021, funds were not remitted timely. Imputed lost earnings applicable to the 2022 and 2021 contributions were calculated and remitted to the Plan in 2022.

(7) Excess contributions

Contributions received from participants for 2022 and 2021 are net of payments of \$13,628 and \$20,470, respectively, made to certain active participants to return to them excess deferral contributions, as required to satisfy the relevant nondiscrimination provisions of the Plan.

(8) Related party and party-in-interest transactions

The Plan invested in pooled separate accounts that were managed by John Hancock. The Plan also had cash held by John Hancock. Therefore, these transactions qualified as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers which also qualify as party-in-interest transactions.
