Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Clinical Management Concepts, Inc. 401(k), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and of accumulated plan benefits as of December 31, 2022 (in liquidation) and 2021 (ongoing), and the related statements of changes in net assets available for benefits and of changes in accumulated plan benefits for the year ended December 31, 2022 (in liquidation), and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Basis for Opinion

Emphasis of Matter — Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Board of Directors of Clinical Management Concepts, Inc. 401(k) approved a plan of liquidation on February 10, 2022, and management determined liquidation is imminent. As a result, Clinical Management Concepts, Inc. 401(k) changed its basis of accounting from the accrual method basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Clinical Management Concepts, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General. As of July 31, 2011, Clinical Management Concepts, Inc. (the "Plan sponsor" or the "Company") implemented a defined contribution profit sharing plan covering substantially all employees of Clinical Management Concepts, Inc., who have completed six months of employment with at least 500 or more hours of service and are age 21 or older. The Plan was amended in 2016 to comply with current regulations and to add additional Plan features which took effect subsequent to the amendment.

Plan Trustee, Sponsor and Administrator. Advisor Trust, Inc., serves as Trustee of the trust created under the Plan. Clinical Management Concepts, Inc., services as both the Plan Sponsor and Plan Administrator.

Contributions. The Plan provides for participant elective deferrals including catch-up contributions. A participant may elect to contribute up to 100% of his or her compensation in any plan year subject to maximum deferral amounts set forth in the Internal Revenue Code. Roth deferrals are also permitted. In addition, the Plan sponsor may provide discretionary matching contributions and non-elective contributions.

The Plan sponsor provides a safe harbor matching contribution equal to 100% of the of the matched employee contributions that are not in excess of 4% of the participant's compensation. The Plan sponsor may also make matching contributions in addition to the above.

Participant Accounts. Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary match and non-elective contributions and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants. Participants may borrow from their vested fund accounts as described in the Plan Document.

Payment of Benefits. On termination of service, the vested balance is paid directly in cash if the participant's vested account totals \$1,000 or less. If the participant's vested balance exceeds \$1,000, the vested balance will be distributed from the Plan. The participant may elect to have the vested account paid in cash or to roll over the distribution to an individual retirement account or the qualified plan of a new employer. Additional guidelines may apply based on the participant's age, vested balance and current or prior marital status.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Forfeited Accounts. Forfeitures of participant non-vested accounts may first be used to pay Plan expenses, and then to reduce future employer contributions. Forfeited non-vested accounts for the year ended December 31, 2022, and 2021, totaled \$-0-.

Vesting. The employee's deferral is fully vested at all times. The employer discretionary match and non-elective contributions are vested on a six-year graded schedule, as follows:

Investment Options. The Plan's investment options are managed by Marmo Financial Group, LLC and held by Advisor Trust, Inc., the Trustee of the Plan. Upon enrollment into the Plan, a participant may direct contributions in any of the available funds managed by Marmo.

Administrative Expenses. The Plan permits the payment of the Plan expenses to be made from the Plan assets. If the Company does not pay these expenses, then the expenses paid using the Plan's assets will be allocated among the participant accounts.

Plan Termination. The plan was terminated on February 10, 2022. No further contributions were made after this date. As of December 31, 2022, all assets of the plan have been fully liquidated.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared using the liquidation basis of accounting in 2022 and the accrual method of accounting in 2021 based on accounting principles generally accepted in the United States of America, which requires the plan administrator to make estimates and assumptions that offset certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investments are reported at fair value as reported by the Trustee. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Refer to Note 4 for discussion of fair value measurements. The Plan's investments are valued daily.

Investment Valuation and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation or depreciation of investments included in the accompanying statement of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in fair value of investments. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in the fair value of the investments held during the year. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investment as of the beginning of the year or the cost of the investment if purchased during the year.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the trustee as of December 31:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 4 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature under Financial Accounting Standards Board (FASB)

Accounting Standards Codification (ASC) 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 values are based on quoted prices in active markets for identical securities; Level 2 values are based on significant observable market inputs corroborated by market data but not quoted on active markets; Level 3 values are based on significant unobservable inputs and include situations where there is little, if any, market activity for the securities.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The Plan had no Level 2 or Level 3 investments as of December 31, 2022 and 2021.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

As the Plan sponsor, the Company is a party-in-interest with respect to the Plan. The Company's employer contributions to the Plan qualify as exempt party-in-interest transactions because a fiduciary does not cause the Plan to participate in the transactions. In addition, there were no reimbursements of direct expenses paid by the Plan to the Company for Plan operations and administration in 2022 or 2021.

Administrative expenses totaling \$13,812 and \$20,666 for the year ended December 31, 2022, and 2021, were paid from plan assets to PCS Retirement, LLC, for accounting, trustee and discretionary trustee services, contract administration, direct payments from the plan, recordkeeping fees and various related services. In addition, the plan paid \$7,966 and \$33,478 to Marmo Financial Group LLC, in 2022 and 2021, for investment management services.

All party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 - TAX STATUS

The Internal Revenue Service has determined and informed the Plan trustee by a letter dated November 30, 2014, that the Volume Submitter Profit Sharing Plan with CODA and trust adopted by the Plan sponsor are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended subsequent to the date of the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax exempt.

The Plan follows the accounting guidance for uncertainty in income taxes using the provisions of FASB ASC Topic 740, *Income Taxes*. The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits. The Plan's evaluation was performed for tax years ended December 31, 2018, through December 31, 2022, the years that remain subject to examination by major tax jurisdictions as of December 31, 2022.

NOTE 7 – AMOUNTS OWED TO WITHDRAWN PARTICIPANTS

As of December 31, 2022, and 2021, the amount of net assets available for benefits that were in accounts of participants that are no longer employees of the plan sponsor totaled \$0 and \$0.

NOTE 8 – RISKS AND UNCERTAINTIES

In March 2021, the World Health Organization categorized the Coronavirus Disease (COVID-19) as a pandemic, and the President of the United States declared the COVID-19 outbreak a national emergency. The COVID-19 pandemic has led to volatility in financial markets and may affect the fair value of Plan assets. The potential economic impact brought by, and the duration of, COVID-19 is difficult to assess or predict and will depend on future developments that are highly uncertain and cannot be predicted. The impact on the Plan sponsor and the Plan could be material.

NOTE 9 – SUBSEQUENT EVENTS

The plan administrator has evaluated events and transactions subsequent to December 31, 2022 through August 28, 2023 (the date the financial statements were available to be issued) for potential recognition or disclosure in the financial statements. Outside the below mentioned item, the plan administrator has not identified any other items requiring disclosure.

In February 2022, Russian forces invaded the country of Ukraine causing a sharp escalation of the Russo-Ukrainian War. The invasion has caused global economic uncertainty due to numerous economic sanctions placed on Russia by the United States, European Union, and members of the NATO alliance. Additionally, during 2022, the U. S. Federal Reserve began raising interest rates in efforts to combat rising inflation. These events have led to volatility in financial markets and has affected, and may continue to affect, the fair value of Plan assets. The potential economic impact brought by, and the duration of, these events is difficult to assess or predict and will depend on future developments that are highly uncertain and cannot be predicted. The impact on the Plan Sponsor and the Plan could be material.
