Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Excel Industries, Inc. Note 1: Description of the Plan

General

The following description of Excel Industries, Inc. Employees 401(k) Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan was a defined contribution plan sponsored by Excel Industries, Inc. (Company) for the benefit of its employees. Related employers who also participated in the Plan include Hustler Turf Equipment, Inc. Employees were eligible to participate at the beginning of the month following their hire date. The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Various members of the Company's management were the trustees of the Plan until November 1, 2021, at which time, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company became the trustee. Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (collectively, Principal) served as Plan custodians.

During 2021, Excel Industries, Inc. was acquired by Stanley Black & Decker, Inc. The Plan was merged with the Stanley Black & Decker Retirement Account Plan effective January 12, 2023. The Plan merger initiated a blackout period beginning January 6, 2023. During this period, participants were unable to direct, diversity or withdrawal the assets held in their accounts.

Contributions

The Plan permitted eligible employees through a salary deferral election to have the Company make annual pre-tax or Roth contributions of up to 95 percent of eligible compensation. Employee rollover contributions were also permitted. Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions.

The Company made matching contributions of 50 percent of employees' salary deferral amounts on the first 6 percent of employees' compensation.

Contributions were subject to certain limitations.

Participant Investment Account Options

Participants directed their accounts to be invested into any of the various investment options offered by the Plan and could change the allocation daily.

The Plan Document also included an automatic deferral feature whereby a participant was treated as electing to defer 6 percent of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provided for an annual 1 percent increase in the percentage deferred and was ultimately capped at 10 percent.

Participant Accounts

Each participant's account was credited with the participant's contribution, the Company's contributions and plan earnings (losses) and was charged with an allocation of administrative expenses. Allocations were based on participant earnings (losses) or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their voluntary contributions plus earnings (losses) thereon. Vesting in the Company's contribution portion of their accounts plus earnings (losses) thereon was based on years of continuous service. A participant was fully vested after five years of continuous service.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or the greater of 50% of their account balance or \$10,000 less outstanding notes. The loans were secured by the balance in the participant's account and bore a reasonable rate of interest based on local prevailing rates as determined by the Plan administrator. Principal and interest was paid ratably through payroll deductions. Notes were repayable over a period not to exceed five years. Participants could only have one note outstanding at any one time.

Payment of Benefits

Upon termination of service, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a joint or survivor annuity. Participants could also elect in-service withdrawals, including for financial hardship withdrawals, as defined by the Plan.

Forfeited Accounts

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$6,352 and \$275, respectively. These accounts were used to reduce future employer contributions or pay Plan administrative expenses. Also, in 2022 and 2021, employer contributions were reduced by \$118,057 and \$80,011, respectively, from forfeited nonvested accounts and forfeitures of \$47,178 and \$29,792 were used to pay Plan administrative expenses, respectively. In 2023, forfeitures of \$6,030 were used to reduce 2022 contribution receivable and forfeitures of \$7,996 were used to pay administrative expenses.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for direct investments in fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value (except for direct investments in fully benefit-responsive investment contracts, which were reported at contract value). Quoted market prices, if available, were used to value investments. Mutual funds were valued at the net asset value (NAV) of shares held by the plan at year end.

Pooled separate accounts were valued at estimated fair value as provided by Principal Life Insurance Company.

The Plan's interest in the collective investment trusts were valued based on information reported by the investment advisor using the audited financial statements of the collective investment trusts at year end.

Direct investments in fully benefit-responsive investment contracts were valued at contract value. Contract value represented contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants were recorded upon distribution.

Administrative Expenses

Administrative expenses could be paid by the Company or the Plan, at the Company's discretion.

Note 3: Certification of Plan Custodians

The plan administrator had elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company, d/b/a Principal Trust Company, collectively qualified institutions, certified the following information included in the accompanying financial statements and ERISA-required supplemental schedules were complete and accurate.

- Investments as shown in the statements of net assets available for benefits as of January 12, 2023 and December 31, 2022 and 2021.
- Notes receivable from participants as shown in the statements of net assets available for benefits as of January 12, 2023 and December 31, 2022.
- Investment income (loss) as shown in the statements of changes in net assets available for benefits for the period ended January 12, 2023 and the years ended December 31, 2022 and 2021.
- Interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period ended January 12, 2023 and the year ended December 31, 2022.
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4: Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

Certain Plan investments were managed by the custodians and, therefore, these transactions qualified as party-in-interest transactions. Fees incurred by the Plan for the investment management services were netted against administrative expenses, as they were paid through revenue sharing, rather than a direct payment. The Company directly paid any other fees related to the Plan's operations.

The Plan paid \$9,451, \$141,904 and \$160,360 of recordkeeping fees to Principal Life Insurance Company during plan period ending January 12, 2023 and for the years 2022 and 2021, respectively. The Company provided certain administrative services at no cost to the Plan.

Note 5: Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There were no significant changes in the valuation techniques during the years ended December 31, 2022 and 2021. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities were classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs were not available, securities were classified within Level 3 of the hierarchy. The Plan did not hold any Level 3 securities.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The following table summarizes investments for which fair value was measured using the net asset value per share practical expedient as of December 31, 2022 and 2021. There were no participant redemption restrictions for these investments; the redemption notice period was applicable only to the Plan.

Note 6: Investment Contract with Insurance Company

In 2016, the Plan entered into a fully benefit-responsive investment contract with Principal Life Insurance Company. Principal Life Insurance Company maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract was fully benefit responsive; therefore, contract value was the relevant measurement. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator did not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Note 7: Plan Termination

Although the Plan did not terminate, it was elected by Stanley Black & Decker's Pension Operating Committee (the parent company of Excel Industries) to merge the Plan into the Stanley Black & Decker Retirement Account Plan effective January 12, 2023.

Note 8: Tax Status

The Plan operated under an adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust sponsored by Principal Life Insurance Company. This prototype plan document had been filed with the appropriate agency. The Plan had not obtained or requested a determination letter. The Plan was amended since the prototype received the opinion letter. However, the Plan Administrator believed the Plan was designed and operated in compliance with the applicable requirements of the Internal Revenue Code.

Note 9: Reconciliation of Financial Statements to Form 5500

For financial statement reporting, revenue sharing credits were netted against administrative expenses. For Form 5500 purposes, administrative expenses were shown gross of revenue sharing credits and those credits were included in net investment gain (loss).

Note 10: Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. The Company did not remit all employee contributions to the Plan within the required time period for the year ended December 31, 2021 and lost earnings were remitted in 2022.

Note 11: Subsequent Events

Subsequent events have been evaluated through September 28, 2023, which is the date the financial statements were available to be issued.
