Note 1: **Description of Plan**

The following description of the Allied Framers 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a qualified retirement plan commonly referred to as a 401(k) Plan covering all eligible employees of Allied Framers, Inc. (the Company), who have completed three months of service and are age twenty one or older, as defined by the Plan. The Plan, which was adopted October 1, 1995, is subject to the provisions of section 401(k) of the Internal Revenue Code (IRC) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees may elect to make pre-tax or Roth contributions to the Plan, not to exceed \$20,500 in 2022. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. The Plan also includes an automatic enrollment feature. The employee is notified that the employer will withhold a percentage of 3% of eligible compensation. Each participant may elect to have their individual account invested in any combination of funds held by the Plan custodian.

The Company may also elect to make matching and profit sharing contributions, at the discretion of management. During the year ended December 31, 2022, the Company did not make any matching or profit sharing contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, and allocations of the Company's contributions, net earnings from investments and changes in investment values, and administrative expenses. Allocations are based on participant contributions, earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are always fully vested in accounts attributable to salary deferrals including Roth 401(k) deferrals, "catch-up contributions" and rollover contributions. Participants become vested in their employer discretionary matching and discretionary profit sharing contributions at the rate of 25% after one year of service and 25% per year of service thereafter. Participants are 100% vested after four years of service. Forfeitures may be used first to reduce the Plan's administrative expenses and then to offset any Plan sponsor contributions.

Note 1: **Description of Plan (Continued)**

Payment of Benefits

Upon termination of employment due to retirement, death, disability or separation from service, the balances in the participants' accounts will be distributed to the participants or to their beneficiaries in a single lump sum payment, in equal installments in the form of a nontransferable annuity, or some combination of the foregoing, at the election of the beneficiary.

Notes Receivable from Participants

Loans to participants consist of promissory notes received from participants in exchange for the distribution of cash from the Plan. A participant is allowed to borrow a minimum of \$1,000, up to one half of the balance of their Plan account, up to a maximum of \$50,000. A participant may have only one loan outstanding at any time unless (1) one loan is a principal residence loan amortized for a period greater than five years or (2) there was more than one loan outstanding on January 1, 2015. The loans bear a reasonable fixed-rate of interest and generally must be repaid within five years.

Administrative Expenses

The Company, as Plan sponsor, pays certain administrative expenses on behalf of the Plan. Participant's accounts are adjusted for fees pertaining to termination processing, and are charged for expenses incurred by the custodian in performance of their duties.

Note 2: **Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

In preparing the financial statements in accordance with accounting principles generally accepted in the United States of America, management makes estimates and assumptions which affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value as certified by the Plan's custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2: **Summary of Significant Accounting Policies (Continued)**

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Subsequent Events

In preparing the accompanying financial statements, management has considered events that have occurred after December 31, 2022, through September 26, 2023, the date these financial statements were available for issuance. Except as disclosed in Note 6, as of such date, management was not aware of any subsequent events requiring additional disclosure.

Note 3: **Information Certified by the Custodian**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by The Standard Insurance Company (the custodian of the Plan).

Note 4: **Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1) Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

- Level 2) Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Note 5: **Guaranteed Investment Contract with Insurance Company**

The Plan entered into a fully benefit-responsive group annuity contract issued by The Standard Insurance Company. The Standard Insurance Company maintains the contributions in a general account. The account is credited with a fixed rate of interest. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest contract. Contract value, as reported to the Plan by The Standard Insurance Company, represents contributions made under the contract, plus interest earned, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value less an early withdrawal charge, when applicable.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) termination of the contract, (2) spin-offs, (3) divestitures, (4) layoffs, (5) corporate relocation, (6) partial or total plan termination, (7) retirement incentive programs, and (8) liberalization of plan withdrawal or transfer rules. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The guaranteed investment account is included in the financial statements at fair value which is equal to contract value.

Standard Insurance Company may terminate the contract with thirty days advance written notice to the contract owner for reasonable cause that includes (1) the contract owner's failure to abide by state or federal law, (2) failure to render performance necessary to company with the terms of the contract, (3) failure to maintain assets of at least \$25,000, (4) plan disqualification, and (5) failure to adopt the plan in a reasonable period of time. The Plan administrator does not believe it is probable that this will occur.

Note 6: **Excess Contributions Payable**

The Plan failed the discrimination testing for the year ended December 31, 2022 and 2021. Excess contributions amounting to \$5,644 and \$17,103 are recorded as liabilities on the accompanying statements of net assets available for benefits and as a reduction of participant contributions for each year, respectively. The Plan distributed these excess contributions to the affected participants during the years ended December 31, 2023 and 2022, respectively.

Note 7: **Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor reserves the right to terminate the Plan at any time. In the event of Plan termination, all accounts become fully vested and non-forfeitable. Plan assets would be first used to pay expenses properly charged to the Plan. The remainder would then be distributed to participants in a lump sum.

Note 8: **Tax Status**

Effective, January 1, 2022, the Company adopted a non-standardized pre-approved profit-sharing plan with CODA (Pre-approved plan). The IRS determined and informed the Pre-Approved Plan sponsor by a favorable opinion letter dated June 30, 2020, that the Pre-Approved Plan is designed in accordance with the applicable section of the IRC.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognizes tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9: **Party-in-Interest Transactions**

Certain Plan investments include shares of registered investment company funds managed by The Standard Insurance Company. As The Standard Insurance Company is the custodian and trustee of the Plan, transactions with this entity qualify as exempt party-in-interest transactions.

Note 10: **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
