Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of T-O Engineers, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of T-O Engineers, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion on the Financial Statements

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

NOTES TO FINANCIAL STATEMENTS

A. Description of Plan:

The following description of the T-O Engineers, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General** - The Plan is a defined contribution plan covering all employees of T-O Engineers, Inc. (Company/Sponsor) upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on August 1, 1995 and was restated on August 1, 2018 to give elective service crediting to employees of GDA. The Plan was amended and restated effective August 23, 2021, to bring the Plan into compliance with the requirements of the 2017 Cumulative List (Notice 2017-37).
2. **Contributions** - Each year participants may make elective deferrals of their pretax annual compensation up to the maximum limits, as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan Sponsor contributes a discretionary matching amount determined annually. Additional amounts may be contributed at the discretion of the Company's management in the form of nonelective contributions. The nonelective contribution is made based on classifications of participants and allocated on a pro rata basis within the classification. To be eligible for the nonelective contributions employees need to work at least 1,000 hours and be employed on the last day of the Plan year. For 2022 and 2021 there were Employer contributions of \$686,127 and \$724,445, respectively. Contributions are subject to certain IRS limitations.
3. **Participant Accounts** – Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. **Vesting** – Participants are immediately vested in their contributions. Participants become fully vested in Employer contributions over a six-year period: 20% upon completion of two years of employment and 20% per year thereafter until fully vested. Participants become 100% vested regardless of years of service upon death or disability.
5. **Forfeited Non-vested Accounts** – When a participant terminates prior to fully vesting, the non-vested portion of the participant's account is used to reduce administrative expenses. At December 31, 2022 and 2021, forfeited non-vested account balances totaled \$0 and \$53,507, respectively. In 2022, forfeited accounts were used to pay Plan expenses and reduce employers' contributions of \$7,000 and \$111,636, respectively. In 2022, forfeited accounts were also used to offset profit sharing in the amount of \$25,000. The remaining balance of forfeitures of \$38,172 were transferred to Ardurra Retirement Plan during 2022. In 2021, forfeited accounts were used to pay Plan expenses and reduce employers' contributions of \$36,000 and \$6,500, respectively.
6. **Payment of Benefits** – Upon attaining normal retirement age of 65, termination of employment, or disability or death, a participant may receive a lump-sum amount or installments equal to the vested interest of his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

B. Summary of Significant Accounting Policies:

The following are the significant accounting policies followed by the Plan:

1. **Basis of Accounting** – The financial statements of the Plan are prepared using the accrual method of accounting.

B. Summary of Significant Accounting Policies (continued):

2. **Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. **Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Custodians determine the Plan’s valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note J for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

4. **Payments of Benefits** – Benefits are recorded when paid.
5. **Costs of Plan Administration** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer, T-O Engineers, Inc. Expenses that are paid by the employer are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.
6. **Reclassifications** – Certain amounts for the year ended December 31, 2021, were reclassified to conform to the current year presentation. The reclassifications did not affect the net increase for the year ended December 31, 2021.
7. **Subsequent Events** – The Plan has evaluated subsequent events through September 29, 2023, the date the financial statements were available to be issued.

C. Plan Termination:

On September 1, 2022, the Plan adopted a resolution to merge with Ardurra Retirement Plan. All plan assets and liabilities were to be transferred and merged with the Ardurra Retirement Plan effective December 31, 2022. However, one of the funds could not be immediately liquidated but instead is being paid out in installments per the conditions laid out in the Contract Termination letter over a period of 12 to 36 months. The plan will remain frozen until the last payout from the annuity occurs, at which time the T-O Engineers, Inc. 401(k) plan will terminate.

As a result of the merger an aggregate amount of \$12,616,077 of Plan assets were transferred from the Plan and is included on the Statement of Changes in Net Assets Available for Benefits. This included \$12,577,905 of participant accounts and \$38,172 of forfeitures.

D. Tax Status:

The Plan uses a pre-approved Plan document sponsored by Empower Trust Company, LLC, which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan itself has not received an opinion letter from the IRS; however, the Plan’s management believes that the Plan is currently designed and being operated in compliance with the applicable requirement of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. Concentration of Credit Risk:

Financial instruments that potentially subject the Plan to concentrations of credit risk consist of cash and short-term investments and marketable securities. The amount of exposure to any one specific investment has been limited by investing in mutual funds that use a diverse investment portfolio to limit risk.

H. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially alter participants' account balances and the amounts reported in the statement of net assets available for benefits.

I. Excess Contribution Payable:

Amounts payable to participants for contributions in excess of nondiscrimination provisions are recorded as a liability with a corresponding reduction to contributions. The amount of excess contributions were \$26,843 and \$14,023 for the years ended December 31, 2022 and 2021, respectively.

J. Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• Quoted prices for similar assets or liabilities in active markets;• Quoted prices for identical or similar assets or liabilities in inactive markets;• Inputs other than quoted prices that are observable for the asset or liability;• Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Valued at the net asset value (NAV) based on the fair value of the assets underlying the funds. These investments are valued daily and have no redemption restrictions or future commitments.

L. Contract with Insurance Company:

The Plan entered into a traditional benefit-responsive guaranteed investment contract (GIC) with Empower Life & Annuity Insurance Company (Empower). Empower maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The GIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contribution made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2022 and 2021 were \$800,584 and \$377,375, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. Amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan).
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions.
3. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestiture or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan.
4. The Plan's failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
5. Premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

M. Related Party and Party-In-Interest Transactions:

Certain Plan investments are managed Empower Annuity Insurance Company of America and Empower Trust Company, LLC Empower Annuity Insurance Company of America and Empower Trust Company, LLC is the custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

N. SECURE 2.0:

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act Secure Act 2.0. Most of the provisions will become effective beginning in 2024. Therefore, there is no current impact to the Plan. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.
