Report on the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **RENEW ENERGY MAINTENANCE LLC 401(k)** Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 30, 2022 (date of merger) and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through December 30, 2022 (date of merger), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 30, 2022 (date of merger), and December 31, 2021, and for the period from January 1, 2022 through December 30, 2022 (date of merger), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

(1) Summary of Significant Accounting Policies

Nature of Business of Plan Sponsor

RENEW Energy Maintenance, LLC and RENEW Energy Electrical, LLC (collectively, the Company) provide construction, maintenance, and testing services in the wind and solar energy industries.

Effective December 30, 2022, the Plan merged into Takkion Management Company LLC 401(k) Plan (Takkion 401(k)) for the purpose of consolidating Takkion Management Company's existing 401(k) plans. Takkion Management Company is the parent Company of RENEW Energy Maintenance LLC 401(k).

Basis of Accounting

The financial statements of RENEW Energy Maintenance LLC 401(k) Plan (the Plan) are prepared using the accrual method of accounting.

Risks and Uncertainties

The Plan provides for various investment options. Investments are exposed to various risks, such as interest, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value on a recurring basis as determined by the Trustee (Notes 3 and 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded when received.

Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 30, 2022 (date of merger) and December 31, 2021, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts and disclosures reported in the financial statements. Actual results could differ from those estimates.

Net Change in Fair Value

The net appreciation (depreciation) in fair market value of investments is composed of the realized gains and losses in securities that were sold or otherwise disposed of during the year and the unrealized gains and losses in securities held at the end of the year.

(1) Summary of Significant Accounting Policies

Payments of Benefits

Benefits are recorded when paid.

(2) Description of the Plan

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the Company. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Full-time employees of the Company who have completed 6 months of service and attained the age of 18 are eligible to participate in the Plan. The Plan excludes union employees, leased employees, nonresident aliens, and part-time, temporary or seasonal employees with less than 1,000 hours of service.

Contributions

Each year, participants may contribute a percentage of their pretax annual compensation, as defined in the Plan, up to certain limits as established by the Internal Revenue Service. The Plan provides for matching contributions by the Company equal to 50 percent of each participant's elective deferral contributions not exceeding 6 percent of their pretax annual compensation. The Plan also allows for additional discretionary profit-sharing contributions by the Company. There were no additional discretionary contributions made at December 30, 2022 (date of merger) and December 31, 2021. Participants may roll over amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan allows Roth elective deferrals. Contributions to Roth accounts are made on an after-tax basis and contributions to a Roth account are included in the participant's gross contributions. Future distributions of Roth elected contributions and earnings thereon will not be taxed, if certain criteria are met. Roth elective deferrals to the Plan are permanently designated as Roth elective deferrals in participant accounts. The participant's Roth deferrals and gains and losses attributable to such deferrals are accounted for separately.

The Plan instituted automatic enrollment in which the Plan Sponsor automatically withholds 3 percent of the eligible participant's compensation upon becoming eligible to participate unless otherwise elected by the participant. Contributions are automatically invested in the appropriate target date fund unless the participant elects other investment options. The Plan increases the participant's automatic enrollment by 1 percentage per year up to a maximum 6 percent of compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's matching contribution, the Company's additional discretionary contribution, Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participants direct investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(2) Description of the Plan

Investment Options

Participants direct their account balance to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options and terminate contributions at any time throughout the year.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contributions portion of their accounts and earnings thereon is based on years of credited service. A participant becomes 20 percent vested after a year of credited service, as defined, and continues to vest at the rate of 20 percent for each successive year of service until 100 percent vested after 5 years of credited service. A participant also becomes 100 percent vested when employed at age 65, upon death, plan termination or permanent disability.

Subsequent to the transfer to Takkion 401(k), plan participants vesting of employer matching contributes are 100% vested after one year of service.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years. Only one note per participant may be outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the prime rate plus one percent. Principal and interest are paid ratably through payroll deductions. Existing loans as of December 31, 2022 (date of merger) were transferred to Takkion 401(k).

Payment of Benefits

Upon termination of service due to death or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or one of various annuities. For termination due to other reasons, a participant may elect a lump-sum amount equal to his or her vested balance. If no election is made by the participant upon termination of employment, benefits less than \$1,000 are distributed as soon as administratively feasible. Vested benefits greater than \$1,000 but less than \$5,000 are rolled over into an individual retirement account.

Forfeitures

Nonvested account balances are forfeited unless participants return to employment and contribute the distribution received at termination within a specified time. At December 30, 2022 (date of merger) and December 31, 2021, forfeited nonvested accounts totaled **\$-0-** and \$13,571, respectively. The Plan uses forfeitures to reduce employer contributions. Forfeitures of approximately \$12,125 were used to reduce employer contributions for the period ended December 30, 2022 (date of merger).

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Company has, at its discretion, absorbed certain other administrative expenses pertaining to the Plan. If not paid by the Company, these administrative expenses become the responsibility of the Plan.

(3) Information Certified by Trustee

The Plan's investments are held by Capital Bank and Trust Company, the Trustee, who performs all accounting functions associated with the Plan's investments. The fair value of investments at December 30, 2022 (date of merger) and December 31, 2021 is determined by the Trustee (Note 7).

In accordance with Section 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator has received certification from the Trustee as to the accuracy and completeness of certain financial information of the Plan as of and for the years ended December 30, 2022 (date of merger) and December 31, 2021. The Trustee has certified information contained in the following:

Statements of Net Assets Available for Benefits
Statement of Changes in Net Assets Available for Benefits (except for contributions, benefits paid to participants, and administrative expenses)

(4) Income Tax Status

The Plan has adopted a non-standardized form of prototype plan. The prototype plan obtained an opinion letter dated June 30, 2020, in which the IRS stated that the volume submitter document satisfies the applicable requirements of the Internal Revenue Code. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Department of Labor or IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 30, 2022 (date of merger), there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(5) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level One: inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level Two: inputs include:
 1. Quoted prices for similar assets or liabilities in active markets;
 2. Quoted prices for identical or similar assets or liabilities in inactive markets;
 3. Inputs other than quoted prices that are observable for the asset or liability;
 4. Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level Three: Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The following table presents the assets carried at fair value as of December 31, 2021, in the accompanying Statements of Net Assets Available for Benefits by fair value hierarchy, as described above. All are measured on a recurring basis. No liabilities are measured at fair value on a recurring or nonrecurring basis.

Money Market Fund: Valued at carrying value, which approximates fair value based on the amount of net contributions plus any investment earnings allocated to the account.

(6) Related Party Transactions

Fees for legal and professional services rendered to the Plan may be paid by the Company at its discretion. The Plan allows participants to take out loans against their account balance.
