### Note 1 - Description of plan:

The following description of the Wayne Farms LLC 401(k) Plan for Union Employees (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan sponsor is Wayne Farms LLC (the Company, Plan Sponsor, or Plan Administrator). The Plan is a defined contribution plan covering substantially all hourly union employees of the Company, who are covered by a collective bargaining agreement, based on eligibility requirements established per the specific Union agreements. Participants are eligible to enroll upon attainment of eligibility, as determined by specific Union agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor Administrative Committee (Admin Committee) is responsible for oversight of the Plan. The Company's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Admin Committee.

On July 22, 2022, Cargill and Continental Grain Company announced the completion of the previously announced acquisition of Sanderson Farms, Inc. (NASDAQ: SAFM) (Sanderson Farms) by a joint venture between Cargill and Continental Grain. As a part of the closing of the transaction, Cargill and Continental Grain have combined Sanderson Farms with the Company, a subsidiary of Continental Grain, forming a new privately held poultry business. The new business is named Wayne-Sanderson Farms. As a result of this transaction, it was determined that the Plan would be merged into the the Wayne Farms, LLC Non-Union Employees' Savings Plan (Non-Union Plan). Substantially all participants of the Plan and assets totaling \$28,366,131, including approximately \$20,000 of notes receivable from participants were transferred to the Non-Union Plan, effective December 31, 2022. The remaining \$650,120 of assets transferred out of the Plan represent participant accounts transferred to the Non-Union Plan during the year ended December 31, 2022 as a result of employees changing from a union position to a non-union position (See Note 2). This merger effectively merged the Plan out of existence, at December 31, 2022.

#### Contributions

Each year, participants may contribute from 1% to 25% of compensation in 1% increments, as defined in the Plan document. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants who have attained age 50 or greater before the end of the Plan year are eligible to make catch-up contributions according to the regulations of the Internal Revenue Code (IRC).

### Note 1 - Description of plan - continued:

#### Contributions - continued

The Company makes non-discretionary matching contributions to the Plan, as determined by specific Union agreements. For the year ended December 31, 2022, the Company made non-discretionary matching contributions totaling \$2,845,000.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated default investment fund until changed by the participant. The employee contribution deferral rate is increased by 1% annually until the contribution deferral percentage reaches 10%. A participant may elect to change their deferral percentage in one percentage point increments or decline to participate in the Plan at any time. Participants may direct their contributions to any of the Plan's investment options and may change their investment options daily.

#### Participant accounts

Each participant's account is credited with the participant's contributions, an allocation of Company non-discretionary matching contributions, and an allocation of Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contributions and earnings thereon is based on years of continuous service.

Participants become vested in Company non-discretionary matching contributions as determined by specific Union agreements.

Participants are immediately vested upon termination of the Plan, upon reaching the normal retirement age of 65, or upon disability or death while an employee of the Company.

### Note 1 - Description of plan - continued:

#### Payment of benefits

A participant is entitled to receive a lump-sum amount equal to the vested value of his or her account upon attainment of age 59½, termination of service, retirement, disability, or death. A participant may request a withdrawal from the Plan while still under the employment of the Company for reasons of financial hardship, but the withdrawal is limited to the amount of the participant's pre-tax contributions and earnings thereon.

#### Notes receivable from participants

The Plan does not allow notes receivable from participants. However, effective January 1, 2018, the Plan allows participants who transfer into the Plan from the Non-Union Plan to transfer an outstanding note into the Plan and continue to make principal and interest payments ratably through payroll. Outstanding notes are secured by the balance in the participant's account and continue to bear interest at the agreed-upon percentage initially agreed upon receipt of the note from the Non-Union Plan.

#### Forfeitures

If a participant is terminated other than by reason of retirement, death, or total and permanent disability, the nonvested portion of the participant's account balance is forfeited. Forfeitures are used to offset administrative expenses of the Plan or to reduce Company contributions. The Company applied forfeitures of \$436,935 to offset Company contributions to the Plan for the year ended December 31, 2022. As a result of the Plan's merger to the Non-Union Plan, there were no amounts of unallocated forfeitures as of December 31, 2022. There were \$201,682 of unallocated forfeitures as of December 31, 2021.

#### Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Company reserves the right to elect to pay, or have the Plan pay, administrative costs in the future. Investment related expenses are included in net depreciation of fair value of investments.

### Note 2 - Summary of significant accounting policies:

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Collective trust fund

Investments in the collective trust fund are required to be reported at fair value. The collective trust fund, at the fund level, is composed primarily of fully benefit-responsive investment contracts held by the fund's trustee. These contracts are not considered fully benefit-responsive to the Plan as the underlying contracts are not direct investments between the Plan and the issuer. The Plan has elected to value the collective trust fund using net asset value (NAV) as a practical expedient to determine fair value.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and Vanguard Fiduciary Trust Company (Vanguard). Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date.

#### Payment of benefits

Benefits are recorded when paid.

#### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Note 2 - Summary of significant accounting policies - continued:

#### Plan transfers in and out

Other than as noted in Note 1, Plan transfers in and out represent transfers from and to the Wayne Farms LLC 401(k) Plan for Non-Union Employees (Non-Union Plan) that occurred during the year.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

#### Recent legislative developments

In December 2019, Congress passed the SECURE Act which included numerous reforms to existing retirement law and allows plan sponsors to make certain immediate plan operational changes without formal amendment of the plan document. If adopted, plan documents are required to be formally amended in accordance with IRS guidance.

In March 2020, Congress passed the CARES Act which included optional immediate changes to distribution and loan provisions without formal amendment of the plan document. If adopted, plan documents are required to be formally amended in accordance with IRS guidance.

The Plan Sponsor has amended the Plan for these changes.

#### Subsequent events

The Plan has evaluated subsequent events through July 31, 2023, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2022, have been incorporated into these financial statements.

### Note 3 - Investments and information certified by Vanguard

Vanguard holds the Plan's investment assets and executes investment transactions. Management has determined that Vanguard is a qualified institution and the information prepared and certified by Vanguard meets the requirements of ERISA Section 103(a)(3)(C). Certain information disclosed in the accompanying financial statements, including investments and participant notes held at December 31, 2021, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2022, was obtained and derived from information supplied to the Plan Administrator and certified as complete and accurate by Vanguard.

### Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4 - Fair value measurements - continued:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no significant changes in the methodologies used at December 31, 2022 and 2021.

- Shares of registered investment companies are valued at the NAV of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.
- Units of participation of the collective trust fund are valued at NAV provided by the fund's trustee as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the Plan's merger into the Non-Union Plan, effective December 31, 2022, there were no assets valued at fair value at December 31, 2022.

### Note 5 - Related-party transactions:

The Plan invests in shares of registered investment companies and a collective trust fund managed by affiliates of Vanguard. Vanguard acts as trustee for investments in the Plan. Transactions in such investments qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

### Note 6 - Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits

### Note 7 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. The Plan was merged out of existence effective December 31, 2022.

### Note 8 - Tax status:

The underlying pre-approved defined contribution plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the IRC, and therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
