### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

**Basis for Opinion**

**Emphasis of Matter – Plan Termination and Liquidation Basis**

As disclosed in Note I to the financial statements, the Plan Sponsor adopted an amendment on July 26, 2022 to terminate the Plan effective September 1, 2022 and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matters**

##### ***Supplemental Schedule Required by ERISA***

The supplemental Schedule of Assets (Held at Year-End) as of December 12, 2022 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

## **I. Description of Plan**

The following description of Wilde Automotive 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan with both employee and employer contributions, covering all eligible employees of Sun Imports, Inc., Wilde Automotive Management, Inc., Blue Water Insurance Group, LLC, Wilde Productions, Inc., Jacasa, Inc. and Lecasa, Inc. (together, the Company). The Plan was initially formed effective January 1, 1995. The Plan was subsequently restated effective January 1, 2017. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Plan Termination**

The Plan Sponsor has adopted an amendment to terminate the Plan effective September 1, 2022. On September 1, 2022 the Plan's assets were frozen until the Plan's liquidation and termination took effect. Participants of the Plan were notified that they had until November 30, 2022 to determine how assets would be distributed. As a result of the Plan termination, the Company has changed its basis of accounting from the going concern basis to the liquidation basis. All Plan assets were distributed in accordance with participant elections and Plan provisions between September 1, 2022 and December 12, 2022.

### **Eligibility**

Employees who are at least 21 years of age and have at least one year of service with the Company are eligible to participate in the Plan. Employees may elect to begin making contributions into the Plan on the first day of the quarter coinciding with eligibility. Employees are eligible to share in any profit-sharing contributions if they are employed with the Company on the last day of the Plan year and if they have completed at least 500 hours of service during the Plan year.

### **Participant Accounts**

Each participant's account is credited with the participant's salary deferral, any rollover contributions, and the employer's matching contributions (if any). Allocations of Plan earnings are based on the participant account balances in Plan's investments. The participant is entitled to the benefit provided by the participant's vested account balance.

### **Contributions**

Salary deferral contributions are made to the Plan by participating employees through payroll deductions in amounts authorized by the employees. Participants may contribute up to the limits of the Internal Revenue Service (IRS) of \$20,500 of pretax annual compensation for 2022. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. For 2022, the annual catch-up contribution limit was \$6,500. The Company also may make a discretionary matching contribution to the Plan each year.

Participants direct the investment of their contributions into various investment options offered by the Plan. The participants may change their investment elections at any time.

### **Vesting**

Participants are immediately vested in their salary deferral contributions and earnings thereon. Participants are vested in employer discretionary profit-sharing contributions and earnings thereon based on hours of service, as defined in the Plan as follows:

If, while an employee, the participant dies, becomes disabled or reaches normal retirement age of 65 before the six-year vesting period, the participant's account will be 100% vested. Participants are 100% vested in the value of employer contributions in their accounts upon termination of the Plan.

**Investment Options**

Upon enrollment in the Plan, a participant may direct and allocate their contributions to the investment options available. Employer contributions are allocated according to the participant's allocations. The percentage of contributions allocated to each of the investment options is at the discretion of the participant. Participants may change their investment options at any time using the custodian's website or via telephone.

**Allocation of Investment Income**

The allocation of earnings or losses of the funds shall be allocated in the same proportion that each participant's non-segregated accounts bear to the total of all participants' non-segregated accounts as of such date. Participants' accounts shall be credited with any dividends or interest received.

**Plan Expenses**

The Company pays the Plan's administrative service fees. For the period ended December 12, 2022, the Plan's administrative expenses were \$55,064.

**Forfeited Accounts**

As of December 12, 2022, and December 31, 2021, there were \$0 and \$183, respectively, in forfeited amounts from non-vested amounts in the accounts of participants who terminated employment. Forfeitures are allocated in the plan year when the forfeiture occurs. Forfeitures are first used to pay certain plan expenses and then any remaining amounts are used to reduce future employer contributions to the Plan. During 2022, forfeitures were used for the Plan's administrative expenses.

**Benefits Paid to Participants**

If a participant ceases to be employed by the Company for any reason other than death or total and permanent disability prior to satisfying the age (65) and service requirements for normal retirement, the terminated participant may elect, with the consent of his or her spouse, to receive any vested amounts plus the earnings thereon. Withdrawals may be subject to tax withholdings and penalties. If a participant's vested balance is \$5,000 or less, they will receive a single-sum payment at termination of employment.

Upon termination of service, due to normal retirement age of 65 (or early retirement age of 55), or death, a participant becomes fully vested and may elect to receive a lump-sum distribution equal to the value of his or her account balance, as described in the Plan.

**Benefits Paid to Participants**

Upon termination of service (due to reasons other than death or normal retirement), a participant may elect to receive a lump-sum distribution equal to the value of his or her vested account balance, as described in the Plan.

**Hardship Distributions**

Hardship distributions are permitted by the Plan at the discretion of the Company for allowable expenditures.

**Notes Receivable from Participants**

The Plan does not permit participants to take a loan from the Plan.

**2. Summary of Significant Accounting Policies**

**Financial Statements**

The financial statements and notes are representations of the Company's management, who is responsible for their integrity and objectivity. The accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

**Basis of Accounting**

The financial statements for the period January 1, 2022 through December 12, 2022 are presented using the liquidation basis of accounting while the financial statements for the year ended December 31, 2021 are presented using the going concern basis of accounting. There were no subsequent changes to the methods and assumptions used to value plan assets under the liquidation basis of accounting. The liquidation of Plan assets was completed on December 12, 2022.

**Use of Estimates and Assumptions**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets, changes in net assets and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

**Fair Value Measurement**

The Company adopted the Fair Value Measurements and Disclosures Topic of the FASB Accounting Standards Codification for fair value measurements of financial assets and financial liabilities that are recognized or disclosed at fair value in the financial statements on a recurring basis. The Fair Value Measurements and Disclosures Topic established a single authoritative definition of fair value, sets a framework for measuring fair value, and requires additional disclosures about fair value measurement. The financial statements reflect the adoption of the Fair Value Measurements and Disclosures Topic.

**Investment Valuation and Income Recognition**

Except for fully benefit-responsive investment contracts, investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Net Depreciation in the Fair Value of Investments**

The Plan presents, in the Statement of Changes in Net Assets in Liquidation, the net depreciation in the fair value of its investments. This consists of the realized gains and losses and the unrealized appreciation and depreciation of those investments.

**Payment of Benefits**

Benefits are recorded when paid.

**Financial Instruments Not Measured at Fair Value**

The Plan's financial instruments that are not measured at fair value on the recurring basis, but are recorded at amounts that approximate fair value due to their liquid or short-term nature include participant contributions receivable.

**3. Information Certified and Provided by Empower Annuity Insurance Company of America**

The Plan Administrator has obtained certification from Empower Annuity Insurance Company of America (Empower) that information provided to the Plan Administrator by the custodian related to the following investments is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information, which appears throughout the financial statements and supplemental schedule related to the following investments.

The following is a summary of the investment information as of December 12, 2022 and December 31, 2021, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by the custodian and furnished to the Plan Administrator.

Empower also certified to the completeness and accuracy of net depreciation in fair value of investments of \$1,794,750 and dividend income of \$214,242 for the period ended December 12, 2022.

**4. Fair Value Measurements**

The Fair Value Measurements and Disclosures Topic provides enhanced guidance for using fair value to measure assets and liabilities and clarifies the principle that fair value should be based on the assumptions market participants would use when pricing the assets or liabilities and establishes a hierarchy that prioritizes the information used to develop those assumptions. The hierarchy gives the highest priority to unadjusted quoted prices in active markets (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements).

The three levels for measuring fair value are based on the reliability of inputs and are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level - 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value at December 12, 2022 and December 31, 2021:

*Mutual funds:* Shares are generally valued at Net Asset Value Per Share (NAVPS) based upon net asset value of underlying portfolio securities and are published on a national exchange valued at the end of each day.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table presents information about the Plan's assets that are measured at fair value on a recurring basis as of December 12, 2022 and December 31, 2021 and indicates the fair value hierarchy of the valuation techniques used to determine such fair value.

**5. Guaranteed Interest Contract with Insurance Company**

The Plan holds a benefit responsive guaranteed interest contract with Empower. Empower maintains the contributions in a general account and is subject to the claims of Empower's general creditors. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed interest contract. The guaranteed interest contract is presented on the statements of net assets available for plan benefits at contract value. Contract value, as reported to the Plan by Empower, the administrator of the contract, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the fixed annuity at December 12, 2022 and December 31, 2021 approximates fair value, prior to any contract terminations. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**6. Parties-in-Interest to the Plan**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. The guaranteed investment contract is managed by the custodian. Transactions related to this investment qualify as party-in-interest transactions. The Supplemental Schedule of Assets (Held at End of Year) identifies these investments as of December 12, 2022.

Investments held by parties-in-interest are approximately 0% and 3% of the Plan's net assets available for plan benefits as of December 12, 2022 and December 31, 2021, respectively. Fees paid to the Custodian by the Plan for services amounted to \$55,064 for the period ended December 12, 2022.

**7. Tax Status**

The Plan has adopted a volume submitter profit-sharing plan. The Plan has received an opinion letter from the Internal Revenue Service as to its qualified status. The opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax position taken by the Plan, and has concluded that as of December 12, 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to income tax examinations for the 2019 through 2022 plan years.


