INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Mid America Computer Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note A - Description of Plan

The following brief description of the Mid America Computer Corporation (Company) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General.** The Plan is a defined contribution plan covering all full-time employees of the Company who have at least 6 months of eligible service and attained 20 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The associated companies of the controlled group of corporations participating in the Plan are Mid America Computer Corporation and EnSite, Incorporated. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

**Contributions.** Each year, participants may contribute up to an amount equal to a dollar amount or percentage of their annual wages before bonuses, based on their Salary Reduction Agreement not to exceed the limits imposed by Code Sections 401(k), 402(g), 404, and 415. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Other additional voluntary contributions are not permitted. Participants direct the investment of their elective deferral and Company matching contributions into various investment options offered by the Plan. Participants may change such allocation at any time directly with the Plan's custodian. The Plan currently offers 27 mutual funds as investment options for participants. The Plan has elected to be a safe harbor plan whereby matching contributions are 100% of the first 3% of any elective contributions plus 50% of any elective contributions in excess of 3% up to 6%.

Effective December 31, 2022, an election was made to freeze the existing plan. Contributions under this Plan are temporarily suspended. No contributions shall be made to the Plan with respect to compensation earned after the date the Plan is frozen.

**Participant Accounts.** Each participant's account is credited with the participant's contributions, any Company matching contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting.** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's safe harbor matching contribution portion of their accounts plus actual earnings thereon is 100%.

**Payment of Benefits.** On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or partial payments. Accounts can be either paid in cash or directly rolled into another qualified plan or into an individual retirement account. For terminated participants whose account is less than \$1,000, plan provisions provide for an automatic payout to the participant. For terminated participants whose account balance is between \$1,000 and \$5,000, plan provisions provide for an automatic rollover into an individual retirement account. The plan also allows for in-service withdrawals under certain circumstances, including withdrawals after age 59-1/2, after age 72, after normal retirement age (65), of rollover contributions, for participants performing qualified military service or qualified reservist distributions. For calendar years after 2019, under the CARES Act legislation, any plan participant that met certain criteria of being affected by COVID-19 could take a withdrawal from the plan.

Note B - Summary of Significant Accounting Policies

**Basis of Accounting.** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates.** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note C for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits.** Benefits are recorded when paid.

**Operating Expenses.** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of investments within participant accounts and distributions from participants accounts are charged directly to the participant's account and are included in administrative expenses.

Note C - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Money market accounts and mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of these investments, the investment adviser reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note F - Related Party Transactions

Certain plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Investments is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services and withdrawal requests to Fidelity Management Trust Company amounted to \$80,123 and \$92,648, respectively for the years ended December 31, 2022 and 2021.

The plan sponsor, Mid America Computer Corporation, absorbs most of the operating and administrative costs of the plan other than those disclosed above.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note G - Income Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

Note H - Risks and Uncertainties

The Plan provides for investments in mutual funds and a common collective trust. Investment securities are exposed to various risks including, but not limited to, interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note I - Subsequent Events

The Company has evaluated all subsequent events through September 25, 2023, the date the financial statements were available to be issued. On January 13, 2023, the Board of Directors of N. Harris Computer Corporation, a controlling party of Mid America Computer Corporation, approved the merger of this Plan into the Constellation Software (USA) Inc. Retirement Savings Plan, effective February 28, 2023. As result, all accounts for acquired participants who are still actively employed at the end of December were spun-off from the MACC Retirement Plan into the Constellation Software, Inc. Retirement Savings Plan on February 28, 2023. The Company believes that no other significant transactions have occurred that would have a material impact on the Plan's financial position and results of operations as of December 31, 2022.

INDEPENDENT AUDITOR'S REPORT

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

Note A - Description of Plan

The following brief description of the Mid America Computer Corporation (Company) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General.** The Plan is a defined contribution plan covering all full-time employees of the Company who have at least 6 months of eligible service and attained 20 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The associated companies of the controlled group of corporations participating in the Plan are Mid America Computer Corporation and EnSite, Incorporated. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

**Contributions.** Each year, participants may contribute up to an amount equal to a dollar amount or percentage of their annual wages before bonuses, based on their Salary Reduction Agreement not to exceed the limits imposed by Code Sections 401(k), 402(g), 404, and 415. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Other additional voluntary contributions are not permitted. Participants direct the investment of their elective deferral and Company matching contributions into various investment options offered by the Plan. Participants may change such allocation at any time directly with the Plan's custodian. The Plan currently offers 27 mutual funds as investment options for participants. The Plan has elected to be a safe harbor plan whereby matching contributions are 100% of the first 3% of any elective contributions plus 50% of any elective contributions in excess of 3% up to 6%.

Effective December 31, 2022, an election was made to freeze the existing plan. Contributions under this Plan are temporarily suspended. No contributions shall be made to the Plan with respect to compensation earned after the date the Plan is frozen.

**Participant Accounts.** Each participant's account is credited with the participant's contributions, any Company matching contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting.** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's safe harbor matching contribution portion of their accounts plus actual earnings thereon is 100%.

**Payment of Benefits.** On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or partial payments. Accounts can be either paid in cash or directly rolled into another qualified plan or into an individual retirement account. For terminated participants whose account is less than \$1,000, plan provisions provide for an automatic payout to the participant. For terminated participants whose account balance is between \$1,000 and \$5,000, plan provisions provide for an automatic rollover into an individual retirement account. The plan also allows for in-service withdrawals under certain circumstances, including withdrawals after age 59-1/2, after age 72, after normal retirement age (65), of rollover contributions, for participants performing qualified military service or qualified reservist distributions. For calendar years after 2019, under the CARES Act legislation, any plan participant that met certain criteria of being affected by COVID-19 could take a withdrawal from the plan.

Note B - Summary of Significant Accounting Policies

**Basis of Accounting.** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates.** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note C for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits.** Benefits are recorded when paid.

**Operating Expenses.** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of investments within participant accounts and distributions from participants accounts are charged directly to the participant's account and are included in administrative expenses.

Note C - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Money market accounts and mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of these investments, the investment adviser reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note F - Related Party Transactions

Certain plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Investments is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services and withdrawal requests to Fidelity Management Trust Company amounted to \$80,123 and \$92,648, respectively for the years ended December 31, 2022 and 2021.

The plan sponsor, Mid America Computer Corporation, absorbs most of the operating and administrative costs of the plan other than those disclosed above.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note G - Income Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

Note H - Risks and Uncertainties

The Plan provides for investments in mutual funds and a common collective trust. Investment securities are exposed to various risks including, but not limited to, interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note I - Subsequent Events

The Company has evaluated all subsequent events through September 25, 2023, the date the financial statements were available to be issued. On January 13, 2023, the Board of Directors of N. Harris Computer Corporation, a controlling party of Mid America Computer Corporation, approved the merger of this Plan into the Constellation Software (USA) Inc. Retirement Savings Plan, effective February 28, 2023. As result, all accounts for acquired participants who are still actively employed at the end of December were spun-off from the MACC Retirement Plan into the Constellation Software, Inc. Retirement Savings Plan on February 28, 2023. The Company believes that no other significant transactions have occurred that would have a material impact on the Plan's financial position and results of operations as of December 31, 2022.
