#### Note 1. Description of the Plan

The following description of the Sanderson Farms, Inc. and Affiliates 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a safe-harbor, defined contribution plan for all employees of Sanderson Farms, LLC (formerly, Sanderson Farms, Inc.) and its affiliated companies (collectively, the "Company") who are 21 years of age or older and have been employed by the Company for 90 days. Upon reaching eligibility requirements, participants may make elective deferrals. Participants become eligible for matching contributions on November 1<sup>st</sup> or May 1<sup>st</sup> following the completion of one year of service and reaching age 21. The Plan is subject to the provisions of the Employee Retirement Security Income Act of 1974 ("ERISA").

##### Plan Merger

The Wayne-Sanderson Farms 401(k) Retirement Plan Committee, as authorized by the Board of Directors of Wayne-Sanderson Farms, LLC, which includes Sanderson Farms, LLC (formerly, Sanderson Farms, Inc.), the Plan's sponsor, voted on October 20, 2022 to merge the Plan into the Wayne-Sanderson Farms 401(k) Retirement Plan (the "WSF Plan") effective December 30, 2022. The majority of Plan assets were transferred to the WSF Plan on January 3, 2023. The remaining assets were transferred to the WSF Plan by March 21, 2023.

##### Contributions

Participants may elect to contribute up to 50 percent of pretax annual compensation to their accounts. The Company is required to match 100 percent of the participant's contribution up to 3 percent of compensation and 50 percent of the participant's contribution above 3 percent up to 5 percent of total compensation for the participant. These contributions are nonforfeitable and subject to withdrawal restrictions. Contributions cannot exceed the limitations established by the Internal Revenue Code (the "Code").

Upon enrollment in the Plan, a participant may direct contributions to any of the investment options offered by the Plan. Participants can change investment options at any time.

##### Vesting

Participants are immediately vested in their contributions and the Company's matching contributions plus actual earnings thereon.

##### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings and losses and is charged with an allocation of administrative expenses to the extent such expenses are paid by the Plan. Allocations are based on participant earnings or account balances, as defined.

##### Notes Receivable from Participants

Participants may borrow from their account a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Note terms range from one to five years or up to 15 years for the purchase of a primary residence. The notes receivable are collateralized by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. As of October 31, 2022 and 2021, the interest rates on outstanding notes receivable from participants ranged from 4.25 to 7.25 percent and from 4.25 to 9.25 percent, respectively. Principal and interest is paid ratably through weekly/monthly payroll deductions.

##### Payment of Benefits

Upon termination of service, retirement, death or disability, a participant may receive a lump-sum amount equal to the value of his or her account.

#### Note 2. Significant Accounting Policies

##### Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Administrative Expenses

Certain Plan expenses are paid by the Company on behalf of the Plan. Expenses paid by the Plan relate to termination distributions, in-service withdrawals and loan establishments.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

##### Payment of Benefits

Benefits are recorded when paid.

#### Note 3. Information Certified by Charles Schwab Trust Bank

Certain information related to investments disclosed in the accompanying financial statements at October 31, 2022 and 2021, investments in the supplemental schedule of assets (held at end of year) at October 31, 2022 and net depreciation in fair value of investments and dividend and interest income for the period from November 1, 2022 through March 21, 2023 (the "period ended March 21, 2023") and year ended October 31, 2022, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the trustee of the Plan (the "Trustee").

#### Note 4. Income Tax Status

The Plan has adopted a volume submitter plan whose sponsor obtained its latest advisory letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The volume submitter plan has been amended since receiving the advisory letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification ("ASC") Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2022 and 2021.

*Mutual funds* (Level 1): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Sanderson Farms, Inc. common stock* (Level 1): Valued at the closing price reported on the active market on which the security is traded.

*Collective investment trust*: Valued based on NAV of units of the common investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As a result of the Plan merger discussed in Note 1 to the financial statements, there were no Plan assets as of March 21, 2023.

**Note 6. Related Party Transactions and Party-In-Interest Transactions**

Certain Plan investments are invested in the common stock of the Company. Investment transactions in employer securities qualify as exempt party-in-interest transactions. For the period ended March 21, 2023 and the year ended October 31, 2022, dividends of \$0 and \$11,435 were received by the Plan from the Company, respectively.

Certain Plan investments are cash, mutual funds, corporate stock and a collective investment trust managed by the Trustee; therefore, these transactions qualify as exempt party-in-interest transactions. For the period ended March 21, 2023 and the year ended October 31, 2022, the Plan paid \$276,162 and \$767,352 to Milliman, Inc., the custodian of the Plan, respectively. As Milliman, Inc. is a service provider to the Plan, these transactions qualify as exempt party-in-interest transactions. Plan expenses paid by the Company on behalf of the Plan qualify as exempt party-in-interest transactions.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Subsequent Events**

The Plan has evaluated subsequent events through September 29, 2023, the date the financial statements were available to be issued.
