## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator, Participants and Beneficiaries of the LifeSchool of Dallas 403(b) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of LifeSchool of Dallas 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 15, 2022 (in liquidation) and December 31, 2021 (in liquidation), and the related statement of changes in net assets available for benefits for the final period January 1, 2022 through December 15, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 15, 2022 and December 31, 2021, and for the final period January 1, 2022 through December 15, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting***

As further discussed in Note A and B to the financial statements, the governing body of LifeSchool of Dallas, approved to terminate the Plan effective August 20, 2021, and management determined liquidation is imminent. As a result, the Plan has changed to the liquidation basis of accounting for the final period January 1, 2022 through December 15, 2022 and year ended December 31, 2021 and no further contributions were made to the Plan and non-vested participants became 100% vested. The benefits held under the Plan were distributed to the participants as of December 15, 2022. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## Notes to Financial Statements December 15, 2022 and December 31, 2021

### NOTE A - DESCRIPTION OF THE PLAN

The following description of the LifeSchool of Dallas 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### [1] General:

The Plan was a defined contribution plan covering all full-time employees of Life School of Dallas, Inc. (the "School") who have attained the age of eighteen years. Pursuant to a board resolution and an amendment executed September 15, 2021, the Plan was terminated effective August 20, 2021. As of the effective date of the Plan termination, all participant contributions ceased and all Plan participants became fully vested. The benefits under the Plan was distributed as of December 15, 2022.

#### [2] Contributions:

Participants were able to contribute up to 100% of pre-tax and after-tax annual compensation, as defined by the Plan. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Special code section 403(b) catch-up contributions were permitted if a participant had 15 years of service with the same employer ("15 years of service catch-up"). The 15 years of service catch-up enabled the limit on elective deferrals to a participant's account to be increased by up to \$3,000 in any year up to a maximum of \$15,000. In no event could participant pre-tax and after-tax contributions exceed any statutory limitations. Participants could have also contributed amounts representing distributions from other qualified defined benefit or contribution plans.

The School could have made matching contributions up to 100% of each participant's contribution to the Plan during the Plan year to all participants who completed at least 500 hours of service during the Plan year, have attained the age of twenty-one years, and are employed on the last day of the Plan year. The School could have made annual discretionary contributions to each participant's account who completed at least 1,000 hours of service during the Plan year, attained the age of twenty-one years, and were employed on the last day of the Plan year. During the final period January 1, 2022 through December 15, 2022, the School did not make any matching or discretionary contributions to the Plan. Participants directed the investment of participant and employer contributions into various investment options offered by the Plan.

#### [3] Participant accounts:

Each participant's account was credited with the participant's contribution and allocations of (a) the School's contributions and (b) Plan earnings, (losses) and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### [4] Vesting:

Participants were fully vested in their contributions, plus actual earnings thereon. Prior to the Plan termination, the School's matching and discretionary contribution portion of their accounts, plus actual earnings thereon, was as follows:

As of the termination date, all non-vested participants were 100% vested.

#### **NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)**

##### **[5] Notes receivable from participants:**

Notes receivable from participants were measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants were able to borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years; however, terms may have exceeded five years for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bear interest at a rate of prime plus 2%, as defined. Interest rates on outstanding loan balances ranged from 4.25% to 8.5% at December 31, 2021. Principal and interest were paid ratably through payroll deductions. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the Plan document. Related fees were recorded as administrative expenses and are expensed when they are incurred.

##### **[6] Payment of benefits:**

Upon termination of service due to death, disability, or retirement, a participant was able to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant was able to receive the value of the vested interest in his or her account as a lump-sum distribution. Participants were able take in-service withdrawals and those who met certain requirements could also take hardship distributions.

##### **[7] Forfeitures:**

Forfeited non-vested accounts were able to be used to reduce future School contributions and pay Plan expenses. During the year ended December 31, 2021, forfeitures of \$633, which included earnings thereon, were used to pay Plan expenses. Forfeited non-vested accounts available at December 15, 2022 and December 31, 2021 was \$-0-.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **[1] Basis of accounting:**

As a result of the Plan termination effective August 20, 2021, the financial statements for the final period January 1, 2022 through December 15, 2022 and year ended December 31, 2021 were prepared under the liquidation basis of accounting. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

##### **[2] Subsequent events:**

The Plan has evaluated subsequent events through October 2, 2023, the date the financial statements were available to be issued.

##### **[3] Investment valuation and income recognition:**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### [4] Payment of benefits:

Benefits were recorded when paid.

##### [5] Plan expenses:

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in the net depreciation of fair value of investments.

##### [6] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, American United Life Insurance Company, has certified the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 15, 2022 and December 31, 2021, and the statement of changes in net assets available for benefits for the final period January 1, 2022 through December 15, 2022.

#### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's Accounting Standards Codification section 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term; the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)**

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2021.

*Pooled separate accounts* – Valued at net asset value (“NAV”), as a practical expedient, based on the market value of the underlying investments. The net asset value is not a publicly quoted price in an active market. The pooled separate accounts are comprised of a wide variety of underlying investments such as equities, preferred stock, bonds, real estate and mutual funds.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE E - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2013, the Plan entered into a benefit-responsive guaranteed investment contract with American United Life Insurance Company. American United Life Insurance Company maintains the contributions in a general account. The contract is reported at contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by American United Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

#### **NOTE E - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than three percent. The crediting rate is reviewed on a quarterly basis and will earn the declared rate until the end of the calendar year next following the current year. At the end of the calendar year next following the current year, the quarterly rates are converted to an annual interest rate, which is then adjusted on an annual basis. No more than 20% of a participant's balance invested in the AUL Fixed Account may be transferred during the year, unless the balance is less than \$2,500, in which case the entire amount may be transferred during the Plan year.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The Plan was terminated effective August 20, 2021 and all of the Plan assets were distributed as of December 15, 2022.

#### **NOTE F - TAX STATUS**

The Plan had been designed under Section 403(b) of the Internal Revenue Code (the "Code"). The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b). The Plan administrator believes that the Plan was designed and operating in accordance with the applicable requirements of Section 403(b) of the Code and, therefore, believes the Plan was qualified and the related accounts tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 15, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### **NOTE G - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments are in an insurance contract and pooled separate accounts managed by American United Life Insurance Company. American United Life Insurance Company is the Plan's insurance company. Therefore, transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan were \$16,661 for the period ended December 15, 2022.
