We have performed audits of the financial statements of Momentum Glass 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Emphasis of Matter

As further discussed in Note 1 to the financial statements, on January 3, 2023, the Employer resolved to terminate the Plan effective December 14, 2022. As a result, the Plan changed its basis of accounting from the ongoing plan basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Management's Responsibilities for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events that, considered in the aggregate, raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Notes to the Financial Statements December 31, 2022 (in Liquidation) and 2021 (Ongoing)

Note 1 – Plan Description

The following description of the Momentum Glass 401(k) Plan (the “Plan”) provides only general information. Momentum Exterior Systems, LLC. (“Company” or “Employer”) is the Plan Sponsor. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

Plan Termination

The Employer resolved to terminate the Plan effective December 14, 2022 (“termination date”), and to distribute Plan assets as soon as administratively feasible. Effective December 14, 2022, the Plan ceased all contributions. The nonvested portion of all participant accounts were fully vested upon the termination date. All Plan participants received an account closing distribution of their account balances based on their distribution election. Distributions were requested in lump sum cash distribution or as a direct rollover to an Individual Retirement Account (“IRA”) or other qualified retirement plan. As of December 31, 2022, the distribution of Plan assets was not complete, and the trust was not fully liquidated and terminated.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of the Employer. The Plan commenced effective January 1, 2018, and was amended and restated effective January 1, 2022, to comply with the latest rules and regulations. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodian and Trustee

CMFG Life Insurance Company (“CMFG” or “Custodian”) is the Plan Custodian maintaining custody of all investments held by the Plan, maintaining the Plan’s participant account balances, and providing record-keeping services to the Plan. Among other duties, the Custodian receives contributions, holds, and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. Certain principals and executive officers of the Company serve as Trustees of the Plan.

Eligibility and Plan Entrance Date

All employees of the Company are eligible to participate in the Plan after the employee has completed two months of service. The Plan entry date is the first day of the Plan year quarter coinciding with or next following the date the eligibility requirements are met.

Contributions

The Plan permits eligible employees to contribute, on a pre-tax or Roth basis, up to 100% of eligible compensation, as defined by the Plan, through payroll deductions. Participant contributions are subject to certain limitations under the IRC, and each participant’s annual contribution shall not exceed the maximum permitted deferral amount, which was \$22,500 for 2022. Participants who have attained age 50 before the end of the Plan year are eligible to make additional annual catch-up contributions of up to the maximum amount permitted annually under the IRC, which was \$6,500 for 2022.

Note 1 – Plan Description (continued)

Contributions (continued)

Rollover contributions may also be accepted by the Plan on behalf of participants from other plans qualified under Section 401(a) of the IRC, provided that such rollover contributions are approved by the Plan's Administrator.

The Plan provides for Employer Safe Harbor matching contributions. For the 2022 Plan year, the Employer made Safe Harbor matching contributions to the Plan on behalf of participants in an amount equal to 100% of participants' elective contributions, up to a maximum of 4% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's and the Company's contributions and allocations of Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and Employer Safe Harbor contributions plus actual earnings thereon.

Participant Directed Investments

All assets of the Plan are participant directed investments. Participants have the option of directing their account balances to one or more investment options offered by the Plan. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. The options vary in types of investments, rates of return, and investment risk.

Payment of Benefits

The payment of benefits from each account may occur upon attaining age 59 ½, retirement, disability, death, or termination of employment. Upon normal or early retirement, disability, or death, a participant is entitled to receive 100% of their account balance. Under the Plan, normal retirement is defined as age 65. Upon termination, participants or beneficiaries are entitled to receive the vested portion of their account balance. Benefits may be paid in lump sum or installments, equal to the vested value of the participant's account. In addition, financial hardship withdrawals are permitted by the Plan for those participants who have incurred a substantial financial hardship. Vested account balances of less than \$5,000 are immediately distributable in a lump sum under the terms of the Plan without the participant's consent.

Pursuant to the Setting Every Community Up for Retirement Enhancement ("SECURE") Act enacted in December 2019, the age at which required minimum distributions must begin was increased from 70½ to 72.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

Effective December 14, 2022, a decision was made to terminate the Plan. As a result, the 2021 financial statements have been prepared on the ongoing basis, and the 2022 financial statements have been prepared on the liquidation basis of accounting in conformity with the accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan’s gains and losses on investments bought and sold, as well as, held during the year.

Payments of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 25, 2023, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021:

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within level 1 of the fair value hierarchy.

The Plan’s independent auditor did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

Note 5 – Exempt Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by the Custodian as an agent of the Plan. These transactions thus qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

Note 6 – Tax Status

The Plan adopted a volume submitter profit-sharing plan (the “Volume Submitter Plan) sponsored by Cuna Mutual Insurance Society. The Internal Revenue Service (“IRS”) has determined and informed the Volume Submitter Plan sponsor by letter dated June 30, 2020, that the Volume Submitter Plan is designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS for a letter regarding the Plan’s qualified tax status, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC, and as such, believes the Plan is qualified and that the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2019.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 – Prohibited Transactions

The Company failed to remit to the Plan's Trustee certain participant contributions totaling \$53,782 and \$29,480 for the years ended December 31, 2022 and 2021, respectively, within the period prescribed by the DOL's Rules and Regulations. Delays in remitting contributions to the Trustee were due to unintentional administrative errors. During 2022, the Company corrected contributions to the affected participants' accounts to compensate those participants for potential lost earnings due to the delays.
