### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Guaranteed Rate, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit (ERISA Section 103(a)(3)(C)). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

As discussed in Notes A and G to the financial statements, the Plan was merged with and into the Rate Holdings Corp. Multiple Employer 401(k) Plan as of December 31, 2022, and ceased to exist as a separate plan as of that date. Our opinion is not modified with respect to this matter.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**A. DESCRIPTION OF PLAN**

The following description of the Guaranteed Rate, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a complete description of the Plan's provisions.

**1. General**

The Plan is a defined contribution plan covering substantially all employees of Guaranteed Rate, Inc. (the Company) who have three months of service and are age 21 or older. The original Plan was established effective January 1, 1998 by the Company for the benefit of its employees and the employees of any affiliated employer to qualify under Section 401(k) of the Internal Revenue Code (IRC). The Plan was amended and restated on January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The internal trustee and Company management are responsible for oversight of the Plan. The investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's internal trustee.

**2. Plan Merger**

Effective December 31, 2022, all contributions to the Plan were suspended as the Plan was merged into the Rate Holdings Corp. Multiple Employer 401(k) Plan.

**3. Partial Termination of the Plan**

As a result of reduction in force, as discussed in Note F, the Plan sponsor determined that a partial termination of the Plan occurred in 2022. All affected Plan participants are to be fully-vested in their account balances as a result of the partial plan termination.

**4. Contributions**

Each year, participants may contribute pre-tax and qualified Roth deferrals to the Plan up to 92% of annual eligible compensation, as defined in the Plan documents. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The deferral rate will increase annually by 1% of compensation, up to a maximum of 6%. The Company may elect to make discretionary matching contributions and discretionary nonelective contributions each year. For the Plan year ending December 31, 2022, the Company matched the lesser of 3% of the participant's total compensation or 50% of the participant's deferrals, with a maximum match contribution of \$3,000 per participant. Participants must be employed at the plan year end to receive employer discretionary match contributions. The Company did not make any discretionary nonelective contributions for the year ended December 31, 2022. Contributions are subject to certain Internal Revenue Service (IRS) and Plan limitations.

**A. DESCRIPTION OF PLAN (Continued)**

**5. Participant Accounts**

Each participant's account is credited with the participant's contribution and the Company's discretionary matching and discretionary nonelective contributions, as well as allocations of the Plan's earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**6. Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after four years of credited service.

**7. Notes Receivable from Participants**

Participants may borrow from their accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participants' accounts. The loan interest rate will be at the Prime rate plus 1.00%. Principal and interest is paid ratably through monthly payroll deductions.

**8. Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or installment payments over a specified period of time (annually, quarterly or monthly), not exceeding the participant's life expectancy or joint life expectancy with their designated beneficiary, or as part lump sum and pass-through installment payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**9. Forfeited Accounts**

At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$0 and \$716,874, respectively. All forfeited balances transferred to Rate Holdings Corp. Multiple Employer 401(k) Plan as of December 31, 2022. These accounts are to be used to pay future Plan expenses or meet future employer contribution obligations. During 2022, employer contributions were reduced by \$817,719 from forfeited non-vested accounts.

**10. Transfers to the Plan**

During 2022, participants transferred amounts totaling \$45,586,789 to the Plan from Guaranteed Rate Affinity, LLC 401(k) Plan and Stearns Lending 401(k) Plan, which is reflected as transfer of assets to the Plan on the statement of changes in net assets available for benefits.

**11. Transfers Out of the Plan**

During 2022, participants account balances totaling \$307,483,227 were transferred from the Plan into Rate Holdings Corp. Multiple Employer 401(k) Plan. Transferred amounts are reflected as transfer of assets out of Plan on the statement of changes in net assets available for benefits.

**B. SUMMARY OF ACCOUNTING POLICIES**

**1. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting. Certain adjustments have been made to the financial statements in order for them to conform to the accrual basis of accounting.

**2. Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and changes therein, and disclosure of contingent assets. Actual results could differ from those estimates.

**3. Investment Valuation and Income Recognition**

The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**4. Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees were recorded as administrative expenses on the statement of changes in net assets available for benefits and are expensed when incurred.

**5. Payments of Benefits**

Benefits are recorded when paid.

**6. Expenses**

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses on the statement of changes in net assets available for benefits. Investment related expenses are included in net depreciation in fair value of investments on the statement of changes in net assets available for benefits.

**C. CERTIFIED INVESTMENT INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplementary information, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments, dividends, interest income on notes receivable from participants, and other income for the year ended December 31, 2022, were obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company (the Trustee).

**D. FAIR VALUE MEASUREMENTS**

Financial Accounting Standard Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement* (ASC 820), defines fair value as the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not assumptions specific to the entity.

ASC 820 specifies a hierarchy of valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon the market data obtained from independent sources (observable inputs). In accordance with ASC 820, the following summarizes the fair value hierarchy:

Level 1 – Unadjusted quoted market prices for identical assets in an active market that the Plan has the ability to access.

Level 2 – Inputs other than the quoted market prices in active markets that are observable either directly or indirectly.

Level 3 – Inputs based on prices or valuation techniques that are unobservable and significant to the overall fair value measurements.

ASC 820 requires the use of observable market data, when available, in making fair value measurements. When inputs used to measure fair value fall within different levels of the hierarchy, the level within which the fair value measurement is categorized is based on the lowest level input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

While the Plan believes its valuation methods are appropriate and consistent with those used by other market participants, the use of different methods or assumptions to estimate the fair value of certain financial statement items could result in a different estimate of fair value at the reporting date. Those estimated values may differ significantly from the values that would have been used had a readily available market for such items existed, or had such items been liquidated, and those differences could be material to the financial statements.

**D. FAIR VALUE MEASUREMENTS (Continued)**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021. There were no assets measured at fair value as of December 31, 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective funds:* Valued at the NAV of units held. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**E. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as risk of foreign currency fluctuations relative to the U.S. Dollar, interest rate risk, credit risk, issuer going concern risk, and overall market volatility. During the year ended December 31, 2022, the net depreciation in fair values of investments totaled approximately \$66.8 million. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Coronavirus Aid, Relief, and Economic Security Act (CARES Act) contains various provisions impacting qualified retirement plans and their participants. These provisions may be adopted by plans immediately while implementing amendments at a later date. Where amendments to the Plan would be required, the CARES Act permits employers to formalize the amendments as late as last day of the plan year beginning on or after January 1, 2022. All such amendments will be retroactively effective to March 27, 2020, or a later stated effective date.

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 was signed into law. The SECURE 2.0 Act contains provisions designed to make retirement plans more accessible to employees and less complicated for employers to establish and administer. While plan amendments are not required immediately, they must be adopted by the end of the first plan year beginning on or after January 1, 2025.

**F. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Plan sponsor determined that a partial plan termination of the Plan occurred in 2022. All affected Plan participants were fully vested in their account balances as a result of the partial plan termination.

**G. PLAN MERGER**

Effective December 31, 2022, the Plan merged into the Rate Holdings Corp. Multiple Employer 401(k) Plan. Plan assets were transferred to the trustee of the Rate Holdings Corp. Multiple Employer 401(k) Plan subsequent to the plan merger.

**H. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments were managed by the Trustee and therefore these transactions qualify as party-in-interest transactions.

Effective March 26, 2021, the Trustee provides certain administrative services to the Plan pursuant to a Master Services Agreement (MSA) between the Company and the Trustee. The Trustee receives revenue from mutual fund service providers for services the Trustee provides to the funds. This revenue is used to offset certain amounts owed to the Trustee for its administrative services to the Plan.

If the revenue received by the Trustee from such mutual fund service providers exceeds the amount owed under the MSA, the Trustee remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2022 there were no excess amounts. The Plan or the Company may make a payment to the Trustee for administrative expenses not covered by revenue sharing.

Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of investments on the statement of changes in net assets available for benefits, as they are paid through revenue sharing, rather than direct payment. The Company pays directly any other fees related to the Plan's operations. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

The Company pays certain Plan accounting and administrative fees. The Company incurred \$208,105 for accounting and administrative fees during the year ended December 31, 2022. These fees are not reflected in the accompanying financial statements.

**I. TAX STATUS**

The Plan uses a prototype plan document sponsored by T. Rowe Price Retirement Plan Services Inc. (T. Rowe). T. Rowe received an opinion letter from the IRS, dated August 19, 2020, which states the prototype document satisfies the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the prototype plan received a determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
