INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of
Equitrans Midstream Corporation Comprehensive Welfare Plan for Retirees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Equitrans Midstream Corporation Comprehensive Welfare Plan for Retirees (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits and of changes in benefit obligation for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of assets (held at end of year) and schedule of reportable transactions as of and for the year ended December 31, 2022 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Equitrans Midstream Corporation Comprehensive Welfare Plan for Retirees (the Plan) provides only general information. Participants should refer to the Plan document and the summary plan descriptions for a complete description of the Plan's provisions. If any statement in this description is inconsistent with the terms of the Plan document, the Plan document will control.

General - Equitrans Midstream Corporation (the Company) adopted the Plan on November 13, 2018, upon the spin-off of the Company from EQT Corporation (EQT) and the Company's assumption of specific retiree benefit obligations and liabilities that were transferred by EQT out of the EQT Corporation Comprehensive Welfare Plan for Retirees (Retiree Plan of EQT) and into the Plan. The Plan generally permits eligible retired Company employees and certain retired employees of predecessor companies, as well as their eligible spouses, and their dependents to choose benefits from among those provided under the Plan.

In connection with the Company's assumption of these retiree benefit obligations and liabilities, the Company also assumed sponsorship of a voluntary employees' beneficiary association (VEBA) trust, which is a tax-exempt trust, that was originally adopted by EQT and which held assets that funded certain of the assumed obligations and liabilities. Pursuant to a Federal Energy Regulatory Commission (FERC) settlement order, the Company is obligated to make annual contributions to the VEBA trust.

The Plan is governed by the Plan document, which has been amended and restated effective January 1, 2022, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). From the period February 18, 2020 through December 26, 2022, the VEBA trust was governed by a certain amended and restated VEBA trust agreement effective February 18, 2020, between the Company and BNY Mellon, as the trustee. Effective December 27, 2022, the VEBA trust is governed by a certain VEBA trust agreement, between the Company and PNC Bank, as the trustee.

Eligibility - Eligible participants are retirees, their spouses and/or their dependents as defined in the Plan document. Participants must (i) have been participating in the Retiree Plan of EQT prior to the Plan's effective date, and have had their retiree benefits transferred from EQT to the Company in connection with the spin-off, or (ii) be retirees of the Company who worked full-time or part-time I and are age 55 and attained five years of service. Part-time I employees were scheduled to work at least 20 hours, but less than 35 hours each week.

In general, participants who retired or were terminated from EQT (prior to the spin-off) or the Company after January 1, 2015 are not eligible for health benefits (medical, vision, dental and prescription drugs) or life insurance benefits under the Plan. They are only eligible for the Medical Spending Account (MSA) described below.

Benefits - The Plan provides health benefits (medical, vision, dental and prescription drugs) and life insurance benefits. The Plan fully insures the health and life insurance benefits. The Company purchases annual insurance contracts for these insured benefits. Premiums are paid to the service providers from participant contributions and either the general assets of the Company or the VEBA trust, as applicable.

The Plan has an MSA that is funded solely through Company contributions. The MSA allows eligible participants to be reimbursed tax-free for qualified medical expenses subject to a specified ceiling. Amounts remaining at the end of the year can generally be carried over to the next year. The employer is not permitted to refund any part of the balance to the employee. The account cannot be used for anything other than reimbursements for qualified medical expenses either through a Company group health plan or another source of coverage.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Effective January 1, 2021, the Company adopted the Equitrans Midstream Corporation Health Reimbursement Account Plan for Eligible Retirees (HRA Plan), which plan is available to a frozen group of retirees and certain covered spouses of retirees. Under the terms of the HRA Plan, the Company will make a credit annually to a health reimbursement account on behalf of the participants. Participants may be reimbursed from their health reimbursement account for the cost of healthcare coverage and/or for other eligible health expenses. Unused amounts remaining at the end of the year will not be carried over to the next year.

Effective January 1, 2021, the Plan was amended to terminate the Early Retiree PPO Medical Plan program option. The HRA Plan described above was introduced to replace the Early Retiree PPO Medical Plan.

Contributions - In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The costs of the postretirement benefit plan premiums are shared by the Company and participants. The Plan document provides a limit on Company contributions that is described as the "Capped Amount" for participants who receive medical/prescription drug, dental and vision coverage. These amounts are subject to change by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan Administrator in the preparation of the accompanying Statements of Net Assets Available for Benefits and related Statement of Changes in Net Assets Available for Benefits, Statements of Benefit Obligations and Statement of Changes in Benefit Obligations (financial statements) follows:

Basis of Accounting - The Plan prepares the financial statements on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Cash - The Plan's cash is maintained with one financial institution. Deposits at this bank may exceed federally insured amounts at times.

Premiums Paid - Premiums paid by either the Company or the VEBA trust are recorded as premium payments in the accompanying Statements of Changes in Net Assets Available for Benefits.

Payment of Claims - Reimbursements of qualified medical expenses through the MSA and HRA are paid by the Company and are recorded as claims paid in the accompanying Statement of Changes in Net Assets Available for Benefits.

Valuation of Investments and Income Recognition - The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis.

Actuarial Present Value of Accumulated Plan Benefits - Accumulated plan benefits are those future periodic payments, including benefits expected to be paid to or for currently retired participants and their dependents.

Medicare Subsidy - The Plan's postretirement benefit obligation does not reflect an amount associated with the Medicare subsidy allowed under the Medicare Prescription Drug Improvement and Modernization Act of 2003 because the Plan is not directly entitled to the Medicare subsidy. The Company has included the effects of the Medicare subsidy in measuring its postretirement benefit obligation; therefore, the Plan's postretirement benefit obligation differs from that of the Company.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. The Plan pays administrative expenses that consist primarily of third-party administrative and professional fees. These fees are reported as administrative expenses in the accompanying Statement of Changes in Net Assets Available for Benefits.

Subsequent Events - Management has evaluated subsequent events for the Plan through September 29, 2023, the date the financial statements were available to be issued.

NOTE 3 - POSTRETIREMENT BENEFIT OBLIGATIONS

A postretirement benefit obligation has been recognized for retiree medical benefits for eligible participants and their dependents upon retirement. This benefit obligation represents the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligations represent the amounts that are expected to be funded by contributions from the Company and from existing assets of the Plan. Postretirement benefits include future benefits expected to be paid to or for (a) currently retired or terminated employees and their beneficiaries and dependents, and (b) active employees and their beneficiaries and dependents after retirement from service with the Company.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

For postretirement benefit obligation as of December 31, 2022 measurement purposes, a 7.00% average annual rate of increase in the average per capita cost of covered health care benefits was assumed; the rate was assumed to decrease gradually to 5.00% for 2031 and to remain at that level thereafter. For postretirement benefit obligation as of December 31, 2021 measurement purposes, a 6.25% average annual rate of increase in the average per capita cost of covered health care benefits was assumed; the rate was assumed to decrease gradually to 5.00% for 2027 and to remain at that level thereafter.

The weighted-average health care cost trend rate assumption has a significant effect on the amounts reported as postretirement benefit obligations. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2022 and 2021 by \$49,175 and \$46,052, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue and that all current employees who attain retirement eligibility will utilize their benefits under the Plan. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

NOTE 4 - CERTIFIED INVESTMENTS (UNAUDITED)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2022 and 2021, and interest income, for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by BNY Mellon as of December 31, 2021 and for the period from January 1, 2022 through December 26, 2022 and PNC Bank as of December 31, 2022 and for the period from December 27, 2022 through December 31, 2022 (the trustees of the Plan).

NOTE 5 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input used is observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of assets and liabilities within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan uses valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2022 and 2021.

Money Market Funds - Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund is deemed to be actively traded.

NOTE 6 - TAX STATUS

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated April 1, 1996, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. In 2022, an insignificant amount of unrelated business taxable income was recorded.

In addition, the Plan and the VEBA trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the VEBA trust. The Plan administrator believes that the Plan and VEBA trust are being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related VEBA trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the remaining assets of the Plan will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 8 - RELATED-PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

Plan investments were managed by BNY Mellon through December 26, 2022, and PNC Bank thereafter. Additionally, the Plan has arrangements with other service providers for various administrative functions. The costs associated with these transactions are included in administrative expenses in the Statement of Changes of Net Assets Available for Benefits. Therefore, these transactions qualify as party-in-interest transactions under ERISA. Certain administrative functions are performed by officers or employees of the Company at no cost to the Plan.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan, at times, may invest in various investment securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care cost trend rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
