Completion of 5 years of participation from beginning of entry year

**Cash Balance Contribution Credit** The plan provides the following cash balance contribution credits to participants based on their group classification:

The maximum monthly benefit is the lesser of \$20,416.66 and 100% of the highest 3-year average salary, subject to service requirements.

Salary based contribution credits are applied to current compensation.

**Normal Form of Benefit** A benefit payable for the life of the participant

**Accrued Benefit** A fraction, not exceeding one, of the normal retirement benefit, calculated based on average salary on the calculation date. The numerator of the fraction is equal to the participant's credited years earned on the calculation date, and the denominator is equal to the participant's total projected credited years at normal retirement, up to a maximum of 10 credited years.

Credited years are plan years from the first day of the plan year containing date of entry excluding the following:

Years before age 18  
Years with less than 1,000 hours

**Termination Benefit** Upon termination for any reason other than death or retirement a participant shall be entitled to a portion of the actuarial equivalent of his accrued benefit in accordance with the following vesting schedule:
