Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of BioDelivery Sciences International, Inc. 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 6, 2022 (in liquidation) and December 31, 2021 (ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through December 6, 2022 (in liquidation) (“period ended December 6, 2022” or the “Period”), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 6, 2022 and December 31 2021, and for the period ended December 6, 2022, stating that the certified investments information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

As discussed in Note 1 and 6 to the financial statements, the governing body of the Plan approved a Plan liquidation on March 21, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Note 1—Description of the Plan

The following description of the BioDelivery Sciences International, Inc. (the “Company” or “Plan Sponsor”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan was a defined contribution plan covering all full-time employees of the Company. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Termination - During March 2022, the Company was acquired by Collegium Pharmaceutical, Inc. Effective March 21, 2022, the Company approved a plan of termination, and management determined that liquidation was imminent. Final distributions were based on all participants being 100% vested. The investments held by the participants in the Plan were to be liquidated and the participants’ distributions options included rolling the proceeds to another qualified Employer Plan or an Individual Retirement Account or receiving a taxable distribution. As a result, the Plan changed its basis of accounting from the going concern basis used in the presentation of the 2021 financial statements to the liquidation basis used in presentation of the 2022 financial statements. All participant accounts were fully liquidated and distributed by December 6, 2022 (the “Termination Date”).

Contributions – Participants could elect to contribute pre-tax or after-tax Roth contributions up to 90% of compensation and dollar amounts permissible under the Internal Revenue Code (“IRC”) not to exceed certain limits. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. All contributions were participant directed and were subject to certain Internal Revenue Service (“IRS”) limitations.

The Company made non-discretionary matching-employer contributions where the Company matched 100% of the first 5% of employee deferrals. The Company contributed \$383,951 in total employer-matching contributions for the period ended December 6, 2022.

Eligibility – Each employee must attain two months of service as defined in the Plan document, reach 21 years of age, and must not be a part-time employee with less than 1,000 hours to participate in the Plan. Eligible participants may enter the Plan immediately upon satisfying the eligibility requirements.

Participant Accounts – Each participant’s account was credited with the participant’s contributions, including any rollover amounts from qualified plans and allocations of (a) non-discretionary, employer matching, and (b) Plan earnings (losses) and charged with benefit payments and an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined.

Investment of Assets – Participants directed their contributions and the Plan Sponsor’s contributions to one or more investment options provided by the Plan. Participant accounts were segregated for the purpose of determining the gains or losses on investments. Participants could change their investment options at any time throughout the year via direct phone and internet access to the third-party administrator. The Plan’s Board of Trustees was responsible for oversight of the Plan and determined the appropriateness of the investment offerings and monitored investment performance.

Vesting – Participants were vested immediately in their voluntary contributions, plus actual earnings thereon. The Plan allowed participants to become 100% vested in employer-matching contributions immediately when received.

Note 1—Description of the Plan (continued).

Notes Receivable from Participants – Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bore interest at a rate of 4.25% to 6.50%, which was determined based on the rates available for similar loans from commercial lending institutions. Principal and interest were paid ratably through bi-weekly payroll deductions. Participant loans must be repaid within a period of five years, unless such loan was for the purchase of the participant's primary residence, in which case loan repayment could be in excess of five years.

Payment of Benefits – Upon termination of service, retirement, death, disability, or a proven financial hardship, a participant could receive a lump-sum payment equal to the vested value of their account. Upon separation of service, a participant with a vested account balance over \$5,000 could receive the value of the vested interest in his or her account as a lump or partial-sum distribution. For participants who separate with account balances of more than \$1,000 but less than \$5,000, the Plan Sponsor could direct a participant's fund to an Individual Retirement Account established in the participant's name. Any participant vested account balances under \$1,000 would be paid out as a lump-sum distribution upon separation. Participants could also take distributions prior to termination of employment if the participant had attained age 59½. For amounts withdrawn under financial hardship prior to age 59½, certain income tax penalties could apply.

Forfeitures – When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represented a forfeiture. Forfeited nonvested accounts could be used to reduce administrative expenses for the Plan or to reduce employer-matching contributions. During the period ended December 6, 2022, forfeitures of \$5 were used to reduce employer contributions and forfeitures of \$13,426 were used to reduce plan expenses. At December 6, 2022 and December 31, 2021, forfeited nonvested accounts had balance of \$-0- and \$5, respectively.

Plan Administration – BioDelivery Sciences International, Inc. was the Plan administrator. Fidelity Management Trust Company served as the "Trustee" of the Plan.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") as of December 31, 2021. As discussed in Note 1, the Plan changed its basis of accounting from the going concern basis used in the presentation of the 2021 financial statements to the liquidation basis used in presentation of the 2022 financial statements.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts in the financial statements and the accompanying notes. Actual results could differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants is measured at their principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowances for credit losses have been recorded as of December 6, 2022 and December 31, 2021. Loans are considered to be in default and uncollectible by the Plan if any scheduled loan repayments are not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. (See Note 4 – *Fair value measurements*.)

Note 2—Summary of significant accounting policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period ended December 6, 2022.

Fair Value Measurements – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

U.S. GAAP describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan uses appropriate valuation methodologies based on the available inputs to measure the fair value of its investments. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Registered Investment Companies – These investments are public investment vehicles valued using the net asset value ("NAV") provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

Money Market Fund – These investments are generally short-term money market funds valued using \$1 for the unit value. The Trustee reports the market and quotes the prices, on a daily basis, that are available to market participants. The investments are valued at amortized cost, which approximates fair value. These are considered Level 2 investments because the inputs used to determine fair value are not quoted prices in an active market.

The Plan believes its valuation method is appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits – Benefits are recorded when paid. As of December 6, 2022 and December 31, 2021, there were no benefit payments requested and not yet disbursed.

Administrative Expenses – As provided by the Plan agreement, administrative expenses related to Plan investments and administration are paid by the Plan, and other administrative expenses are paid by the Plan Sponsor.

Note 3—Information certified by the Plan’s Trustee (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the Trustee, has certified that the following data, included in the accompanying financial statements and supplemental schedule, is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 6, 2022 and December 31, 2021.
- Net depreciation in fair value of investments, interest and dividends, and interest earned on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period ended December 6, 2022.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 5—Party-in-interest transactions

Fees paid by the Plan to the Trustee for recordkeeping services totaled \$38,597 for the period ended December 6, 2022. \$3,321 in fees were paid to the Plan’s investment advisors for the period ended December 6, 2022. These transactions qualify as party-in-interest transactions for which a statutory exemption exists.

Note 6—Plan termination

In 2022, the Company was acquired by Collegium Pharmaceutical, Inc. In connection with the acquisition, the Company approved a plan of liquidation on March 21, 2022. As a result, Plan assets were liquidated. The participants' distribution options included rolling the proceeds to another qualified employer plan or an Individual Retirement Account or receiving a direct taxable distribution.

Note 7—Tax status

The Plan used a standardized prototype plan sponsored by Fidelity Management & Research Company. The IRS had determined and informed Fidelity Management & Research Company by letter dated March 31, 2014, that the prototype document satisfied the applicable sections of the IRC. The Plan itself had not received a determination letter from the IRS and the Plan had been amended since receiving the determination letter. Plan management believed the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes had been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 6, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or an asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
