We have performed audits of the accompanying financial statements of the MTD Products Inc Hourly 401(k) and DC Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 30, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period January 1, 2022 to December 30, 2022 and year ended December 31, 2021, and the related notes to the financial statements.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the MTD Products Inc Hourly 401(k) and DC Retirement Plan (the Plan) is provided for general information purposes. Participants should refer to the plan document for more complete information.

The Plan was a defined contribution savings plan providing benefits for the eligible hourly employees of MTD Products Inc (the Company). The Company was the plan sponsor and administrator. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Reliance Trust Company was the trustee of the Plan as of and for the year ended December 31, 2021. Effective January 1, 2022 Empower Trust Company, LLC became the trustee.

During 2021, Stanley Black & Decker completed an acquisition of the Company. Effective December 30, 2022, the Plan was merged into the Stanley Black & Decker Retirement Account Plan.

Participation

Employees became eligible to participate in the Plan following attainment of age 21 and the completion of 90 days of service. Upon attaining eligibility status, participants were automatically enrolled at a 3% deferral rate unless they elected not to participate or to participate at a different deferral percentage.

Participant Accounts and Contributions

Each participant's account was credited with the participant's contributions, company contributions, and investment fund earnings. Plan participants were permitted to make tax-deferred and/or Roth contributions to the Plan of 1% to 70% of their total compensation up to the maximum amounts allowed under the Internal Revenue Code (IRC).

The Plan provided for safe harbor matching contributions calculated as 100% of participant contributions up to 3% of eligible compensation plus 50% of participant contributions that exceed 3% of eligible compensation but that did not exceed 5% of eligible compensation. In order to qualify for the safe harbor matching contribution, a participant must have completed twelve months of service.

Additionally, following attainment of age 21 and the completion of 12 consecutive months of service under the elapsed time method, the Company made a discretionary contribution to the Plan equal to 4% of the participant's base compensation.

Rollover Contributions

Distributions from another qualified plan were able to be transferred into the Plan.

Investment Options

Participants directed the manner in which their contributions, rollover contributions and employer contributions were allocated among the investment options available under the Plan.

Plan Expenses

The Plan paid certain of the administrative expenses.

Party-in-Interest Transactions

Certain plan investments were managed by and administrative expenses were paid to the custodian of the Plan. These transactions qualified as party-in-interest transactions.

The Plan participated in a plan expense reimbursement account with its custodian whereby funds were received to pay certain administrative fees of the Plan, with excess amounts available for allocation to plan participants. Funds received during the period ended December 30, 2022 and year ended December 31, 2021 totaled approximately \$53,000. During the period ended December 30, 2022 and year ended December 31, 2021, approximately \$45,000 and \$33,000, respectively, of these funds were used to pay plan expenses. During the period ended December 30, 2022 and year ended December 31, 2021, approximately \$16,000 and \$20,000, respectively, was allocated to participants. Any excess funds allocated are reflected as reductions to administrative expenses on the statements of changes in net assets available for benefits.

Vesting

Participants were immediately vested in their contributions and earnings thereon. Through December 31, 2017, vesting in the company contributions and earnings thereon occurred ratably over 5 years of vesting service at which time they would be 100% vested. As a result of a plan amendment, effective January 1, 2018, participants were immediately vested in company contributions and earnings thereon.

Forfeitures

Forfeitures of non-vested account balances were to be used to reduce employer contributions or pay plan expenses. As of December 31, 2021, forfeited non-vested accounts totaled approximately \$74,000. For the period ended December 30, 2022 and year ended December 31, 2021, approximately \$6,000 and \$19,000 of forfeitures were used to offset employer contributions, respectively.

Notes Receivable from Participants

The Plan allowed for eligible employees to borrow from their accounts, a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The interest rate must be a reasonable rate as determined by the Plan administrator. Loans bore interest at the prime rate at the time of issuance plus 1%. Maturities on these loans could not exceed five years. The term could be for any period of time not exceeding 15 years if the purpose of the loan was to acquire the participant's principal residence. A participant could have only one loan outstanding at any given time.

Notes receivable from participants were measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent loans were treated as distributions based upon the terms of the plan document.

Benefit Payments

Upon service or disability retirement, death, termination or financial hardship, the participant or beneficiary could elect to receive a benefit payment. In-service withdrawals were permitted as well, as defined in the Plan. A participant could elect to make a direct rollover, receive a lump-sum amount or periodic payments, subject to the provisions of the Plan. Benefit payments were recorded upon distribution.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Financial Statements

The financial statements are prepared on the accrual basis of accounting.

Investments

Gains and losses on sales of securities were based on the actual cost of securities. Dividend income was recorded on the ex-dividend date. Interest from other investments was recorded as earned.

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As described in Accounting Standards Codification (ASC) 962, *Defined Contribution Pension Plans*, investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Fixed Interest Fund was a fully benefit-responsive investment contract.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (US GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 30, 2022 and December 31, 2021, and net investment gain (loss), interest and dividends, and interest income on notes receivable from participants for the period ended December 30, 2022 and year ended December 31, 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee of the Plan.

4. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2021.

Mutual Funds: Valued at the net asset values of shares held by the Plan at year end.

Pooled Separate Accounts: Valued using the net asset value per share as determined by the trustee. The value is based on a pro rata share of the market value of the underlying investments in the separate account.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan invested in a benefit-responsive investment contract with its custodian. The custodian maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. As described in Note 2, because the guaranteed investment contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the custodian, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer. Such interest rates were reviewed on a quarterly basis for resetting. Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events generally included significant changes in the operation, or investment strategies of the Plan or significant events impacting the plan sponsor. The plan administrator did not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, was probable.

6. FEDERAL INCOME TAXES

The Plan adopted a non-standardized pre-approved profit-sharing plan which received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022, which stated that it is qualified under the appropriate sections of the IRC. The Plan administrator believed that the plan was being operated in compliance with the applicable requirements of the IRC, therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 30, 2022 and December 31, 2021, there were no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS;

however, there are currently no IRS audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

7. SUBSEQUENT EVENTS

Plan management evaluated subsequent events through September 18, 2023, the date which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
