December 31, 2022

1. Description of the Plan

Plan Document

The following description of The MasterCorp, Inc. 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. Copies of this document are available from Mastercorp, Inc.

General

The Plan is a defined contribution plan and is subject to the Employee Retirement Income Security Act of 1974 (ERISA). All employees, excluding non-resident aliens, of Mastercorp, Inc., Sourcemaster, LLC, The Kibo Group, Inc., Mastercorp Commercial Services, LLC, Kibo Holdings, LLC, Clean Concepts Marketing, LLC, and Grindstaff Property Management, LLC (collectively referred to as the Plan Sponsor) that have attained age 21 are eligible to participate in the Plan. Employees must have 500 hours of service, as defined, during the first six months of employment or the completion of one year of service, as defined, to be eligible to participate in the Plan. Eligible employees may enter the Plan on the first day of each quarter of the Plan year (January 1, April 1, July 1, or October 1).

The Plan Sponsor is responsible for the administration of the Plan and has entrusted Reliance Trust Company (Reliance) to be the trustee of the Plan. The Plan Sponsor has entrusted the maintenance of records and the day-to-day administration to T. Rowe Price Retirement Plan Services, Inc. (T. Rowe Price).

Contributions

Participants may elect to defer a maximum of 100% of compensation to the Plan, subject to Internal Revenue Code (IRC) limitations. Participants may direct both Plan Sponsor and participant contributions to various investment options with the primary custodian or to a participant segregated account. Participants may change their deferral elections on the first day of each calendar month. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Plan Sponsor may make a discretionary contribution to participants. No such contributions were made during 2022 or 2021. For 2022, the Plan Sponsor contributed to the Plan a contribution of 3% of a participant’s compensation, as defined in the Plan document, plus 50% of a participant’s deferrals up to the next 2% of a participant’s compensation (safe harbor contributions).

Receivables from the Plan Sponsor, if any, for contributions are unsecured.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's and Plan Sponsor contributions, investment earnings and losses that are allocated based on each participant's relative account balance within the respective fund, and an allocation of administrative expenses paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

The Plan invests in mutual funds and a collective investment trust that are stated at fair value. Net appreciation or depreciation in the fair value of investments is reflected in the Statement of Changes in Net Assets Available for Benefits. This includes all investments bought, sold, or held during the year.

Participants can direct the investments of both their contributions and the Plan Sponsor contributions allocated to their accounts to various investment options. The Plan does not require these investments to be collateralized. The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments.

Vesting

Participants are immediately vested in their elective contributions and the Plan Sponsor's safe harbor contributions plus actual earnings on these contributions. Vesting in the Plan Sponsor's discretionary contributions plus related earnings thereon is as follows:

Forfeitures

Forfeitures of terminated participants' nonvested accounts may be used to pay Plan expenses or to reduce future Plan Sponsor contributions to the Plan. If a terminated participant, who is deemed to have received a distribution, resumes participation in the Plan before five consecutive one-year breaks in credited service, the participant may be entitled to a restoration of any amount forfeited.

1. Description of the Plan (continued)

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant (or his or her beneficiaries) may receive a lump sum distribution, installment distributions over a specified period, or annuity distributions in an amount equal to the vested value of his or her account. Additionally, participants still employed at the Plan Sponsor may withdraw their vested account balances at any time on or after the age of 59 ½.

Hardship withdrawals are available in certain circumstances.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Accrual Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis, as are annual returns filed under applicable provisions of ERISA and the IRC.

Benefit Payments

Benefits are recorded when paid.

Investments

Investments are reported at fair value based primarily on quoted prices in an active market. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the Statement of Changes in Net Assets Available for Benefits.

Generally, the Plan's investments are collateralized by the proportionate share of the respective fund's underlying net assets. The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform and any collateral was insufficient is the recorded amount of such investments.

2. Summary of Significant Accounting Policies (continued)

Administrative Expenses

Certain Plan administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Certain investment related expenses are included in net realized and unrealized appreciation or depreciation in the fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent Events

Plan management has evaluated subsequent events through August 22, 2023, the date the financial statements were available to be issued.

3. Income Tax Status

The Plan Sponsor adopted a prototype plan sponsored by DST Retirement Solutions, LLC that received a favorable advisory letter from the IRS dated June 1, 2015, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC.

Effective March 1, 2022, the Plan Sponsor adopted a prototype plan sponsored by DST Retirement Solutions, LLC that received a favorable opinion letter from the IRS dated June 30, 2020, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC.

The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

4. Certified Investment Information (Unaudited)

T. Rowe Price, on behalf of Reliance, holds the Plan's investment assets and executes transactions therein. Financial information relating to those assets disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments as of December 31, 2022 and 2021, net realized and unrealized depreciation in the fair value of investments, and interest income, is based upon information provided to the Plan Administrator and agreed to or derived from information certified as complete and accurate by Reliance.

5. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.
- Level 2 Inputs to the methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value, which have not changed as of December 31, 2022 and 2021:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust: Valued at the NAV of units of the collective investment trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Other Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are investments held and managed by T. Rowe Price; therefore, these transactions qualify as party-in-interest transactions. Also, certain fees paid by the Plan qualify as party-in-interest transactions. Participant contributions are also considered to be party-in-interest transactions. Plan Sponsor contributions are considered to be party-in-interest and related party transactions.

7. Delinquent Participant Contributions

Defined contribution plans are required to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. During 2022, contributions totaling \$10,598 were not remitted within the required time period. As of August 22, 2023, the Plan Sponsor is in the process of correcting these delinquent contributions, including remitting the lost earnings associated to the Plan. During 2021, contributions totaling \$33,256 were not remitted within the required time period. During December 2022, the Plan Sponsor corrected these delinquent contribution, including remitting the lost earnings to the Plan.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
