Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Universal Beauty Products, Inc. 401(k) & Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 22, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to December 22, 2022, and the related notes to the financial statements (collectively, financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 22, 2022 and December 31, 2021, and for the period from January 1, 2022 to December 22, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Universal Beauty Products, Inc. (Company) 401(k) & Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all employees of the Company who had attained the age of 21, except for leased employees, union employees, and non-resident aliens. Initial enrollment was available on the first day of the month after reaching eligibility. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees were responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Effective December 22, 2022 the Plan transferred all assets to another qualified employee benefit plan. See Note 7.

Contributions

Each year, participants could have contributed up to 100% of pretax annual compensation, as defined in the Plan agreement. Participants had the option of contributing a percentage of their taxable compensation as a Roth contribution. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans.

Discretionary matching contributions may have been made on behalf of qualified participants who made a pretax or Roth contribution to the Plan during the year and who were employed on the last day of the Plan year. Discretionary matching contributions were not to exceed 4% of a participant's annual compensation. A participant became qualified for the matching contributions upon completing six months of service. The Company may have also made discretionary profit sharing contributions to qualified participants who were employed on the last day of the Plan year. A participant became qualified for the profit sharing contributions upon completing one year of service. During the period from January 1, 2022 to December 22, 2022, the Company declared matching contributions totaling \$49,661 and profit sharing contributions totaling \$90,000. The Company also made a qualified non-elective contribution totaling \$13,001.

Participants directed the investment of their contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing portions of their accounts was based on years of continuous service. A participant was 100% vested after three years of credited service.

Notes Receivable from Participants

Participants could have borrowed from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate was set at 1% above the prime rate, as defined. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant could elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments in accordance with the Plan agreement. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited Accounts

Forfeited nonvested accounts could have been used to pay administrative expenses of the Plan or to reduce the Company's future contributions to the Plan. At December 22, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$83, respectively. For the period from January 1, 2022 to December 22, 2022, \$11,946 of forfeited nonvested account balances were used to pay administrative expenses of the Plan. No amounts were used to reduce the Company's contributions to the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value, except for the fully benefit-responsive investment contract, which was reported at contract value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Trustees determined the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses has been recorded as of December 22, 2022 and December 31, 2021. If a participant did not make loan repayments and the Plan Administrator considered the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan document. Deemed distributions resulting from delinquent participant loans totaled \$2,040 for the period from January 1 to December 22, 2022 and are included in benefits paid to participants on the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net depreciation in fair value of investments.

Subsequent Events

Subsequent events have been evaluated through September 14, 2023, the date that the financial statements were available to be issued.

The Plan Administrator had elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, Empower Trust Company, LLC (Empower Trust), a qualified institution, has certified that the following information included in the financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statement of net assets available for benefits as of December 22, 2022.
- Interest and dividends, interest on notes receivable from participants, and net depreciation in fair value of investments as shown in the accompanying statement of changes in net assets available for benefits for the period from January 1, 2022 to December 22, 2022.

Additionally, Great-West Trust Company, LLC, a qualified institution, has certified that the following information included in the financial statements is complete and accurate:

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to the certified investment information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedule.

NOTE 4 - FAIR VALUE MEASUREMENTS

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 22, 2022 and December 31, 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Collective investment trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient was not used when it was determined to be probable that the fund would sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may have occurred daily.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan held an investment in the Key Guaranteed Portfolio Fund, a group annuity contract managed by Empower Annuity Insurance Company of America (EAIC). The contract value of the group annuity contract at December 22, 2022 and December 31, 2021 was \$0 and \$51,818, respectively. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer. The crediting rate was reviewed on a quarterly basis for resetting. The group annuity contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for the fully benefit-responsive investment contract because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAIC, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could have ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE 6 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by Empower Trust, the trustee of the Plan. An entity related to Empower Trust, EAIC, provided certain administrative services to the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping and transaction processing services amounted to \$19,899 for the period from January 1, 2022 to December 22, 2022.

Huntington National Bank provided investment advisory services to the Plan. Fees paid by the Plan for investment advisory services amounted to \$14,566 for the period from January 1, 2022 to December 22, 2022.

In addition, Howard Simon & Associates, Inc. provided certain administrative services to the Plan. Fees paid by the Plan for these administrative services amounted to \$2,625 for the period from January 1, 2022 to December 22, 2022.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 - PLAN TERMINATION

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

In October 2022, the Company entered into an Agreement of Merger of the assets of the participants in the Plan into the iSolved 401-K Plan. Effective December 22, 2022, the Company discontinued contributions to the Plan and transferred the Plan's assets of \$1,859,953 to the iSolved 401-K Plan.

NOTE 8 - TAX STATUS OF PLAN

The Plan adopted a non-standardized form of a pre-approved plan sponsored by FIS Business Systems, LLC. The pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan was designed and operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 22, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator has no reason to believe Form 5500 is subject to examination for years prior to 2019.
