## **GARVEY CORPORATION 401(K) PROFIT SHARING PLAN**

### **NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2022 AND 2021**

---

#### **1. DESCRIPTION OF PLAN**

The following is a brief description of the Garvey Corporation 401(k) Profit Sharing (the Plan) provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions. A summary of the Plan's provisions is as follows.

##### **General**

The Plan is a defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code, covering eligible employees of Garvey Corporation (the Company and Plan Sponsor). The Plan is funded by employee and employer contributions. Investment management fees and a portion of administrative expenses are paid by the Plan. The assets of Plan were maintained in investment funds held by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (the Trustees). The Plan is intended to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable.

During 2022, the Company approved the merger of the Plan into the Columbus McKinnon Corporation Thrift 401(k) Plan. Effective December 31, 2022 (Merger date), the Plan was merged into the Columbus McKinnon Corporation Thrift 401(k) Plan. The total Plan assets transferred amount to \$7,318,447.

##### **Eligibility**

Prior to the Merger date, employees of the Company must have attained age 18 to be eligible to participate and receive safe harbor matching contributions. Employees had to complete one year of service to receive nonelective contributions.

##### **Contributions**

Prior to the Merger date, participants could authorize a pre-tax elective deferral contribution up to 100% of earnings, subject to certain Internal Revenue Code limitations. Roth elective deferrals were permitted under the Plan. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Prior to the Merger Date, the Company provided safe harbor matching and nonelective contributions. The Company's safe harbor matching contributions were provided equal to 100% of participants contributions up to 3% of participants eligible compensation plus 50% of participants contributions between 3% and 5% of participants eligible compensation, as defined by the plan. There were no discretionary nonelective contributions made for the years ended December 31, 2022 and 2021.

## 1. DESCRIPTION OF PLAN (Continued)

### **Contributions (Continued)**

Participants directed the investment of employee and employer contributions into various investment options offered by the Plan. Participants could change their investment allocation on a daily basis.

### **Participant Accounts**

Prior to the Merger date, each participant's account was credited with the participant's contributions and allocation of (a) the Company's safe harbor matching and nonelective discretionary contributions (b) Plan earnings and losses, and (c) administrative expenses. Allocations are based on participant earnings/losses or account balances, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

### **Notes Receivable from Participants**

Prior to the Merger date, participants could borrow a minimum of \$500 from their funds up to a maximum amount, which is the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years, but could exceed five years for the purchase of a primary residence. The notes were collateralized by the balance in the participant's account and bore interest at a rate as determined by the Plan Administrator. Principal and interest were paid ratably through payroll deductions.

### **Withdrawals and Distributions**

Prior to the Merger date, unless a participant elected otherwise, distributions were made as soon as practical after the participant's normal retirement date or actual retirement date occurs. The normal retirement date was the date upon which the participant reaches age 65.

Participants could also receive hardship distributions under certain circumstances, as defined in the Plan Document. The Plan also allowed for in-service withdrawals for employees who attain age 59 ½.

### **Administrative Expenses**

Administrative expenses not paid by the Plan are paid by the Plan Sponsor.

### **Vesting**

Participants are immediately 100% vested in their elective deferral contributions and safe harbor matching contributions plus actual earnings thereon. Participants are 20% vested in discretionary non-elective contributions after two years of service, as defined by the plan, with a 20% annual increase in each of the next four years.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Plan prepares its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

### **Valuation of Investments**

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold or held during the year.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States required management to make estimates that affected the amounts reported in the financial statements. Actual results could differ from those estimates.

### **Payment of Benefits**

Benefits were recorded when paid.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2022 and 2021, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

### **Income Taxes**

The Plan used a prototype plan document sponsored by Great-West Trust Company, LLC. Great-West Trust Company, LLC received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the prototype Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan had been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan was designed and was operated in compliance with the applicable requirements of the IRC.

### **Risks and Uncertainties**

The Plan's assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect the amounts reported in the financial statements.

### 3. FINANCIAL CERTIFICATION

The following financial information relating to the Plan's assets at December 31, 2022 and 2021, as well as investment income and investment transactions for the year then ended, has been derived from information provided by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Trustees, and has been certified as complete and accurate. The incorporation of this financial information in the financial statements is based solely on their certification and has not been audited by independent accountants.

### 4. FAIR VALUE MEASUREMENTS

The Plan uses various valuation techniques in determining fair value. FASB ASC Section 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### 4. FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Values are determined based on quoted market prices in active markets.

The methods described could produce a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. GROUP ANNUITY CONTRACT

The Plan allowed participants to direct their contributions into an investment contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintained the contributions in a general account. Participant principal and interest were fully guaranteed by the general account assets of Empower Annuity Insurance Company of America. The group annuity contracts credited interest daily to the group contract holder on a portfolio basis. The credited interest rate could stay the same or change each quarter. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events could have limited the ability of the Plans to transact at contract value with the contract issuer. These events could be different under each contract. Examples of such events included the following:

## **5. GROUP ANNUITY CONTRACT (Continued)**

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

As described in Note 2, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the fully benefit-responsive investment contract.

Certain events limited the Plan's ability to transact at contract value. The Plan administrator did not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants were probable of occurring.

## **6. PARTY-IN-INTEREST TRANSACTIONS**

During the year ended December 31, 2022 and 2021, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, were the Trustees of the Plan, therefore, any transactions between the Plan and Empower Annuity Insurance Company of America or Empower Trust Company, LLC, qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest.

## **7. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through September 7, 2023, which is the date the financial statements were available to be issued.
