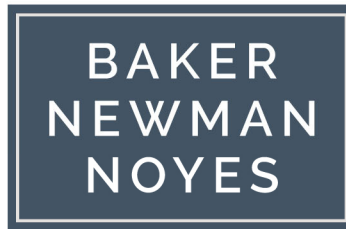

INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants
MMP/HTI 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the MMP/HTI 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 5, 2022 and December 31, 2021, the related statements of changes in net assets available for benefits for the period ended December 5, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

All plan assets were transferred to the Major Tool and Machine Inc. Personal Savings Plan in December 2022. Our opinion has not been modified with respect to this matter.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the MMP/HTI 401(k) Plan, formerly the Hoppe Technologies, Inc. 401(k) plan (the Plan), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Hoppe Technologies Inc. (the Company) is the Sponsor and Plan Administrator. Effective January 1, 2018, Maine Machine Products, Inc. employees were eligible to participate in the Plan. Effective September 1, 2021, Shields Manufacturing, Inc. and Viper Northwest, Inc. employees were eligible to participate in the Plan, and the respective plans merged with the MMP/HTI 401(k) Plan. In 2022, the Plan sponsor voted to merge the assets of the Plan into the Major Tool and Machine Inc. Personal Savings Plan, effective December 5, 2022.

General

The Plan is a defined contribution plan covering all employees of the Company, Maine Machine Products, Inc., Shields Manufacturing, Inc. and Viper Northwest, Inc. who have at least 35 days of service and are age eighteen or older. For purposes of employer profit sharing contributions, the employee must also complete at least five hundred hours of service during the plan year with certain exceptions. The Plan's assets are invested with Reliance Trust Company (as an agent of Transamerica Life Insurance Company), who is the custodian of the Plan. Transamerica Life Insurance Company (Transamerica) is the recordkeeper of the Plan and invests all contributions and allocates to each participant's account its proportionate share of investment earnings, withdrawals and administrative charges. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Contributions

Participants elect to contribute to the Plan a percentage of pretax annual compensation, as defined in the Plan, subject to certain limitations set forth by the Internal Revenue Code (IRC). Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options.

The Plan is a safe harbor 401(k) retirement plan under the IRC. Employees contributing to the Plan who have at least five weeks of service and are age twenty-one or older are eligible for a safe harbor employer matching contribution. The safe harbor employer matching contributions are equal to 100% of contributions up to 3% of an employee's compensation plus 50% of contributions between 3% and 5% of an employee's compensation. Safe harbor contributions are immediately vested under this plan. The Company may also make non-elective profit sharing contributions to the Plan at its discretion. No such additional amounts were contributed for the period ended December 5, 2022.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and, (b) plan earnings, and charged with an allocation of any administrative expenses not paid by the Company. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (Continued)

Vesting

Participants are immediately vested in their contributions plus allocated earnings thereon. Vesting in Company non-elective profit-sharing contributions is based on years of continuous service whereby a participant is 100% vested after three years of service. For certain profit sharing contributions made to Maine Machine Product employees prior to January 1, 2018, these contributions vest evenly over 3 years. Matching contributions under the safe harbor rules are immediately vested. In the event of death, disability, the attainment of normal retirement age, or termination of the Plan, a participant becomes 100% vested in all Company contributions.

Payment of Benefits

On termination of employment, except upon death, a participant will, if the vested interest is less than \$1,000, receive a lump sum amount equal to the participant's vested interest in his or her account, or, if the vested balance exceeds \$1,000, may elect to leave the investment in the Plan or receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Effective October 1, 2020 the plan was amended to change this limit to \$5,000. On termination of employment due to death, the participant's beneficiary will normally receive a lump sum amount equal to the value of the participant's account balance.

Participant Loans

In 2021, loan balances from the former Viper Northwest 401(k) Plan and the SMI 401(k) Plans were transferred to this plan. In 2022, the Plan was amended to permit new loans to participants. The loans are secured by the balance in the participant's account and bear interest at fixed rates. Principal and interest are paid ratably through payroll deductions. As noted in note 7, all notes receivable from participants were transferred out of the Plan as of December 5, 2022.

Forfeited Accounts

Forfeitures by non-vested participants are generally used to reduce future Company contributions and pay Plan expenses in accordance with the Plan document. Forfeited amounts at December 5, 2022 and December 31, 2021 were not significant.

Administrative Expenses

Some general administrative costs incurred by the Plan are paid by the Company. Any administrative expenses attributable to an individual participant are paid from the participant's account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

2. Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition

Investments in mutual funds are reported at fair value. See note 3 for discussion of fair value measurements. The collective investment trust is stated at estimated fair value, which has been determined based on the unit values of the trust based on the fair value of the underlying assets.

Purchases and sales of investments are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded daily on the accrual basis. Net appreciation (depreciation) in fair value of mutual funds includes realized gains and losses on mutual funds that were both bought and sold during the year, as well as unrealized appreciation on investments held at year end.

Contributions

Contributions from employees are recorded during the period in which the Company makes payroll deductions. Employer matching contributions are recorded in the same period as the corresponding employee contributions. Other employer contributions, if any, are recorded when the Company commits to making the contribution.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

For the purposes of recognition and disclosure in these financial statements, management of the Plan has evaluated subsequent events through October 4, 2023, which is the date these financial statements were available to be issued.

3. Investments, Information Certified and Fair Value Measurements

Information Certified

Reliance Trust Company, the Plan's custodian, has certified as complete and accurate the Plan's investments at fair value, related income and investment transactions, including net appreciation in fair value of investments and participant notes receivable, as of December 5, 2022 and 2021 and for the period ended December 5, 2022. Accordingly, as permitted under 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the custodians. The Plan Administrator has determined that the custodian meets the requirements of a qualified institution defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used in 2022 or 2021.

Mutual funds: Valued at the net asset value of shares (based on quoted market prices) held by the Plan at year end.

Common collective trusts: The units of common collective trusts are valued using the NAV practical expedient as determined by the issuer based on the fair value of underlying assets of the funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Party-in-Interest Transactions

The Plan's investments are managed by Transamerica or Reliance Trust Company. Transamerica serves as the Plan's custodian (through agent Reliance Trust Company) and recordkeeper and therefore transactions involving certain Plan investments affiliated with Transamerica qualify as party-in-interest. Administrative expenses paid by the Plan in 2022 to Transamerica were approximately \$70,000. AFG Fiduciary Services provides investment advisory services to the Plan. The Plan paid approximately \$45,000 to AFG Fiduciary Services in 2022.

5. Tax Status

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contributions, and the plan is not taxable.

This Plan is a volume submitter profit sharing 401(k) plan with a cash or deferral arrangement, which received a favorable opinion letter dated June 30, 2020 from the Internal Revenue Service, stating the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The volume submitter plan opinion letter has been relied upon by this Plan. The Plan has been amended since the opinion letter was issued. The Plan administrator believes that the Plan has continued to operate within the applicable sections of the IRC upon which the favorable opinion was based.

5. **Tax Status (Continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 5, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

6. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

7. **Plan Merger**

In December 2022, the Plan's assets were transferred to the Major Tool and Machine Inc. Personal Savings Plan as a result of a merger approved by the Plan Sponsor. Assets totaling \$29,169,130 were transferred out of the Plan.
